Opinion

(the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (modified cash basis) of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) for the years then ended in accordance with the modified cash basis of accounting described in Note A.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note A to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note A, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Note A - Plan Overview and Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The Health Care Plan of the Employees of IAT Insurance Group, Inc. (the "Plan"), prepares its financial statements on the modified cash basis of accounting. Contributions from IAT Insurance Group, Inc. (the "Sponsor"), its subsidiaries and their employees and retirees are recorded monthly when received. Benefits are recorded when paid. Interest and other income is recognized when received.

The preparation of financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes. Actual results could differ from those estimates.

Plan Overview

The following description of the Plan provides only general information. Participants in the Plan should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a High Deductible Health Plan ("HDHP") with a Health Savings Account ("HSA") feature, and provides health and death benefits covering substantially all employees of the Sponsor and specified subsidiaries and eligible participants under the Consolidated Omnibus Budget Reconciliation Act of 1986 ("COBRA"). Retirees and dependents are also eligible for participation. A HDHP features higher annual deductibles than traditional plans, and the HSA component provides a tax-free mechanism to Plan participants for funding such deductibles.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). The Health Care Plan of the Employees of IAT Insurance Group, Inc. Trust (the "Trust") serves as a conduit through which the benefits provided by the Plan are paid.

Credit Losses

The Plan measures expected credit losses on financial assets measured at amortized cost and record an allowance for credit loss against those assets. This applies to the Plan's imprest fund receivable. The Plan has concluded that no allowance for current expected credit losses was necessary at December 31.

Cash

Cash consists of interest bearing cash accounts. Included in these accounts are amounts in excess of federally, or other applicable, insured limits. The Plan mitigates its exposure to losses from these cash deposits by monitoring the financial stability of the financial institutions involved.

Notes to Financial Statements (Modified Cash Basis) (Continued)

Note A - Plan Overview and Summary of Significant Accounting Policies (continued)

Benefits

The Plan provides for health benefits (hospital, surgical, major medical, and prescription drug), life, accidental death and dismemberment, long-term disability, death benefits, vision, and dental care. All benefits other than health and dental benefits are insured through outside insurance carriers.

Death benefits are fully insured through an outside insurance carrier. Death benefits for employees on long-term disability are covered under an agreement with an outside insurance carrier whereby death benefits exceeding certain specified minimums will be paid by the carrier, subject to certain limitations.

Contributions

Plan participants make semi-monthly contributions to the Plan at prescribed rates, and the Sponsor subsidizes the remaining costs of operating the Plan. Contributions include the employee portion for optional or supplemental coverages elected by the employee. With the exception of COBRA, all coverages end at termination of employment.

Imprest Fund

The Plan is required to maintain funding with United Healthcare, a third-party administrator, to cover medical claims. This requirement was \$344,000 and \$331,000 at December 31, 2024 and 2023, respectively. These funds are not included in the Plan's cash accounts, but instead are being held at United Healthcare. The imprest fund receivable represents the Plan's fund requirement, less any claim payments issued by United Healthcare that have not been reimbursed by the Plan.

Other Income

The Plan receives prescription drug rebates per the contract provisions with United Healthcare, its pharmacy benefits manager. The rebates received are reported as Other Income on the Statements of Changes in Net Assets Available for Benefits. For the years ended December 31, 2024 and 2023 pharmacy rebates collected by the Plan totaled \$1,234,075 and \$1,193,723, respectively.

Administration

Health and dental claims are processed and reviewed by United Healthcare and Delta Dental in accordance with the terms of administration agreements. Fees paid for claims administration and review services during the years ended December 31, 2024 and 2023 amounted to \$723,669 and \$595,505, respectively.

Plan Termination

Although it has not expressed any intention to further do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees and future retirees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. If the Sponsor terminates or partially terminates the Plan, the Trust will pay benefits that participants are entitled to receive under the terms of the Plan, and no assets will revert to the employer.

Subsequent Events

The Plan evaluated subsequent events through September 11, 2025, the date on which the financial statements were available to be issued and has considered any relevant matters in the preparation of the financial statements and note disclosures.

Note B - Federal Income Tax Status

The Trust funding the Plan received an exemption letter from the Internal Revenue Service dated December 21, 1987, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the "Code") as a Voluntary Employee Beneficiary Association ("VEBA"). The Plan and Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the Trust.

Beginning in 2007, all VEBA trusts were required to file a form 990 with the Internal Revenue Service. The Trust has not filed a form 990 since inception, resulting in a revocation of its tax exempt status effective May 15, 2010. As of September 11, 2025, the Sponsor believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related Trust will not be subject to income tax.

The Sponsor analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023, no uncertain positions were taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. No tax planning strategies were used in 2024 and 2023.

Note E - Risks and Uncertainties

Plan contributions are made and reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

Note F - Transactions with Parties-in-interest

Certain administrative functions related to the Plan are performed by employees of the Sponsor. Neither the Sponsor nor the employees receive compensation from the Plan for these services. Additionally, certain expenses of the Plan, primarily trustee, record keeping and regulatory compliance fees, are paid by the Sponsor.

The subsidiaries of the Plan Sponsor include: Harco National Insurance Company, Occidental Fire & Casualty, Wilshire Insurance Company, Commercial Alliance Insurance Company, Acceptance Casualty Insurance Company, Acceptance Indemnity Insurance Company, IAT Reinsurance Company Ltd, Transguard Insurance Company of America, and International Fidelity Insurance Company.
