Report of Independent Auditors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Vrdolyak Law Group, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Description of the Plan

The following description provides only general information regarding the provisions of Vrdolyak Law Group, LLC 401(k) Plan (the Plan). Participants should refer to the summary plan description for more complete information.

The Plan was established on July 1, 1995 by Vrdolyak Law Group, LLC (the Company) under Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is a defined contribution retirement plan covering employees of the Company who have completed the eligibility requirements as detailed in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Employees who are not otherwise excluded from the Plan, are eligible to participate in the Plan as of the first entry date (January 1, April 1, July 1, or October 1) based on when the employee satisfies the minimum age and service requirements under the Plan. New employees who participate in the Plan and do not make alternative elections are automatically enrolled at a 6% contribution rate.

Participants may elect to contribute up to a maximum of 100% of their pre-tax compensation as defined by the Plan, subject to IRC limitations. For the years ended December 31, 2024 and 2023, the Company elected to make discretionary matching contributions to participants that satisfied the eligibility requirements of \$103,711 and \$82,322 respectively. Participants may also roll over amounts representing distributions from other qualified retirement plans.

Contributions to the Plan are invested as directed by the participants in various investment options. In the absence of participant direction, contributions are invested in a qualified default investment alternative account until changed by the participant. Participants must evaluate their own investment goals and objectives and choose the investments best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their account balance to be lower than contributions made to the Plan.

Individual accounts are maintained for each participant to reflect the participant's contributions and any rollover or Company matching contributions, as well as allocations of investment earnings or losses and administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of the Plan (continued)

Participants are immediately fully vested in their elected deferrals, rollovers and actual earnings thereon. Employer discretionary matching contributions are fully vested after five years of vesting service. A year of vesting service is earned upon working 1,000 hours in a Plan year. In the event that an eligible participant passes away or becomes disabled while still employed, a participant will become 100% vested. The portion of the employer discretionary matching contribution that is vested is as follows:

Upon termination of service due to death, disability or retirement after age 59½, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in the account, partial account distributions or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in the account as a lump-sum distribution. Under current provisions, vested account balances of terminated participants that are less than \$7,000 are automatically distributed.

Participants in service may make hardship withdrawals from their vested contributions upon demonstrating an immediate and heavy financial need, as allowed under federal rules.

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one outstanding note at any time. Loan terms can range up to 60 months unless the proceeds are used to acquire the participant's principal residence, in which case, the loan may be repaid over a period longer than 60 months. The interest rate is based on prevailing market conditions and is fixed over the life of the note. Interest rates on outstanding participant notes as of December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are repaid ratably by the participants through payroll deductions.

In December 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was enacted and increased the required minimum distribution age to 73 effective in 2023 and as late as 75 effective in 2033. The Plan also was amended effective January 1, 2024, pursuant to optional provisions of SECURE Act 2.0 to raise the required account balance threshold for an automatic lump-sum distribution to be made to a terminated participant from \$5,000 to \$7,000.

Included in net assets available for benefits are forfeited nonvested accounts totaling \$17,615 and \$17,943 as of December 31, 2024 and 2023, respectively. Forfeited nonvested accounts may be used to reduce employer contributions or to pay Plan administrative expenses. During the years ended December 31, 2024 and 2023, nonvested amounts of \$2,961 and \$3,584 respectively, were forfeited. For the years ended December 31, 2024 and 2023, forfeitures of \$5,540 and \$11,710, respectively, were used to pay Plan administrative expenses. In addition, for the year ended December 31, 2023, forfeitures of \$4,457 were used to reduce employer contributions.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

Investments - The investments of the Plan are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. For all other investments, the fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of either December 31, 2024 or 2023. Related fees are recorded as administrative expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits - Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

Expenses - Certain management and administrative services are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The following provides a description of the three levels of the fair value hierarchy:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The Plan's investments in mutual funds are classified within Level 1 of the fair value measurement hierarchy. The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Note 4. Information Certified by Plan Trustee/Custodian

The following information as of December 31, 2024 and 2023, and for the years then ended, was obtained by management and agreed to or was derived from information certified as complete and accurate by Empower Trust Company, LLC (Trustee) and Empower Annuity Insurance Company of America (Custodian), qualified institutions.

Note 5. Investment Contract with Insurance Company

The Plan has a traditional benefit-responsive group annuity contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The average yield and crediting interest rates were 1.41% and 1.23% for the years ended December 31, 2024 and 2023, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. Plan administration believes the occurrence of such events that would limit the Plan's ability to transact at contract value is not probable.

Note 6. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

Note 6. Risks and Uncertainties (continued)

The Plan has a significant portion of its assets invested in two mutual funds, Vanguard Total World Stock Index Fund and Vanguard Intermediate-Term Bond Index Fund, which represented approximately 51% and 39% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively. It is reasonably possible that changes in the values of these investments could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across the participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial investments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participant who made such decisions.

Note 7. Priorities upon Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the employer contribution portion of their account.

Note 8. Tax Status

The Company has adopted a volume submitter prototype plan. The Plan is not required to receive a determination letter directly from the Internal Revenue Service, and therefore, the Plan has not received a determination specific to the Plan itself. The prototype plan determination letter has been relied upon by the Plan. The Company and the Plan Administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Party-in-Interest Transactions

Certain Plan investments are held by Empower Annuity Insurance Company of America, the Custodian of the Plan.

Empower Trust Company, LLC, the Trustee of the Plan, provides certain administrative services to the Plan pursuant to a service agreement. Administrative services are primarily paid through quarterly administrative fees charged to participants.

These transactions qualify as party-in-interest transactions under ERISA.
