Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Price Edwards & Company Savings & Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Price Edwards & Company Savings & Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering substantially all employees of Price Edwards & Company (the Company or the Employer) who are age 21 or older and completed six months of service (12 months and 1,000 hours of service was required prior to amendment effective July 1, 2024). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was adopted January 1, 1991. The most recent amendment to the Plan became effective July 1, 2024, and the most recent restatement of the Plan became effective January 1, 2021.

CONTRIBUTIONS

Each year, participants may contribute up to 100% of pretax annual compensation as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan has elected the 401(k) Safe Harbor provision in which the Employer makes matching contributions of 100% of the participants' elective deferral up to 4% of the participants' gross compensation. Participants are automatically 100% vested in the 401(k) Safe Harbor Employer matches. The Company may also make a discretionary profit-sharing contribution to the Plan, allocated to eligible employees, though not required. There were no discretionary contributions made for the years ended December 31, 2024 and 2023, respectively.

Participants direct the investment of their contributions, including employer contributions, into various mutual funds offered by the Plan.

AUTOMATIC DEFERRAL

The Plan includes an "automatic" deferral feature that eliminates the requirement of new employees from executing a salary reduction agreement. Thus, if the other Plan requirements have been satisfied, the employer will automatically withhold 2% of compensation and deposit such amounts into the Plan for the benefit of the employee, which will remain in effect until such time a signed salary reduction agreement is executed.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, the Safe Harbor Employer matching contribution as well as allocations of the company's discretionary profit-sharing contribution, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

VESTING

Participants are immediately vested in their contributions and the Safe Harbor Employer matching contribution plus actual earnings thereon. Vesting in the Company's discretionary non-elective

contribution portion of their accounts is based on years of service. A year of service must include at least 1,000 hours of service by the employee to qualify. A participant is 100% vested after six years of credited service. A participant is fully vested when any of the following occur: reaching full retirement age, retirement due to disability, death, and termination of the Plan.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The maximum number of loans outstanding is one. The loan is secured by the balance in the participant's account and bears interest at rates determined by the loan administrator, which are commensurate with rates charged by commercial lenders for loans made under similar circumstances. Repayment, principal and interest, through payroll deductions must be completed within six years or up to 15 years if proceeds were used for the purchase of their principal residence.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

FORFEITED ACCOUNTS

As of December 31, 2024 and 2023, the balance of the forfeiture account was \$14,955 and \$14,228, respectively. Forfeitures may be used in the future to pay allowable plan administrative expenses or to reduce employer contributions. There were no forfeitures from participant accounts and no forfeitures used during 2024 to reduce employer matching or to pay plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based on the terms of the Plan document.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Company or otherwise stated. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of the notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

USE OF ESTIMATES

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets and liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED TO BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company (the trustee of the Plan).

NOTE 5 – EXCESS CONTRIBUTIONS PAYABLE

As of December 31, 2024, there were no excess contributions required to be distributed in the subsequent year to satisfy federal tax law contribution limits.

NOTE 6 – PLAN ADMINISTRATIVE EXPENSES

Certain administrative expenses of the Plan have been paid by the Plan Sponsor during the years ended December 31, 2024 and 2023.

NOTE 7 – TRANSACTIONS WITH PARTIES-IN-INTEREST

Slavic Mutual Funds Management Corporations (SMF) is the investment advisor to the Plan. Participants have the option to use the services of SMF which charge a quarterly fee paid by the participants should they elect to utilize the services of SMF.

Slavic Integrated Administration (SIA) is the Plan's Third-Party Administrator (TPA) and receives an annual administrative or asset fee that is allocated to and paid by each participant.

The owners of SMF and SIA are the same.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 9 – TAX STATUS

The Plan has adopted a standardized plan pre-approved by the Internal Revenue Service ("IRS"). The Internal Revenue Service has ruled that the master volume submitter plan from which the Plan was adopted qualifies under Section 401(a) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. Although, the Plan has been amended since receiving the IRS tax-exempt determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
