#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### ***Basis of Presentation***

The financial statements of The Capco 401(k) Profit Sharing Plan (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

##### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

##### ***Related Party Transactions***

Several employees of The Capco Markets Company, LLC (the "Plan Sponsor") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees of the Plan.

Certain expenses and costs of administering the Plan were paid by the Plan Sponsor, and accordingly are not reflected in the Plan's financial statements. Certain investment-related expenses are included in net depreciation in fair value of investments.

##### ***Estimates***

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Receivable from Employer Contributions*

Receivable from employer contributions represents the Plan Sponsor's true-up contributions remitted to participant accounts after December 31, 2024 and 2023. Receivable is recorded as \$400,893 and \$353,655 as of December 31, 2024 and 2023, respectively.

##### *Subsequent Events*

In preparing its financial statements, the Plan has evaluated events subsequent to the balance sheet date through September 18, 2025, which is the date the financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan Sponsor adopted the Plan effective August 1, 2017. This plan was amended and restated on January 1, 2024.

The Plan is a defined contribution 401(k) plan sponsored by The Plan Sponsor covering substantially all employees of the company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Vanguard Fiduciary Trust Company (Vanguard) is the Trustee of the Plan.

##### *Contributions*

The Plan permits participants to defer up to 40% of their eligible compensation, as defined by the Plan, subject to the maximum allowable under the Internal Revenue Code (IRC) (\$23,000 in 2024). To be eligible for elective deferrals, a participant must have achieved the age of 18 and have completed at least 90 days of service. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions up to the IRC limit. Upon satisfying the eligibility requirements, participants are automatically enrolled with an initial pre-tax deferral contribution of 3% unless participants affirmatively elected not to participate. Participants' deferral percentages are automatically increased by 1% in June of each subsequent calendar year, up to a maximum of 12%. Participants are eligible to receive an employer match of 50% of the participant's deferrals for the plan year up to a maximum of the first 6% of eligible compensation.

The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations (\$7,500 in 2024).

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### ***Rollover Contributions***

Participants may roll over their taxable portion of funds previously held for their account in another qualified employee benefit plan to the Plan on a tax-free basis.

##### ***Participant Accounts***

Each participant's account is credited with allocations of (a) the participant's contribution, (b) the Plan Sponsor's contribution, and (c) allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### ***Vesting***

Participants are immediately vested at the time of participation in their contributions and rollovers plus actual earnings thereon. Participants are vested in their employer match and discretionary contributions 34% after one year of service, 67% after two years of service and 100% after three years of service.

##### ***Investment Options***

Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan offers mutual funds and common collective trusts as investment options for participants.

##### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balances. The notes receivable are secured by the balance in the participant's account and bear interest equal to the prime rate at the time of the loan obligation plus 1%. The interest rate on loan outstanding ranges from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Loan payments are made through payroll deductions in equal installments over a period that may not exceed ten years for the purchase of a primary residence and five years for other loans from the date the loan was made.

##### ***Forfeited Accounts***

Forfeitures may be used to offset future employer contributions or pay Plan expenses. The balance in the forfeiture account was \$499,834 and \$147,489 at December 31, 2024 and 2023, respectively. Forfeitures are used to reduce employer contributions or plan expenses. Forfeitures of \$333,009 were used to reduce employer contributions during 2024.

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Payment of Benefits*

Upon a participant's retirement, death, disability, termination of employment, or termination of the Plan, the participant may receive benefits in accordance with the Plan's provisions and existing laws and regulations.

In conditions of "financial hardship", a participant may request approval to withdraw that portion of his retirement account balance necessary to meet the financial hardship, subject to limitations of the Plan and the Internal Revenue Code.

In-service distributions are permitted for those participants who have reached the age of 59 1/2. Participant rollover contributions may be withdrawn in whole or in part at any time.

Upon termination of the Plan, assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Common collective trusts are valued at their accumulation unit value (AUV), which is used as a practical expedient to approximate fair value. The AUV is determined daily based on the NAV of shares of the underlying funds less liabilities and may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

The Company pays certain fees associated with the Plan as a party-in-interest. Certain investments are managed by Vanguard, the Trustee of the Plan and, therefore, transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Additionally, notes receivable from participants also qualify as party-in-interest transactions.

#### NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### NOTE 7 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service dated May 20, 2019, which states that the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Furthermore, the Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income taxes has been included in the Plan's financial statements.
