## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Hartzell Propeller, Inc. 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Hartzell Propeller, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. The Plan is a prototype plan and has adopted the provisions of the Tailwind Technologies 401(k) Plan. The Participants should refer to the adoption agreement, which was amended and restated as of January 1, 2021, for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible full-time employees of Hartzell Propeller, Inc. (the “Plan Sponsor”). Eligible employees may elect to make pretax salary deferral contributions effective after the completion of one month of service. The Plan is administered by the Plan Sponsor along with Empower Trust Company (“Empower”) (the “Trustee”) as of and for the years ended December 31, 2024 and 2023, respectively. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Participants may elect to contribute up to the maximum amount allowed by Internal Revenue Service (“IRS”) regulations for the Plan year. The Plan Sponsor makes matching contributions equal to 50% of participant deferrals up to the first 4% of the participant’s eligible compensation and 25% of the participant deferrals up to the next 1%. New employees are automatically enrolled in the Plan, unless they elect otherwise, at an automatic enrollment rate of 5%.

Effective January 1, 2023, the Plan was amended and restated to increase the employer matching contribution to 50% of participant deferrals up to 6%. Effective March 1, 2023, the Plan was amended to increase the automatic enrollment rate to 6% of compensation. The Plan Sponsor’s matching contributions were \$942,364 and \$1,147,437 for the years ended December 31, 2024 and 2023, respectively.

If a participant reaches age 50 during the calendar year and is making the maximum Plan or IRS pre-tax contribution, they may make an additional “catch-up” contribution each pay period, up to the annual IRS dollar limit.

The Plan Sponsor will also make a non-elective Safe Harbor contribution in an amount of 3% on an annual basis. The Plan Sponsor’s non-elective Safe Harbor contributions were \$1,056,697 and \$1,283,678 for the years ended December 31, 2024 and 2023, respectively. The non-elective Safe Harbor contribution amounts are included in employer contributions on the Statements of Changes in Net Assets Available for Benefits.

The Plan also includes a transition contribution for each transition participant, grandfathered participant, and each non-grandfathered participant, as defined by the Tailwind Technologies 401(k) Plan document. Each transition participant shall receive a transition contribution in an amount that is equal to 3.25% of the transition participant's annual compensation. Each grandfathered participant shall receive a transition contribution that is equal to 6% of the participant's annual compensation. Each non-grandfathered participant shall receive an applicable contribution percentage, which is based upon the sum of: (1) the age of the participant as of December 31, 2013, plus (2) the years of service attained by the participant as of December 31, 2013, as stated in the following chart:

The Plan Sponsor's transition contributions were \$459,865 and \$686,524 for the years ended December 31, 2024 and 2023, respectively.

During 2025, the Plan Sponsor paid out a lump sum payment to participants for future transition contributions. The lump sum payments were paid outside of the Plan. Effective January 1, 2026, there will no longer be a transition contribution made to participants.

Rollovers

Rollover contributions consist of amounts rolled over by participants from another qualified plan as defined by the Internal Revenue Code ("IRC").

Allocation of Forfeitures

Forfeitures attributable to Plan Sponsor matching contributions are used to reduce the Plan Sponsor's contribution or to pay Plan expenses. At December 31, 2024 and 2023, there were accumulated forfeitures of \$1,974 and \$12,034, respectively. There were \$10,237 and \$9,518 of forfeitures used to pay Plan expenses during the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Separate accounts are maintained in the name of each participant. Participants direct their contributions and Plan Sponsor contributions to be invested in one or a combination of available investment accounts. Each participant's account is credited with the participant's contribution, the Plan Sponsor's contributions, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may elect their allocation percentage among investment options with varying degree of risk. Participants may change their investment directive at any time during the year.

Vesting

Participants are immediately vested in their contributions, as well as Plan Sponsor matching contributions, and earnings thereon. Plan Sponsor non-elective Safe Harbor contributions and transition contributions and related earnings are immediately vested.

Notes Receivable from Participants

The Plan allows participants to apply for and obtain notes in an amount defined in the Plan (no less than \$1,000 and limited to 50% of the participant's vested account balance provided such notes do not exceed \$50,000), from the balance of the participant's account. All notes must be repaid within five years unless the note is used to acquire the participant's primary residence in which case the term of the note may be set for a term of up to 15 years. The notes are secured by the balance in the participant's account and bear interest at a fixed rate of Prime plus 1% as of the date of the note's inception. Payments of principal and interest are credited to the participant's account.

Notes are in default when payments are not made by the end of the calendar quarter following the quarter in which the payment was due, if there is still an outstanding balance on the note's maturity date, or employment with the Plan Sponsor is terminated. In the event of default, the entire outstanding note balance, consisting of the missed payments, remaining principal, and all accrued but unpaid interest, will be reported to the IRS as taxable income. If a note has not been fully repaid by the end of its term, the outstanding balance will be treated as a deemed distribution and will be reported to the IRS as taxable income.

Payment of Benefits

On termination of service, if a participant's account is less than \$1,000, the participant must receive a lump-sum amount equal to the value of his or her vested account balance. If the participant's account balance is between \$1,000 and \$5,000 and the method of distribution is not specified by the participant, an automatic rollover to an Individual Retirement Account is made. If the participant's account exceeds \$5,000, the terminated participant may elect to defer distribution until a later date (not later than their normal retirement date).

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative fees are paid by the Plan or the Plan Sponsor.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all participants shall be fully vested and shall receive a full distribution of the balances in their respective accounts.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis.

Use of Estimates

In preparing the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America, the Plan Sponsor is required to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities and the reported increases and reductions of Plan assets during the reporting period. Actual results could differ from these estimates.

Fair Value of Financial Instruments

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Valuation of Investments and Investment Income

The Plan's investments in mutual funds are stated at fair value at December 31, 2024 and 2023.

The Plan has entered into a fully benefit-responsive investment contract with Empower Trust Company and Great-West Life Trust Company (the "Issuers"), totaling \$3,792,294 and \$4,287,845 as of December 31, 2024 and 2023, respectively. The Issuers maintain the Plan's investment in their general accounts and are contractually required to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the Issuers, represents contributions made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

In certain circumstances, the amount withdrawn from the fixed annuity contract would be payable at fair value rather than at contract value. These circumstances may include, but are not limited to, the following: mergers, mass layoffs, plan terminations, implementation of early retirement incentive programs or other events within the control of the fund or the Plan Sponsor resulting in a material and adverse financial impact on the issuers' obligations under the contract.

Investment income consists of dividend and interest income. The net appreciation of investments consists of realized gains or losses and the unrealized appreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

Notes Receivable from Participants

The Plan allows loans in accordance with the Plan document. The loans are carried at their unpaid principal balance, plus any accrued interest. Loans are deemed distributions by the Plan when they are determined to be in default.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

Under the Income Taxes Topic of the Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC"), the Plan Sponsor is required to identify potential uncertain tax positions taken, assess and quantify those positions and record reserves. As of and for the years ended December 31, 2024 and 2023, the Plan Sponsor has identified no uncertain tax positions. The Plan files the United States Federal Form 5500 annually.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued. Effective January 1, 2026, all Plans managed by the Plan Sponsor will be merged into a single Plan. Also see Note 1.

NOTE 4 – INVESTMENTS

The Plan's investments are participant-directed accounts that are held by the Trustee.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methods.

NOTE 5 – TAX STATUS

The Plan adopted a profit sharing plan with cash or deferred arrangement and obtained a favorable determination letter from the IRS to the effect that the Plan is exempt from federal income taxes dated November 14, 2022. The Plan has been amended since receiving the determination letter. However, the Plan Sponsor is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 – RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included as a reduction of the return on each fund. There are also indirect fees deducted directly from the investment earnings of the Plan.
