### **1 – DESCRIPTION OF THE PLAN**

#### ***General***

Delta Projects, Inc. 403(b) Retirement Plan (the "Plan") is a defined contribution plan that was established on January 1, 2018, under Internal Revenue Code Section 403(b) for the benefit of employees of Delta Projects, Inc. (the "Organization"). The Plan is funded by contributions from its participants and the Organization and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The following description of the Plan provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***Eligibility for Participation***

Employees are eligible to make voluntary deferral contributions and receive employer matching contributions upon their date of hire. Employees who are expected to work less than 1,000 hours for the first 12 months of employment are not eligible for the Plan. If those employees work 1,000 hours in a 12-month period, they will be eligible for the Plan the following year.

#### ***Employee Elective Deferred Contributions***

Employees participating in the Plan may elect to defer a specific dollar amount or percentage of their annual earnings as their contribution to the Plan, subject to the limitations described in the Internal Revenue Code. Employee contributions in the form of rollovers and transfers from other qualified retirement plans are allowed as defined in the Plan document.

#### ***Employer Matching Contributions***

The Organization will make discretionary matching contributions to the Plan equal to an amount approved by the Organization's Board of Directors.

#### ***Qualified Non-Elective Employer Contributions***

The Organization may decide each Plan year whether to make a discretionary non-elective employer contribution on behalf of eligible active participants. Such contribution shall be allocated to eligible active participants based upon the ratio each eligible participant's compensation bears to the total compensation paid to all active participants for the Plan year. There were no discretionary non-elective contributions made by the Organization for the years ended December 31, 2024 and 2023.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's contributions is based on years of service. With respect to employer contributions, participants vest 25% after one year of service, 50% after two years of service, and 100% after three years of service.

#### ***Participant Accounts***

Accounts are maintained for each participant. Accounts are increased for contributions, transfers and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants, administrative expenses, and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

#### ***Investment Options***

Voya Retirement Insurance and Annuity Company (including its subsidiary Voya Institutional Plan Services, LLC) (“Voya”), serves as the Plan’s custodian. Upon enrollment into the Plan, a participant may direct employee and employer contributions to the various investment options offered by Voya.

#### ***Notes Receivable from Participants***

A participant may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant’s account and bear interest at a commercially reasonable rate established by the Plan Administrator or under the terms of the applicable funding vehicle. Principal and interest is paid ratably through payroll deductions.

#### ***In-service Withdrawals***

In-service withdrawals may only be made under the following circumstances:

- Hardship as defined in the Internal Revenue Code and the Plan document
- Attainment of age 59½
- Withdrawal of employee rollover contributions

#### ***Retirement Benefits***

The normal retirement age under the Plan is the later of age 65 or a participant’s third anniversary of participation in the Plan. A participant who becomes disabled as defined in the Plan document is eligible for disability retirement.

#### ***Payment of Benefits***

Upon termination of service from the Organization, a participant may elect to receive the vested portion of their account in the form of a single lump sum or any form of payment permitted under the applicable funding vehicle or as an annuity payment. Upon termination of service at the Organization, a participant with an accumulated balance of \$7,000 or less who does not otherwise request a distribution will receive a distribution of the vested balance at the discretion of the Organization.

#### ***Timing of Distributions***

Distributions described above shall be made as soon as reasonably practicable following the date the participant’s application for distribution is received by the custodian.

As of December 31, 2024 and 2023, there were no distributions payable to participants.

#### ***Administrative Expenses***

Substantially all administrative expenses incurred by the Plan are paid by the Organization. However, certain administrative fees may be paid by the Plan.

#### ***Forfeited Accounts***

Forfeited accounts may be used to offset the Organization’s future contributions or pay Plan expenses. As of December 31, 2024 and 2023, forfeited accounts available for such use totaled \$16,527 and \$10,972, respectively.

#### ***Participant-Directed Contributions, Withdrawals and Transfers***

The election to allocate contributions between the investment options, and any decision to change such allocation, is made by each participant as permitted by the custodian. Withdrawals and transfers are recorded at the time such transactions take place.

### 2 – SUMMARY OF ACCOUNTING POLICIES

#### ***Basis of Accounting***

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investments***

Investments are reported at fair value as described in Note 4. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and, for money market instruments, includes amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains (losses) on investments bought and sold as well as held during the year.

Each participant’s assets are jointly invested and the return on assets is allocated monthly among the participants and recorded as income or loss. The basis of allocation is the unit of participation method. Under this method, contributions and income result in an increase of units of participation while benefits paid, and losses result in a decrease of units of participation.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Risks and Uncertainties***

The Plan provides for investment options in various accounts that are investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

#### ***Subsequent Events***

The Plan Administrator evaluated events that occurred after December 31, 2024, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued, June 17, 2025, for potential recognition or disclosure in the financial statements. The Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

### **3 – INFORMATION CERTIFIED BY CUSTODIAN**

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's custodian and furnished to the Plan Administrator and includes all Plan assets (except for the effects of participant and employer contributions receivables, if any) and all investment transactions. The Plan Administrator has obtained certifications from the custodian that such information is complete and accurate.

### **4 – FAIR VALUE MEASUREMENTS**

The Plan applies the provisions of GAAP, which establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these provisions are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### **Mutual Funds**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### 4 – FAIR VALUE MEASUREMENTS (continued)

#### Fixed Account

This account is reported at contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, less any withdrawals. Contract value provides a reasonable approximation of fair value.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **6 – PLAN TERMINATION**

Although it has expressed no intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, all affected participants will become vested in their accounts.

### **7 – INCOME TAX STATUS**

The Organization has adopted the Angell Pension Group, LLC (“Angell”) Volume Submitter 403(b) Basic Plan Document #007 for its Plan document. Angell obtained an advisory letter from the Internal Revenue Service indicating its Volume Submitter 403(b) Basic Plan Document #007 is acceptable under Internal Revenue Code Section 403(b).

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **8 – PARTY-IN-INTEREST TRANSACTIONS**

Plan investments consist of shares of various accounts and funds managed by Voya. Voya is the custodian of the Plan’s assets and, therefore, these transactions qualify as party-in-interest.

The Organization provides certain administrative services at no cost to the Plan. The Organization also pays for certain administrative costs of the Plan.
