## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants  
Wallenius Wilhelmsen Group of Companies 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Wallenius Wilhelmsen Group of Companies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

### Note 1 - Description of plan:

The following description of the Wallenius Wilhelmsen Group of Companies 401(k) Plan, (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan open to substantially all employees of WWL Vehicle Services Americas, Inc. (the Company, Plan Sponsor, Plan Administrator), excluding those who are covered by a collective bargaining agreement for which retirement benefits have been provided, leased employees, non-resident aliens who do not receive any U.S. earned income, on-call employees, and temporary employees hired for a short-term assignment. The Plan requires the completion of three months of service with the Company, with no age requirement, to become an eligible participant. Plan entry is immediate upon meeting eligibility requirements. The WWL Vehicle Services Americas Executive Committee (Administrative Committee) and the Plan Administrator control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

On December 10, 2024, the Plan was amended to include 2W Americas Holdings, LLC as a participating employer effective January 1, 2025.

#### Contributions

Each year, participants may contribute up to 60% of pretax annual compensation, as defined by the Plan, subject to a maximum, as specified by the Internal Revenue Code (IRC). All participants who make pretax contributions and who have attained age 50 before the close of the taxable year are eligible to make additional catch-up contributions up to a maximum, as specified by the IRC. Participants may also contribute amounts representing distributions from other qualified plans. No voluntary after-tax or Roth contributions are permitted. Employees who become eligible to participate in the Plan are auto enrolled in the Plan. Participants are notified 30 days prior to being auto enrolled into the Plan and can modify or decline the automatic contribution. As part of the auto enrollment feature, a 3% deferral rate, with auto increases of 1% up to a cap of 6%, is elected for the participant by the Plan. The deferral is directed to one of the target date funds (based on the participant's date of birth) offered by the Plan unless directed into other funds by the participant. The Company makes safe harbor matching contributions of 100% of a participant's contribution up to the first 6% of a participant's eligible compensation. The Company may make discretionary non-elective contributions, which are subject to a last day and 1,000 hour requirement, but none were declared in 2024.

#### Contributions - continued

Upon enrollment in the Plan, a participant may direct all contributions in 1% increments to any of the Plan's investment options. Participants may change their investment options daily.

#### Participant accounts

Each participant's account is credited with the participant's contributions and Company safe harbor matching or discretionary non-elective contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and Company safe harbor matching contributions plus actual earnings thereon. Discretionary non-elective contributions are subject to a three year cliff vesting schedule. Some participants transferred into the Plan through mergers are subject to vesting schedules defined in the Plan document on the amount of their account transferred in.

Participants are immediately vested upon termination of the Plan, upon reaching the early retirement age of 59½, or upon disability or death while an employee of the Plan Sponsor.

#### Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$390 and \$15,408, respectively. These accounts may be used to pay Plan administrative expenses or to reduce future Company contributions. During the year ended December 31, 2024, \$40,122 of forfeited non-vested accounts were used to pay administrative expenses and \$250 was used to reduce Company contributions.

#### Payment of benefits

Upon termination of service, the participant is entitled to distributions of vested balances in the form of: (i) installment payments or (ii) a single lump-sum payment; however, balances less than \$1,000 will be paid via a lump-sum payment. Participants who are still employed may request a withdrawal for reasons of proven financial hardship and those who have reached age 59 1/2 may elect an in-service withdrawal in accordance with the Plan document.

#### Notes receivable from participants

Participants may borrow from the Plan in any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms are for a period not exceeding five years unless for the purchase of a principal residence, in which case the note repayment period may not extend beyond 10 years. Notes are secured by the balance in the participant's account and bear interest at an agreed-upon percentage based on prevailing market rates. Principal and interest is paid ratably through payroll deductions. Participants are allowed one outstanding note.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Common/collective trust fund

Investments in the common/collective trust fund (CCT) are reported at fair value. The CCT, at the fund level, is composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. The statements of net assets available for benefits present the fair value of the investment in the CCT for the Plan's proportionate share of the CCT. The statement of changes in net assets available for benefits is prepared on the fair value basis.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee (See Note 3).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and Company safe harbor matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

The Plan maintains an unallocated revenue credit account for excess recordkeeping revenue. Recordkeeping revenue in excess of agreed upon compensation is deposited to the account and can be allocated to participants accounts or used to reduce participant level administrative costs. At December 31, 2024 and 2023, the balance in the revenue account totaled \$86,813 and \$81,832, respectively. During the year ending December 31, 2024, \$570 was deposited into the revenue account and was recorded as a reduction to administrative expenses reported in the statement of changes in net assets available for benefits. No amounts were allocated to participants.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

#### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### Recent accounting pronouncements

The AICPA Financial Reporting Executive Committee (FinREC) approved enhanceive accounting updates related to accounting for revenue sharing arrangements in accordance with Financial Accounting Standards Board (FASB) ASC No. 606, *Revenue from Contracts with Customers*. Revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and are not paid to the plan for delivering or producing goods, rendering services or undertaking other activities for the investment manager. A plan should consider all relevant facts and circumstances, including the terms of the agreement to determine the appropriate presentation of revenue sharing amounts. The presentation should be applied on a consistent basis and the plan should consider whether the presentation of revenue sharing amounts is a significant accounting policy that should be disclosed in the notes to the financial statements. If significant, the notes to the financial statements should include a description of revenue sharing arrangements including how such arrangements are presented in the financial statements. The adoption did not have a material impact to the Plan's financial statements.

##### Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

##### Subsequent events

The Plan has evaluated subsequent events through August 19, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

The Plan excludes employees covered under a collective bargaining agreement for which retirement benefits have been or are already being provided. Currently, the employees located at the Tacoma, Washington Vehicle Processing Center location are taking steps to form a union and will be transferring their balances out of the Plan in August 2025 to a plan set up under a collective bargaining agreement. The Plan was amended to permit these employees to continue their participation in the Plan until the transfer out.

#### Note 3 - Investments and information certified by the trustee:

Fidelity Management Trust Company (Fidelity) is the trustee for the Plan. Fidelity holds the Plan's investment assets and executes investment transactions. Management has determined that Fidelity is a qualified institution and the information prepared and certified by Fidelity meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity.

### Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB Accounting Standards Codification No. 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### Note 4 - Fair value measurements - continued:

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds, including those held in self-directed brokerage accounts, are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Interest-bearing cash, which includes amounts held in self-directed brokerage accounts, is stated at cost, which approximates fair value due to the short term nature of the investment.
- Self-directed brokerage accounts consist of mutual funds, common stocks, bonds and securities that are valued on the basis of readily determinable market prices.
- Units of participation in the CCT are based on the fair value of the contractual terms of the underlying assets/investment contracts. The CCT's are priced daily. The price is calculated based on the specific provisions of the contract and at the Plan level is reported at fair value in the statements of net assets available for benefits. A daily mil-rate is provided for income accretion. The daily mil-rate is a blend of the contracts' rate of return and liquidity component's daily mil-rate. The contract's rate of return is typically reset on a quarterly basis.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 - Related-party and parties-in-interest transactions:

Certain Plan investments are shares of mutual funds, interest bearing cash, a self-directed brokerage window, and a common/collective trust managed by an affiliate of Fidelity. Fidelity is the trustee as defined by the Plan and; therefore, these transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation.

#### Note 6 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Tax status:

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and; therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
