## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Healthcare Services 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 25, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period January 1, 2024 through October 25, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institution as of October 25, 2024 and December 31, 2023, and for the period January 1, 2024 through October 25, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, the Board of Directors of the Plan Sponsor of the Plan approved a plan of liquidation effective on January 1, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Information Required by ERISA**

The supplemental information of Schedule H, line 4a – schedule of delinquent participant contributions and Schedule H, line 4i – schedule of assets (held at end of year), as of October 25, 2024, or for the period January 1, 2024 through October 25, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

### Note 1 – Description of Plan

The following description of Healthcare Services 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General and eligibility

The Plan was established on January 1, 2015, as a defined contribution plan available to substantially all employees of Priority Care Group, LLC and certain participating affiliated entities (collectively, the Company, Employer or Plan Sponsor) who meet the Plan's eligibility and service requirements. The Plan was restated on January 1, 2022, to comply with certain tax legislation. Eligible employees may enter the Plan after reaching the age of twenty-one (21), as defined in the Plan document. There is no minimum services requirement for eligibility to participate in the Plan. Upon meeting the eligibility requirements, participants may enter the plan as soon as attaining eligibility. The Company is the Plan Administrator. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan merger and 2024 termination

On April 5, 2023, a portion of the Plan's assets and participants' accounts of certain participating employers were merged into the America's Healthcare Retirement Pooled Employer Plan I (the Successor Plan). As of that date, participant account balances and substantially all of the Plan's assets and liabilities were transferred to the Successor Plan. After the 2023 merger, one participating employer remained in the Plan. Effective January 1, 2024, the Plan Sponsor approved a plan of termination, ceased contributions to the Plan and fully liquidated the Plan's assets and distributed the participant accounts.

#### Contributions

Participants in the Plan may voluntarily contribute up to 100% of their annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained the age of fifty (50) before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans (rollover). Participants may make Roth 401(k) contributions under the Plan's provisions.

Prior to the approved plan of termination, the Company may make discretionary matching and/or profit-sharing contributions to the Plan. Participants must reach the age of twenty-one (21) and complete one thousand (1,000) hours of service in order to be eligible to receive the Company's discretionary matching contributions. For the period January 1, 2024 through October 25, 2024, the Employer did not make any contributions to the Plan. Employer contributions were invested in funds in accordance with the participants' direction and the Plan's provisions.

Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's contributions (if any), and (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of Plan's administrative expenses. Allocations are based on participant earnings or losses, deferrals, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

**Note 1 – Description of Plan, Continued**

Vesting

Upon termination of the Plan, participants become fully vested in their accounts.

Forfeitures

Forfeited nonvested accounts may be used to offset Plan administrative expenses or reduce future Employer contributions. During the period January 1, 2024 through October 25, 2024, forfeitures of \$13,720 were used to offset administrative expenses. As of October 25, 2024 and December 31, 2023, available forfeited nonvested accounts totaled \$0 and \$15,407, respectively.

Notes receivable from participants

Plan participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from one to five years unless the loan is used to acquire the principal residence of the participant, which must be repaid within ten years. Loans are secured by the balance in a participant's account and must bear a reasonable rate of interest. Principal and interest are paid through regular payroll deductions and remitted to the Trustee. Any delinquent notes receivable from participants are recorded as distributions, under the Plan's provisions.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, or in monthly installments. For termination of service due to other reasons, a participant may choose to leave the vested interest in the Plan if such amounts exceed \$5,000 or elect a lump-sum distribution. Participants with vested amounts less than \$5,000 must elect a lump-sum distribution. Benefit payments to participants are recorded upon distribution. Participants may elect to take an in-service distribution of vested funds if they meet certain defined requirements, including becoming disabled, reaching age 59½, or for heavy financial hardship needs, as defined.

Plan administration

The Company is the Plan Administrator and, as such, controls and manages the operations of the Plan. The Employer bears substantially all administrative expenses of maintaining the Plan in accordance with the Plan document. The Plan's investment assets are maintained by John Hancock Life Insurance Company, U.S.A (John Hancock or the Custodian). The Custodian invests cash received, interest and dividend income, and makes distributions to participants (subject to the direction of participants).

Fees from covered service providers of the Plan are in compliance with the Department of Labor's (DOL) regulations regarding ERISA Section 408(b)(2).

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting

The accompanying 2023 financial statements were prepared on the accrual basis of accounting.

The accompanying 2024 financial statements have been prepared under the liquidation basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update (ASU) 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan effective January 1, 2024.

Basis of accounting, continued

Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's advisor and Custodian. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual method. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Notes receivable from participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Related fees are charged directly to the borrowing participant's account and included in fees and administrative expenses when incurred. No allowance for credit losses has been recorded at October 25, 2024 and December 31, 2023. Any delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

Payment of benefits

The Plan records benefits when paid.

Plan expenses

For the period January 1, 2024 through October 25, 2024, the Plan classified certain administrative expenses as an expense rather than as a reduction of investment income. Substantially all Plan administrative expenses for maintaining the Plan are paid by the Employer and are not reflected in these financial statements.

Uncertain tax positions

U.S. GAAP requires Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan management has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

**Note 3 – Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental information is complete and accurate:

- Investments and participant notes receivable as shown on the statements of net assets available for benefits as of October 25, 2024 and December 31, 2023;
- Net investment activity and interest income on participant notes receivable as shown in the statement of changes in net assets available for benefits for the period January 1, 2024 through October 25, 2024; and
- Investment information included in Schedule H, Line 4i – Schedule of Assets (held at end of year) as of October 25, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 4 – Fair Value Measurements**

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

**Note 4 – Fair Value Measurements, Continued**

A financial investment’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at October 25, 2024 and December 31, 2023. During the period January 1, 2024 through October 25, 2024, there were no transfers of financial investments into or out of Level 3.

Following is a description of the valuation methodology used for assets measured at fair value:

*Pooled separate accounts* - Valued at its net asset value (NAV) based upon the units of such pooled separate accounts held by the Plan at year-end multiplied by the respective unit value. The unit values of the pooled separate accounts are based upon significant observable inputs but are not based upon quoted market prices in an active market and are therefore considered Level 2 investments within the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan’s investments measured at fair value, on a recurring basis, as of December 31, 2023:

**Note 5 – Fidelity Bond Non-Compliance**

For the period January 1, 2024 through October 25, 2024, the Plan was not covered by an adequate fidelity bond in accordance with regulations and requirements under ERISA.

**Note 6 – Tax Status**

On June 30, 2020, the IRS stated that the non-standardized pre-approved profit-sharing plan with CODA adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the Plan and its related trust are tax-exempt. The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since adoption; however, the Plan Administrator and the Plan’s tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in process for any tax periods. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 7 – Party-In-Interest Transactions**

Parties-in-interest are defined under the DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. The Plan’s investments consist of pooled separate accounts administered, maintained and managed by John Hancock. The Custodian’s affiliate John Hancock Retirement Plan Services (JHRP) is the Plan’s recordkeeper. Therefore, transactions with John Hancock and JHRP qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transactions rules under ERISA. Certain administrative functions are performed by officers and employees of the Employer. No officer or employee receives compensation from the Plan for these services.

**Note 8 – Plan Termination**

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. On January 1, 2024, as described in Note 1, the Plan Sponsor resolved to terminate the Plan effective January 1, 2024. Participants become 100% vested in their accounts as of the termination date.

**Note 9 – Delinquent Participant Contributions**

ERISA Section 2510.3-102, requires the Plan Sponsor to segregate participant contributions from its general assets as soon as it is practicable. For the years ended December 2023 and 2022, the Plan Sponsor failed to timely remit to the Plan certain participant contributions and loan repayments totaling \$20,386 and \$174,054, respectively, within the period prescribed by DOL regulations. Such transactions are non-exempt party-in-interest transactions as defined by ERISA. The 2023 and 2022 delinquent participant contributions were corrected subsequent to October 25, 2024.

**Note 10 – Subsequent Events**

The Plan evaluated events occurring subsequent to October 25, 2024 through September 30, 2025, the date on which the financial statements were available to be issued, for matters that should be recorded in the financial statements or disclosed in the footnotes thereto.
