Independent Auditor's Report

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1: DESCRIPTION OF PLAN

The following description of the Metropolitan Companies 401(k) Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees of Metropolitan Management Group and related employers: Metropolitan Development Group, Inc., Metropolitan Commercial Development, LLC, and Foxlane Homes, LLC (Company). The Plan was initially effective January 1, 2020. The Plan is intended to meet the requirements of Section 401(k) of the Internal Revenue Code (IRC) and is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - All employees, except those employees of an employer acquired as part of a code section 410(b)(6)(C) transaction, that have had one year of service and are 21 years of age, are eligible to contribute elective deferrals as soon as administratively feasible. Participants may receive an employer-matching contribution after being credited with three months of service. Entry into the plan is the date the minimum age and service requirements are satisfied.

Contributions - Participants may contribute a percentage of their eligible pretax compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may designate all, or a portion of, their elective deferral contributions as after-tax Roth elective contributions. A Roth contribution is defined as being made in lieu of all, or a portion of, the pre-tax elective deferral the participant is otherwise eligible to make under the Plan and treated by the Company as includible in the participant's income. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Upon enrollment, participants may direct their contributions to the various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible contributions and their contributions are invested in a designated balanced fund until changed by the participant. The Company may make a discretionary matching contribution to the Plan. The Company may contribute a discretionary employer contribution in a permitted disparity allocation. An employee must be employed by the Company on the last day of the plan year and be credited with at least 1,000 hours of service during the plan year to receive an allocation of the employer contribution. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of the Companies' matching contribution, if any, investment results, and charged with an allocation of administrative expenses, as provided by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1: DESCRIPTION OF PLAN - CONTINUED

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and Company contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 0% vested with 0-1 years of service and 20% vested with two years of service. Vesting increases 20% each year thereafter until the participant is 100% vested after six years of service.

Employer Contributions Receivable - As of December 31, 2024 and 2023, employer contributions receivable amounted to \$221,070 and \$188,195, respectively.

Payment of Benefits - Distributions from the Plan are permitted upon termination of employment, death, disability, retirement (age 65), or hardship. An eligible participant may request a single lump-sum payment. A participant may receive an in-service distribution upon attaining age 59½.

If a terminated participant does not elect to have a mandatory distribution not exceeding \$1,000 paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, the plan administrator will direct the custodian to immediately distribute such benefit in a lump sum without the participant's consent. For any distribution exceeding \$1,000 but not in excess of \$7,000, the participant shall be given the option to elect to have such distribution paid directly to an eligible retirement plan specified by him or her in a direct rollover or to receive the distribution directly. If neither option is selected, the plan administrator shall make such distribution in a direct rollover to an individual retirement account designated by the plan administrator and shall provide written notices to the participant informing the participant that he or she has the option to transfer such amount in the individual retirement account or plan of his or her own choice.

As required under Section 401(a)(9) of the IRC, a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the calendar year following the year in which the participant reaches age 73, or (ii) the calendar year in which the participant retires. Each year the minimum is recomputed based on the participant's and spouses, if married, current life expectancies and the value of the then-remaining account. The participant may elect a larger payment.

Hardship Withdrawals - Participants may withdraw their elective deferrals under the Plan to the extent permitted by the individual agreements controlling the account assets to be withdrawn in the form of a hardship withdrawal to satisfy an immediate and heavy financial need as defined by the Plan. The participant must first exhaust all other assets reasonably available prior to obtaining a hardship withdrawal. The hardship distribution cannot be in excess of the need.

Forfeitures - As of December 31, 2024 and 2023, the forfeiture account balance was \$34,119 and \$10,829, respectively. Forfeitures may be used to pay plan expenses or reduce company contributions. There was no use of forfeitures during the year ended December 31, 2024.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits - Benefit payments to participants, or their beneficiaries, are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Company's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The Company has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under the Financial Accounting Standards Board's Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurements*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be activity traded.

NOTE 3: FAIR VALUE MEASUREMENTS - CONTINUED

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Mid Atlantic Trust Company. Mid Atlantic Trust Company is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The Company has not considered normal plan operations such as participant and employer contributions or benefits paid to participants as party-in-interest transactions that require separate disclosure. Certain plan investments are shares of registered investment companies (mutual funds) managed by Mid Atlantic Trust Company. Fees paid during the year for certain professional services rendered by parties in interest included service fees paid by the Plan for investment advisory services. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 7: TAX STATUS

The underlying July Business Services Non-Standardized Pre-Approved Profit-Sharing Plan with Cash or Deferred Arrangement (CODA) has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan and related trust were designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and that the related trust is tax exempt.

NOTE 7: TAX STATUS - CONTINUED

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or the IRS. The Organization has analyzed the positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's federal Form 5500 is subject to examination by the IRS and DOL, generally for three years after it is filed.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9: COMMITMENTS AND CONTINGENCIES

In the normal course of business, there may be various commitments and contingencies outstanding, which are not reflected in these financial statements. In the opinion of the Company, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

NOTE 10: PLAN AMENDMENT

Effective April 6, 2023, the Plan was amended to exclude interns, temporary employees, and independent contractors from being eligible to participate in the plan. An intern, temporary employee, and independent contractor is an employee whose regularly scheduled service is less than 1,000 hours of service in the relevant eligibility computation period. However, if such employee works 1,000 hours in an eligibility period than that excluded employee will no longer be part of the excluded class.
