## Independent Auditor's Report

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

**Note A. Description of the Plan**

The following description of the Hero Digital, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan was established on July 1, 2017 as a defined contribution retirement plan for the exclusive benefit of all eligible employees of Hero Digital, LLC (the "Company") and related employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company is the Plan Sponsor and serves as Plan Administrator. The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Plan Merger*

Avionos, LLC was acquired by the Company and its plan was merged with the Hero Digital, LLC 401(k) Plan effective February 1, 2024. As a result, net assets of \$6,239,038 were transferred to the control of the Plan. Coinciding with the merger, effective February 1, 2024, the Plan was amended to recognize prior service of merged participants for purposes of eligibility and vesting. Vesting for these participants was not affected by the merger, as the vesting schedule for employer matching contributions under the Plan remained consistent with that of the previous plan.

*Contributions*

Each year, eligible participants may contribute both pretax and Roth elective deferrals, as defined in the Plan. Pretax and Roth elective deferrals are limited to 90% of a participant's eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may contribute a discretionary matching contribution each Plan year equal to a uniform percentage of each eligible participant's pretax and Roth elective deferrals determined by management. Contributions are subject to certain Internal Revenue Service limitations.

*Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of (a) Company's contributions when made and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined and provided for in the Plan document. The benefit to which a participant is entitled is limited to the amount that can be provided from the participant's vested account balance. The investment direction for the account is provided by the participant.

*Vesting*

Participants are immediately 100% vested in their elective deferrals and rollover contributions, plus actual earnings and losses thereon. Participants are vested in the Company's discretionary contributions after three years of credited service. Prior to January 1, 2020, participants were 100% vested after one year of credited service for discretionary contributions. Any participant that was eligible for the Plan prior to January 1, 2020 will vest according to the former, more favorable, vesting schedule.

**Note A. Description of the Plan** (continued)

*Notes Receivable from Participants*

Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest between 4.25% to 9.50%. Loan terms, unless for the purchase of a principal residence, are not to exceed five years. Participants are limited to one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions. Delinquent loans are treated as distributions based upon the terms of the Plan document.

*Benefits Paid to Participants*

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum payment in an amount equal to the value of the participant's vested portion of their account. In the event of termination of employment before retirement, a participant will be entitled to receive their vested account balance. If a terminated participant's vested account balance is greater than \$5,000, such participant may leave their funds in the Plan. If the terminated participant's vested account balance is equal to or less than \$5,000, the Company may elect to distribute the participant's funds without consent. A participant may elect a 401(k) hardship distribution prior to their separation from service in accordance with the hardship distribution policy.

If a participant has attained age 65 (normal retirement), the participant is entitled to their entire account balance and may elect to receive all or any portion of the balance prior to their separation from service.

*Forfeited Accounts*

Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures may be used to first reduce future employer contributions to the Plan, with the excess used to fund Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$65,181 and \$134,905 respectively.

**Note B. Summary of Significant Accounting Policies**

*Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

*Contributions*

Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

*Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Note B. Summary of Significant Accounting Policies** (continued)

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Benefits Paid to Participants*

Benefit payments to participants are recorded when paid.

*Investment Valuation and Income Recognition*

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included as a reduction of net appreciation in fair value of investments.

**Note C. Certified Information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023; and,
- Net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Note D. Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

---

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

---

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan were deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note E. Party-In-Interest Transactions**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are managed by the trustee of the Plan. Therefore, these transactions and the Plan's payment of fees to the trustee qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**Note F. Plan Termination**

Although the Company has not expressed any intent, the Company has the right under the Plan to discontinue, amend or modify, and terminate the Plan without any liability for such termination subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in any unvested portion of their accounts.

**Note G. Income Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note H. Risks and Uncertainties**

The Plan invests in several funds which hold various investment securities. Investment securities are exposed to interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note I. Contingent Plan Receivable**

Subsequent to year end, Plan management identified certain wages that were excluded from compensation used in the computation of employee and employer contributions, though the Plan document states these are eligible wages. Management is currently evaluating the nature and extent of the discrepancy, as well as its potential impact on participant accounts and Plan operations. As of the date of these financial statements, the required corrective contribution has not been determined and therefore has not been recorded and accrued for in these financial statements.

**Note J. Subsequent Events**

The Plan Administrator has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

Effective January 20, 2025, the Plan was amended to allow Huge LLC and Hello Elephant, LLC, related employers, to participate in the Plan.
