## Independent Auditors' Report

### Opinion

### Note 1 - Description of Plan

The following description of Mueller Industries, Inc. Welfare Benefit Plan provides only general information. Readers should refer to the plan agreement and associated separate plan documents for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

#### General

Mueller Industries, Inc. Welfare Benefit Plan (the "Plan") is a health and welfare benefit plan established to provide participants and beneficiaries certain health and welfare programs sponsored by Mueller Industries, Inc. and its subsidiaries (collectively, the "Company"). Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The various individual programs provided for under this Plan are outlined in the respective plan documents and, hereinafter, are collectively referred to as the Programs. Benefits provided for under the Programs include health, prescription drug, dental, vision, life insurance, accidental death and dismemberment, severance, healthcare spending account, dependent care and medical reimbursement accounts, and others. Eligible retirees include former employees of certain subsidiaries of Sharon Steel Corporation (the corporate predecessor to the Company). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Certain Programs are fully insured while others, primarily certain health programs, are self-funded subject to stop-loss contracts entered into with various carriers. Benefits are paid solely in the form and amount pursuant to the terms of each individual Program.

An employee becomes eligible to participate in the Plan when he or she satisfies the eligibility and participation requirements of any one of the individual Programs. Whether or not a participant is eligible to receive a specific benefit is dependent upon the terms of the specific Program in which he or she is eligible to participate. Substantially all current fulltime U.S. employees, including those represented under collective bargaining agreements, are eligible to participate in at least one, but not all, of the individual Programs. The terms of each individual Program govern the amount and timing of participant and employer contributions. When participant contributions are required, the participant must authorize the employer to make the appropriate payroll withholdings. The Company funds the majority of the costs of retiree benefits. Employees and retirees contribute specified amounts, determined periodically by the plan administrator or the Plan's insurance companies, to extend coverage to eligible dependents. The Company makes contributions necessary to cover the benefit obligations of the Plan.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The Plan's policy is to prepare its financial statements on the cash basis of accounting; consequently, certain revenues and the related assets are recognized when received rather than when earned, and certain expenses and the related liabilities are recognized when paid rather than when the obligations are incurred. Accordingly, the accompanying financial statements are not intended to be presented in accordance with accounting principles generally accepted in the United States of America.

#### Use of estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities and the actuarial present value of postretirement benefit obligations at the date of the financial statements. Accordingly, actual results could differ from those estimates.

#### Payment of benefits

Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims administrator.

#### Stop loss

Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits, totaling \$1,121,802 in 2024 and \$1,173,624 in 2023.

#### Refunds

The Plan utilizes a pharmacy benefit manager to help control drug costs. The benefit manager pays refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. There is an inherent lag between the periodic capture and calculation of refunds due the Plan and receipt of such refunds. Refunds are recorded when received.

#### Administrative expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses are paid by the Company on behalf of the Plan.

### Note 3 - Actuarial present value of benefit obligations

#### Claims incurred but not reported

Plan obligations for health claims incurred but not reported at year end include actual claims incurred and paid during the first ninety days of the following plan year, and an additional amount based upon management's review of the previous eighteen month period for claims paid after this ninety day period.

#### Postretirement benefit obligations

Postretirement benefit obligations have been recognized for eligible participants and their dependents upon retirement and represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the Company and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently eligible retired or terminated employees and their beneficiaries and dependents, and (b) certain active employees and their beneficiaries and dependents after retirement. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of postretirement benefit obligations is determined by actuaries for the Mueller Brass Company Postretirement Medical and Life Insurance Plan, the Extruded Metals Postretirement Medical and Life Insurance Plan, the U.S. Fuel Company Plan, and other OPEB programs sponsored by acquired companies. It is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and adjusting such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The computation of the actuarial present value of postretirement benefit obligations was made as of December 29, 2024 and January 1, 2024 for the years ended December 31, 2024 and 2023, respectively. Had the valuation for 2023 been performed as of December 31, 2023, respectively, there would be no material difference.

The following were significant assumptions used to determine the actuarial present value of postretirement benefit obligations for the years ended December 31, 2024 and 2023.

The weighted-average healthcare cost trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the aggregate postretirement benefit obligation as of December 31, 2024 and 2023 by \$159,442 and \$181,994, respectively. If the assumed rates decreased by one percentage point in each year, it would decrease the aggregate postretirement benefit obligations as of December 31, 2024 and 2023 by \$144,768 and \$165,572, respectively.

*Age related morbidity* - Increases in unit costs with age have been derived from employer and insurance carrier data.

*Spouses' assumptions* - Actual spousal data for current retirees has been reflected in this valuation.

*Mortality rates for death after retirement* - For 2024 and 2023, PRIA-2012 mortality study with blue collar adjustments projected generationally from 2012 with Scale MP-2021.

*Mortality rates for disabled lives* - For 2024 and 2023, PRIA-2012 mortality study projected generationally from 2012 with Scale MP-2021 for Disabled.

The foregoing assumptions are based upon the presumption that the Plan will continue. If the Plan were terminated, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations. Obligations for health claims incurred by participants, but not reported as of the end of the Plan year, are

estimated by the Company using the Plan's historical claim payment pattern data. The Plan's deficiency of net assets compared to benefit obligations relates primarily to postretirement benefit obligations. The deficiency of net assets over benefit obligations will be funded through future employer and participant contributions.

### Note 4 - Tax status

The trust funding the Plan has received an exemption letter from the Internal Revenue Service (IRS), dated June 7, 1994, which states that the trust is tax-exempt under the provisions of section 501(c)9 of the Internal Revenue Code (IRC) as a VEBA. The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan has requested a new exemption letter for the trust but has not yet received it as of the date of the report. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 5 - Related party transactions and party-in-interest transactions

The Plan is provided certain services by third parties and the fees paid for such services qualify as party-in-interest transactions. Fees paid for claims administration services totaled \$1,284,634 in 2024 and \$1,428,509 in 2023.

### Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue contributions at any time, and to terminate the Plan subject to the provisions of ERISA and the associated separate plan documents. If the Company terminates or partially terminates the Plan, the trust will pay benefits that participants are entitled to receive under the terms of the Plan through the date of termination. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

### Note 7 - Risks and uncertainties

Plan contributions are made and the actuarial present value of benefit obligations are reported based upon certain assumptions pertaining to discount rates, healthcare trend rates, and employee demographics, all of which are subject to change. Due to the uncertainties inherent in the estimation and assumptions processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

### Note 8 - Subsequent events

Plan management has evaluated subsequent events through September 30, 2025, which is the date that the financial statements were available to be issued.

On January 1, 2025, employees of Nehring Electrical Works Company, Unified Wire & Cable, Inc., and Elkhart Products Company became eligible to participate in the Plan.
