INDEPENDENT AUDITOR'S REPORT

Robert Stopher, Plan Administrator Boehl Stopher & Graves Amended and Restated Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Boehl Stopher & Graves Amended and Restated Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits Boehl Stopher & Graves Amended and Restated Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Boehl Stopher & Graves Amended and Restated Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS
YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Boehl Stopher & Graves Amended and Restated Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

GENERAL – The Plan is a defined contribution plan covering all employees of Boehl Stopher & Graves, LLP (Partnership) who have completed one year of service with 1,000 hours and are age 21 or older. Employees who have completed one year of service with 500 hours and are employed by the Partnership on the last day of the Plan year are eligible to receive the Partnership's match and non-elective contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). A committee consisting of three or more members appointed by the Partnership is responsible for the oversight of the Plan.

Effective August 3, 2023, the Plan was amended to add a qualified Roth contribution program to the Plan and to incorporate the Roth requirements for catch-up contribution from the SECURE 2.0 Act of 2022.

CONTRIBUTIONS – Each year, participants may contribute up to the dollar amount set by law of their pre-tax annual compensation, as defined by the Plan, with pre-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Partnership may elect, at its discretion, to contribute matching contributions or qualified non-elective contributions. For 2024, the Partnership elected to match 50% of participant elective deferrals up to 5% of eligible compensation, as well as a non-elective contribution of 5% of eligible compensation. During the year ended December 31, 2024, the Partnership's total contributions to the Plan were \$155,846. Contributions are subject to certain IRS limitations.

PARTICIPANT ACCOUNTS – Each participant's account is credited with the participant's contributions and Partnership matching and non-elective contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may choose to invest among various participant directed funds through State Street Bank and Trust and TransAmerica Trust Company, or they may choose personal choice retirement account (PCRA) investments through Charles Schwab. Participants who choose the PCRA may invest in any type of investment available through Charles Schwab, including bonds, stocks, and mutual funds. The Partnership absorbs any significant costs of the participant directed funds' accounts administration, but participants who choose the PCRA must pay any Charles Schwab management fees from retirement assets.

VESTING – Participants are vested immediately in all contributions and account balances.

NOTES RECEIVABLE FROM PARTICIPANTS – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have two loans outstanding at a time. The loans are secured by the balance in the participant's accounts. The loan interest rate is based on the Prime Rate, as defined. Principal and interest are paid ratably through payroll deductions.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

PAYMENT OF BENEFITS – On termination of service due to retirement, a participant may elect to receive a lump sum distribution equal to the value of the participant's vested interest in his or her account or installment payments. On termination of service due to death, the designated beneficiary will receive a distribution under the method that is applicable in the current IRS guidelines.

For terminated participants whose vested account balances are over \$5,000, the participant may elect to receive a lump sum distribution in cash or a rollover or leave their funds in the Plan. For accounts with vested balances between \$1,000 and \$5,000, the participant may elect to receive a lump sum distribution in cash or a rollover, or the account will automatically be rolled over to a traditional IRA. For accounts with balances less than \$1,000, a lump sum will be distributed for the entire vested amount upon termination without the participant's consent, if the participant does not make an election by the required date.

FORFEITED ACCOUNTS – Participants vest immediately in all contributions and account balances. Therefore, there are no forfeitures.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

BASIS OF ACCOUNTING – The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's oversight committee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 3 – Fair Value Measurements for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Accrued but unpaid interest was \$466 and \$586 as of December 31, 2024 and 2023, respectively. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

PAYMENT OF BENEFITS – Benefits are recorded when processed and approved for payment by the Plan.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

EXPENSES – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Partnership. Expenses paid by the Partnership are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments or separately as expenses.

Certain administrative and investment advisory fees related to the Plan's operations are paid indirectly through the investment vehicles held by the Plan. These fees, often referred to as revenue sharing, are paid by the mutual funds and other investment vehicles to the Plan's investment advisor.

For the year ended December 31, 2024, the Plan's investment advisor received indirect compensation from mutual fund companies for services provided to the Plan. The compensation is generally calculated as a percentage of the Plan's assets invested in those funds.

All direct and indirect compensation received by the Plan's service providers has been disclosed to the Plan's fiduciaries in accordance with Department of Labor regulations. The Plan's fiduciaries review this information to ensure the total fees paid by the Plan are reasonable for the services rendered.

RECLASSIFICATIONS – Certain accounts relating to the prior year have been reclassified to conform to the current year presentation with no effect on previously reported net income.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Investments are measured at fair value using the net asset value per share or its equivalent, practical expedient, and therefore not classified under the fair value hierarchy. These securities can be redeemed daily.

NOTE 4 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, and administrative expenses for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (the trustee) and Transamerica Trust Company (the custodian).

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in a cash reserve account managed by State Street Bank and Trust Company, which is the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Certain Plan investments are invested in a collective trust fund managed by Transamerica Retirement Solutions, the recordkeeper of the Plan, and mutual funds managed by an affiliated company, Transamerica Partners Funds Group. These transactions also qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in administrative expenses and are allocated to participants' accounts. The Company pays directly any other fees related to the Plan's operations.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Internal Revenue Service ruled on June 30, 2020, that the Volume Submitter Plan of Transamerica Retirement Solutions Corporation, upon which the Plan is based, was designed in accordance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.
