### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Celltron, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Celltron, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO THE FINANCIAL STATEMENTS  
December 31, 2024 and 2023

NOTE 1—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of Celltron, Inc. 401(k) Profit Sharing Plan (the Plan) are kept on the accrual basis.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3—Investments and Fair Value Measurements for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

The Plan follows the provisions of Topic 962 of the Financial Accounting Standards Board Accounting Standards Codification, which requires participant loans to be classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the cash basis, which approximates accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance may be reduced and a benefit payment recorded based on the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Celltron, Inc. (the Company). Expenses that are paid by the Company are excluded from these financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through September 25, 2025, the date which the financial statements were available for issue.

## NOTE 2—DESCRIPTION OF PLAN

The following description of the Celltron, Inc. 401(k) Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering substantially all nonunion employees of Celltron, Inc. (the Company) who have completed two months of employment and are age 18 years or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

Participants may contribute up to 90% of their compensation, subject to the maximum limits established in the Internal Revenue Code.

The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company, of the participants' elective deferrals. Elective deferrals will be matched by a discretionary percentage of participants' contributions or dollar amount as determined by the Company. The Company currently contributes fifty cents for each dollar of participant elective deferrals up to 3% of compensation.

The Company may also make an additional profit sharing contribution at the end of a Plan year for the benefit of those participants who have completed 500 hours of service during the year. No such contributions were made in 2024 and 2023.

Participants direct the investment of their contributions as well as the Company's contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and one pooled fund as investment options for participants.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings, and is charged with an allocation of losses and administrative expenses and investment advisory fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting and Forfeitures

Participants are immediately vested in their voluntary contributions and are 100% vested in the Company's matching and profit sharing contributions after one year of service.

Forfeitures occur upon termination of employment of participants who are not fully vested in the Plan. Amounts forfeited are transferred to an investment account, which is included in the Plan's assets, and may be used to pay administrative expenses of the Plan or reduce the Company's contributions. The balance in this account as of December 31, 2024, is \$1,030. The amounts used to reduce Company contributions for the years ended December 31, 2024 and 2023, were \$663 and \$601, respectively.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. All loans must be repaid within five years, except for loans used to acquire any dwelling to be used as the participant's principal residence. The notes are secured by the balance in the participant's account and bear interest at the rates of 4.25% - 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

On termination of service, a participant will normally receive a lump sum amount equal to the value of the participant's vested interest in their account.

### NOTE 3—INVESTMENTS AND FAIR VALUE MEASUREMENTS

The Plan's investments at December 31, 2024 and 2023, were held by the Plan's trustee, Reliance Trust Company, and are reported at fair value in the accompanying statements of net assets available for benefits.

The Plan has determined the fair value of certain assets and liabilities through application of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10. FASB ASC 820-10 defines fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the Plan's principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The standard establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described below:

- Level 1 inputs - are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.
- Level 2 inputs - are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs - are unobservable inputs for assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- **Mutual Funds:** are valued based on quoted net asset values of the shares held by the Plan at year end. These investments, therefore, are classified as using Level 1 inputs.
- **Common Collective Trust Funds:** these are stable value funds valued at Net Asset Value (NAV) of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trusts, the issuers reserve the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

During 2024 and 2023, the Plan's investments (including gains in investments bought and sold, as well as held during the year) appreciated in value by \$341,861 and \$451,594, respectively.

**NOTE 4—SUMMARY OF INFORMATION CERTIFIED BY TRUSTEE OF PLAN UNDER SECTION 29 CFR 2520.103-8 OF THE DEPARTMENT OF LABOR'S RULES AND REGULATIONS FOR REPORTING AND DISCLOSURE UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974**

Reliance Trust Company, the trustee of the Plan, holds the Plan's investment assets and executes transactions therein. Financial information relating to those assets is included in the accompanying financial statements based on information provided by the trustee. The Plan administrator has obtained certifications from the trustee, as of and for the years ended December 31, 2024 and 2023, that such information is complete and accurate. That information, which has not been audited by independent accountants, is summarized as follows:

- a. Investment balances and transactions
- b. Participant loan balances and transactions
- c. Investment income (loss) and accrued income

**NOTE 5—TERMINATION OF THE PLAN**

The Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan. In the event of termination or partial termination of the Plan or discontinuance of contributions thereto, the interests of the participants in the Plan shall be fully vested at the time of such termination or discontinuance. The trustee shall continue to administer the funds in the Plan until all obligations of the Plan have been satisfied.

#### NOTE 6—INCOME TAX STATUS

The Plan was amended and restated effective April 1, 2022. This was done by the adoption of a prototype plan. The Internal Revenue Service has determined by letter dated October 6, 2020, that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

#### NOTE 7—RELATED PARTY TRANSACTIONS

The Plan made payments to the recordkeeper, ADP, Inc., for recordkeeping and administrative services rendered to the Plan for 2024 and 2023 in the amounts of \$36,694 and \$30,740, respectively.

Certain significant costs of operating the Plan are absorbed by the Plan sponsor.

#### NOTE 8—RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
