## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Cherokee Health Systems, Inc.:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Cherokee Health Systems, Inc. Tax-Deferred Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

The following description of the Cherokee Health Systems, Inc. Tax-Deferred Retirement Plan (the Plan) provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of Cherokee Health Systems (the Plan sponsor). The Plan covers substantially all employees beginning with their date of hire (participants). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions:* Participants may voluntarily make qualified retirement contributions to the Plan which may be Roth deferrals or pre-tax deferrals deductible by the participants for federal income tax purposes under Section 403(b) of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions are permitted up to the annual IRC limit.

The Plan automatically enrolls all employees who normally work 20 hours or more per week at a deferral rate of 3%, unless the employee elects not to participate in the Plan or elects a different deferral rate. Participant deferral rates automatically increase 1% each year as of the anniversary of the date the participant's account was first established. The increase will continue each year until the participant has reached a maximum deferral rate of 10% or the participant specifically elects otherwise.

Participants who are age eighteen or older and have completed one year of service which is defined as at least 1,000 hours of service in a twelve-month period are also eligible to receive matching contributions and employer contributions from the Plan sponsor. Employer contributions are made to all participants at 3% of eligible compensation regardless of whether the participant makes any contributions. In addition, if a participant makes contributions, the Plan sponsor also matches those contributions not to exceed 3% of eligible compensation.

*Participant Accounts:* Each participant's account is credited with the Plan sponsor's contributions as calculated above and participant's contributions. Each participant account is credited or charged with the actual investment earnings (losses) of the investment options selected by the participant, an allocation of administrative expenses, and an allocation of forfeitures of terminated participants' non-vested accounts if not used to reduce the Plan sponsor's contributions. Allocations are based on account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are immediately vested in their voluntary salary deferral plus actual earnings (losses) thereon. Vesting in the Plan sponsor's contributions is based on years of continuous service. Participants are 100% vested after 6 years of service as following:

Participants may also become 100% vested upon full or partial termination of the Plan, or in one of the following ways, if incurred while employed: (1) death, (2) disability, or (3) reaching the age of 59 ½.

*Notes Receivable from Participants:* Participants may generally borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable from participants are secured by the balance in the participant's vested account and bear interest at fixed rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the plan administrator when the loan was originated. Principal and interest are collected ratably through payroll deductions.

*Payment of Benefits:* Upon termination of service due to death, permanent disability, or retirement, a participant may elect to receive either a lump-sum payment, purchase an annuity contract or receive annual installments over a specified period equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution or installments.

*Forfeited Accounts:* Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan sponsor's contribution portion of their accounts. Such forfeitures may reduce the Plan sponsor's contribution to the Plan or be reallocated to the remaining participants.

Participants who have 100% non-vested balances when they terminate forfeit their entire balance on the date they terminate. For participants who are partially vested in their account balance when they terminate, forfeitures are determined at the earlier of (1) the last day of the Plan year in which the former participant incurs five consecutive one-year breaks in service or (2) the distribution of the vested portion of the participant's account. Potential forfeited amounts which had not yet met the five-year break in service period requirement, or the vested portion distributed were \$37,822 and \$33,512 as of December 31, 2024 and 2023, respectively. The Plan utilized \$111,417 in 2024 to reduce Plan sponsor contributions to the Plan and to pay plan expenses.

*Hardship Withdrawals:* The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59 <sup>1/2</sup>. Hardship withdrawals are limited to the participant's elective account balance.

*Administrative Expenses:* Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Custodian fees associated with administering the Plan and processing distributions are paid from the assets of the Plan and are charged to the participant's account and are included in administrative expenses. Fees incurred and paid by the Plan for investment management services are included in net (depreciation) appreciation in fair value of investments.

*Plan Termination:* Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in the Plan sponsor contribution portion of their accounts.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting:* The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Investment Valuation and Income Recognition:* Investments are stated at fair value, except for the fully benefit-responsive insurance contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are classified as distributions based upon the terms of the plan document.

*Payment of Benefits:* Benefits are recorded when paid.

*Use of Estimates:* The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### NOTE C--INFORMATION CERTIFIED BY THE CUSTODIAN AND INSURANCE COMPANY

Certain information reported and disclosed in the accompanying financial statements and supplemental schedule, including the fair or contract value of investments and notes receivable from participants held at December 31, 2024 and 2023, net change resulting from investment activity, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company (Empower Insurance) and Voya Retirement Insurance and Annuity Company (Voya).

#### NOTE D--FAIR VALUE MEASUREMENTS

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3).

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- *Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan holds various pooled separate accounts. Empower Insurance has reported its pooled separate accounts as direct filing entities. Voya has not reported its pooled separate accounts as direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named.

#### NOTE E--INSURANCE CONTRACTS WITH INSURANCE COMPANIES

The Plan has a guaranteed income fund with Empower Insurance and a guaranteed insurance contract with Voya, which meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Insurance and Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was \$5,208,107 and \$6,210,481, respectively.

The Plan's ability to receive amounts due is dependent on Empower Insurance's and Voya's ability to meet its financial obligations. The issuers' ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Empower Insurance and Voya. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow Empower Insurance and Voya to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### NOTE F--INCOME TAX STATUS

The Plan sponsor adopted a 403(b) volume submitter plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on August 7, 2017, which stated that the 403(b) volume submitter plan is designed in accordance with the applicable requirements of the IRC. The Plan itself has not yet received a determination letter from the IRS stating that the Plan is qualified under Section 403(b) of the IRC. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **NOTE G--RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are shares of mutual funds, pooled separate accounts, and insurance contracts managed and administered by Empower Insurance or Voya, and therefore, these transactions qualify as party-in-interest transactions under ERISA. The Plan holds notes receivable from participants, which also qualify as party-in-interest transactions. As described in Note A, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions. Fees paid by the Plan to Empower Insurance totaled approximately \$33,267 for the year ended December 31, 2024.

#### **NOTE H--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

#### **NOTE I--SUBSEQUENT EVENTS**

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. On June 24, 2025, the Plan Sponsor changed its legal name from Cherokee Health Systems to River Valley Health. The name change does not affect the operation or administration of the Plan. All responsibilities and obligations of the Plan Sponsor under the Plan remain unchanged. Management did not note any other material recognizable subsequent events that required recognition or disclosure in the financial statements, other than disclosed above.
