### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed audits of the accompanying financial statements of the Emerge Community Development 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Emerge Community Development 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### 1. DESCRIPTION OF THE PLAN

The following description of the Emerge Community Development 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan was adopted effective April 1, 2019, and was amended on March 27, 2020, to comply with Internal Revenue Service regulations. The Plan's Sponsor and Plan Administrator is Emerge Community Development (the Company) and the Plan's Custodian is Alerus Financial, N.A. (the Custodian).

**General** – The Plan is a defined contribution plan covering all eligible employees, as defined, of the Company. Non-resident aliens and employees who normally work less than 20 hours per week are excluded from Plan participation. Employees are eligible to make deferrals upon commencement of employment. In order to be eligible for the Company's nonelective contributions, employees are 21 years or older and have completed one (1) year of service as well as fulfilling the age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** – Participants are allowed to make both voluntary pretax and Roth contributions of eligible compensation, as defined, to their plan accounts. Participants may also make rollover contributions from qualified benefit plans of previous employers. The Company may also contribute on a discretionary basis a match equal to a percentage of employee contributions. In 2024, the Company made a discretionary matching contribution equal to 100% of the employee's contribution up to 4%. The Plan allows for additional non-elective contributions in amounts determined at the sole discretion of the Company. In 2024, the Company made an additional non-elective contribution equal to 2% of eligible employees' earnings. Contributions are subject to certain limitations.

**Vesting** – Participants are immediately vested in their voluntary and rollover contributions. Vesting in the Company's voluntary matching contributions and additional discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is one hundred percent vested after three years of credited service.

**Forfeitures** – Forfeitures can be used to pay administrative expenses of the Plan or reduce Company discretionary matching or nonelective contributions. Forfeited non-vested accounts totaled \$45 and \$6,657 at December 31, 2024 and 2023, respectively. In 2024, no forfeitures were used to reduce Company discretionary matching and nonelective contributions and \$10,792 were used to pay administrative expenses.

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions, the Company’ discretionary matching contributions, if any, allocations of (a) the Company’s nonelective contributions, if any, and (b) plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

**Notes Receivable** – Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan transactions are treated as a transfer to or from the investment fund from or to the participant’s loan fund. Loan terms range from one to five years, or a longer term for the purchase of a primary residence. The loans are secured by the balance in the participant’s account, and the interest rate charged is 4.25% to 9.50%. Principal and interest is paid ratably through biweekly payroll deductions.

**Payment of Benefits** – On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant’s account in either a lump-sum amount, or in annual installment options as specified in the Plan. For termination of service due to other reasons, participants with vested accounts of less than \$5,000 will have their vested balance distributed as soon as administratively possible. Participants with vested accounts greater than \$5,000 may receive the value of the vested interest in his or her account as a lump-sum distribution or minimum required distributions. The Plan also allows for in-service withdrawals and hardship withdrawals subject to Plan provisions.

**Investment Options** – Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Company contributions are allocated on the same basis as employee contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, except for distributions paid to participants which are prepared on the cash basis of accounting.

**Valuation of Investments** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates** – The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded (deemed distribution).

**Payment of Benefits** – Benefits are recorded when paid.

**Administrative Expenses** – The Company pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

#### 4. INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The volume submitter plan document adopted by the Plan obtained its latest advisory letter on March 31, 2017, in which the Internal Revenue Service stated that the volume submitter, as then designed, was in compliance with the applicable requirements of the Code. The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the advisory letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

#### 5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market fund:** Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end fund that is registered with the U.S. Securities and Exchange Commission. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The fund held by the Plan is deemed to be activity traded.
