INDEPENDENT AUDITOR'S REPORT

To the Trustee, Plan Administrator and Participants of
Finch Turf Inc. Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Finch Turf Inc. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan, established on January 1, 1976, is a defined contribution plan of Finch Turf Inc. and related employers who have adopted the Plan as participating employers (Jackson Properties, Inc. and O'Brien Holding Co. (collectively, the Company)). The Plan is subject to the provisions of ERISA.

On December 29, 2022, the SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed throughout these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: The Plan covers substantially all employees of the Company who are 18 years of age or older and have completed three consecutive months of service. Employees covered by a collective bargaining agreement are not eligible to participate. Employees are eligible to participate in the Plan for deferral contributions and QACA Safe Harbor contributions on the first day of each calendar quarter. Service with the following predecessor employers is credited for purposes of eligibility and vesting: W.L Sterner, Inc., Suburban Sales, SARMAC Associates, LLC, and LaCorte Farm & Lawn Equipment, Inc.

Employees are eligible to receive a discretionary profit sharing contribution after one year of service, as defined, and may enter the Plan on the first day of each calendar quarter. Participants not actively employed at the end of the plan year will not share in the discretionary contribution, regardless of service, unless in the event of death, termination after having incurred a disability or the attainment of normal retirement age (as defined).

Contributions: Each year, participants may elect to make pre-tax or Roth after-tax deferral contributions up to the maximum allowable contribution amount under the Internal Revenue Code (IRC). Under the Qualified Automatic Contribution Arrangement (QACA) provision, a pre-tax deferral contribution of 6% of eligible compensation (as defined) will automatically be elected, unless otherwise directed by the employee. Participants may make a separate deferral election for bonuses received. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make the following contributions on behalf of participants:

A QACA Safe Harbor contribution in an amount equal to 100% of each participant's deferrals (including catch-up), up to 1% of eligible compensation, plus 50% of each participant's deferrals in excess of 1%, but not in excess of 6%, of eligible compensation. For 2024, the Company's QACA Safe Harbor contribution totaled \$326,944.

A discretionary profit sharing contribution, as determined by the Company and allocated based on pre-determined allocation groups in the ratio that each qualifying participant's eligible compensation for the plan year bears to the total compensation for all qualifying participants in the applicable allocation group for the plan year. No discretionary profit sharing contribution was made for 2024.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Contributions - continued:

The Company may also make Qualified Nonelective Contributions (QNECs) and Qualified Matching Contributions (QMACs), as defined in the Plan. No QNECs were made for 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and any Company contributions into various registered investment companies (mutual funds) and a common/collective trust fund offered by the Plan. For those participants who do not make an investment selection, their contributions and the related Company contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions, QNECs and QMACs plus earnings thereon. QACA Safe Harbor contributions are 100 percent vested after two years of credited service. Vesting in the Company's discretionary matching (contributed in previous years) and profit sharing contribution portion of participants' accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Regardless of the vesting schedule, participants will become fully vested upon death or total and permanent disability.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at prime + 2% and can only exceed a repayment period of five years for the purchase of a principal residence. Only one note may be outstanding at a time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums or partial payments and are payable upon termination of employment, death, disability or attainment of normal retirement. The Plan shall make automatic distributions of vested account balances that are less than \$7,000 (in accordance with the SECURE 2.0 Act). Distributions from a participant's rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59 ½ are also permitted, subject to provisions defined in the plan document.

Forfeitures: Forfeitures of the Company contribution portion of participants' accounts (due to participants' termination prior to full vesting) are used to reduce the Company contributions or to pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,062 and \$7,672, respectively. During 2024, forfeitures of \$5,742 were used to pay administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Unit Values: Individual participant accounts for the common/collective trust fund are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units valued daily. The fund earns dividends which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are made daily at the NAV and are considered as made immediately after daily valuation, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document. However, the Plan allows for a cure period after separation of service of up to 60 days.

Contributions: Contributions from plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. Fees for investment advisory services, administrative services, the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Putnam Stable Value Fund: The common/collective trust fund primarily invests directly or indirectly in fully benefit-responsive investment contracts. The fund is valued daily at the NAV as provided by the trustee and is based on the fair value of the underlying contracts except for certain investment contracts that generally are valued at contract value. The NAV is used as a practical expedient to estimate fair value. Unit values are computed by dividing total net assets by the total number of participants' units outstanding on the valuation date. The fund declares and pays dividends which are reinvested in the fund and included in the determination of unit value. The fund maintains a stable \$1 unit price.

NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC (qualified institution), an authorized representative for Ascensus Trust Company (the trustee of the Plan).

NOTE 5 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed Ascensus LLC, by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Plan investments consist of registered investment companies managed by The Vanguard Group, Inc. (Vanguard). Vanguard is the recordkeeper of the Plan, and therefore, these transactions qualify as party in interest transactions.

Vanguard provides certain administrative services to the Plan pursuant to the Retirement Plan Recordkeeping Service Agreement between the Company and Vanguard (Agreement). The Agreement provides for an annual service fee, which includes a base fee plus a per participant fee and is billed and payable quarterly. Certain investment products provide revenue credits which are provided in an Administrative Fee Credit Account (AFCA) of the Plan and can be used to offset the annual service fee and advisory fees. Any remaining annual service fee balance after offsets is billed to participants. The AFCA balance in the Plan totaled \$92 and \$134 at December 31, 2024 and 2023, respectively. Participants also pay to Vanguard transactional fees relative to notes receivable and distributions. Fees paid by the Plan to Vanguard amounted to \$14,992 for 2024, before AFCA offsets and forfeitures.

Fees for trustee services provided by Ascensus Trust Company are included in the annual service fee paid to Vanguard. As additional compensation for its services, Ascensus Trust Company retains any interest earned (float) on contributions and distributions.

Wealth Enhancement Advisory Services LLC (WEAS) provides certain investment management services pursuant to the Non-Discretionary Pension Consulting and Investment Advisory Agreement (Agreement) between WEAS and the Company. The Agreement provides for an annual fee based on a percentage of the market value of plan assets as reported by the trustee and is billed and payable quarterly. The annual fee paid by the Plan to the registered broker of WEAS, LPL Financial, amounted to \$21,269 for 2024.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 72% and 64%, respectively, of net assets available for benefits is invested in the T. Rowe Price Retirement Funds; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.
