Independent Auditor's Report

To the Plan Administrator and Plan Trustee
Somacis, Inc. 401(k) Salary Reduction Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Somacis, Inc. 401(k) Salary Reduction Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of Plan:

The following description of the Somacis, Inc. (formerly: Hallmark Circuits, Inc.) 401(k) Salary Reduction Plan and Trust (the “Plan”) provides only general information. For additional information concerning the Plan’s provisions, participants should refer to the Plan Agreement and Summary Plan Description.

General

The Plan is a defined contribution plan covering the employees of Somacis, Inc. (the “Company” and “Employer”) who have completed one month of service and attained the age of 18. An employee will become a participant in the Plan on the first day of the quarter immediately following the date of employee satisfies the eligibility conditions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan Administrator has appointed Lincoln National Life Insurance Company as the Custodian of the Plan assets, with authority over management and investment of Plan assets and Plan accounting and reporting.

The Plan was amended January 1, 2023 to allow participants to enter the plan immediately after completing 3 months of service and attaining the age of 18. Under the Plan, as amended, Employer matching contributions will be determined on the basis of contributions made during each payroll period.

Contributions

Participants may make elective deferral contributions of at least 1% of eligible annual compensation up to the maximum dollar amount established by the Internal Revenue Code (IRC) of pretax annual compensation, as defined in the Plan. The Plan permits Roth elective deferrals. The Plan also provides for a matching contribution at the discretion of the Company. Effective January 1, 2023, participants eligible for Employer matching contributions are entitled to receive \$.50 for every dollar, up to 6% of wages, each biweekly pay period.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, allocation of Participant’s share of the Company’s contributions, the participants’ share of the Plan’s earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant’s account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their contributions and Company contributions into various investments, which are more fully described in the Plan’s literature. The Plan currently offers a variety of pooled separate accounts, and a guaranteed interest contract. Participants may change their investment options any time throughout the year.

Forfeitures

Forfeitures are used to reduce Company contributions and are allocated in the year that the forfeiture occurs. There were no forfeitures used to reduce Company contributions for the years ended December 31, 2024 and 2023. Forfeited balances totaled \$6,379 and \$6,275 at December 31, 2024 and 2023, respectively.

Vesting

Participants are immediately vested in their voluntary contributions and for all Employer contributions made after January 1, 2001, plus actual earnings thereon.

Notes Receivable From Participants

Participants may borrow from their accounts in amounts not to exceed the lesser of \$50,000 or 50% of the participant's vested account balance, with a minimum of \$1,000. The loans are secured by up to one-half of the vested account balance in the participant's account. The loans bear interest at rates equal to the prime rate plus 2%, established when the loan is granted. Interest rates ranged from 4.25% to 9.50% on the participants' loan balances at the years ended December 31, 2024 and 2023. Loans are repaid through payroll withholding, generally over five years; however, the Plan provides for longer maturities if the loan is used to acquire the participant's principal residence.

Payment of Benefits

Upon termination of services due to death, disability or retirement, a participant or his/her beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his/her account in either a lump-sum amount or through various annuities, based on the participant's election. Participants with account balances of \$5,000 or less will receive a lump-sum distribution upon termination of service with the Company. Participants with account balances of greater than \$1,000 but less than \$5,000, a direct rollover will be made to an individual retirement account, unless otherwise directed by the participant.

Participants may receive withdrawals for reasons of financial hardship. These withdrawals are included with benefits paid, and cannot exceed the participant's voluntary contributions and vested Employer contributions plus earnings.

Note 2 - Significant Accounting Policies:

Accounting Method

The financial statements of the Plan have been prepared on the accrual basis of accounting, which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Employee and Employer contributions were recognized in the period that contributions are due.

Guaranteed interest contracts held by a defined contribution plan are reported at contract value, which is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Fair Value Measurements

Fair value accounting standards define fair value, establish a framework for measuring fair value, outline a fair value hierarchy based on inputs used to measure fair value, and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy), and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

- Level 1 inputs are quoted prices in active markets for identical investments that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the investment, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the investment.

The Plan's statements of net assets available for benefits include the following financial instruments that are required to be measured at fair value on a recurring basis:

- Pooled separate accounts ("PSA") represent units held in pooled separate accounts that are valued using the net asset value ("NAV") of the fund. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a PSA is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund.

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable From Participants

Loans to participants are reported at their unpaid principal balances, plus any accrued and unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of the Plan, including legal, audit, administrative, and Custodian expenses, are generally paid by the Company, with the exception of certain administrative expenses which are paid for by the Plan and charged to participants' accounts. The Plan incurred \$24,637 of administrative expenses for the year ended December 31, 2024. Participants with loan balances pay an origination fee for loan administration from their respective Plan accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 4, 2025, the date the financial statements were available to be issued, and concluded that there were no events or transactions that needed to be disclosed.

Note 3 - Fair Value Measurements:

The Plan has no assets measured at fair value that are required to be reported by classification within the fair value hierarchy at December 31, 2024 and 2023.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 5 - Guaranteed Interest Contract:

The Plan has a fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company (“Lincoln”) totaling \$672,261 and \$690,530 at December 31, 2024 and 2023, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments, and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal, and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 2.77% and 2.54% in 2024 and 2023, respectively. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes, or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; (4) a material amendment to the agreement without the consent of the issuer.

Note 6 - Party-In-Interest Transaction:

Certain Plan investments are shares of pooled separate accounts managed by Lincoln National Life Insurance Company, the Custodian, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. The Plan paid contract administrator fees, loan fees, and loan maintenance fees totaling \$24,637 for the year ended December 31, 2024. In addition, the Plan may pay fees for investment management services which are included in net appreciation in fair values of investments.

Note 7 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Tax Status:

The prototype Plan sponsor, Lincoln Retirement Services Company, LLC, has obtained an opinion letter dated March 31, 2014, in which the Internal Revenue Service stated that the Plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is currently being operated in accordance with the IRC.

The Plan believes that it has appropriate support for any tax position taken, and, as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2020.
