Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Blind & Vision Rehabilitation Services of Pittsburgh Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

1. Description of Plan

Blind & Vision Rehabilitation Services of Pittsburgh (Company), formerly Pittsburgh Vision Services, was established July 1, 1997 as a result of the consolidation of the Greater Pittsburgh Guild for the Blind (Guild) and the Pittsburgh Blind Association (PBA). As a result of the consolidation, the Company assumed responsibility for the Guild's pension Plan which originated January 1, 1986 and was amended and restated as Pittsburgh Vision Services Retirement Plan July 1, 1997. Effective January 23, 2000, the Retirement Plan was materially modified to include the employees of the former PBA, whom had previously been excluded. Effective July 1, 2005, the Retirement Plan name was changed from the Pittsburgh Vision Services Retirement Plan to Blind & Vision Rehabilitation Services of Pittsburgh Retirement Plan (Plan). Effective July 1, 2015, the Plan was amended to include all employees of Somerset County Blind Association and all periods of service were counted toward the years of vesting requirement.

The Plan was established for the purpose of providing retirement benefits to the employees of the Company. The accompanying financial statements include only the activity and financial position of the Plan and are not intended to reflect the Company as a whole.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution Plan. Highly compensated employees are not permitted to participate in the Plan. Employees of PBA Products & Services, Inc. and vocational rehabilitation department client participants of the Company are permitted to make salary deferrals to the Plan; however, they are excluded from receiving Employer Contributions. Employees of the Company become eligible to make salary deferrals to the Plan beginning on their date of hire. Effective September 1, 2024, employees must also be age 21 or older in order to be eligible to participate in the Plan. For employer-base contributions from the Company, participant eligibility requires a minimum of one year of service and 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute up to the maximum percentage allowable, not to exceed the 401(k), 402(g), 404, and 415 limits as regulated by the Internal Revenue Code. Roth contributions are permitted by the Plan. Participants may also contribute amounts representing distributions or rollovers, from other qualified defined benefit or defined contribution plans. Effective January 1, 2020, the Plan was amended to provide for auto-enrollment for all eligible employees at a rate of 2% of eligible compensation.

Effective March 1, 2020, the Plan was amended to change the mandatory employer base contribution to a discretionary employer base contribution. In accordance with this amendment, as of April 1, 2020, the Company elected to temporarily discontinue the discretionary employer base contribution. Effective December 1, 2021, the Company reinstated the discretionary employer base contribution at a rate of 2% of eligible compensation. Effective July 1, 2022 through December 31, 2024, the Company increased the discretionary employer base contribution to a rate of 4% of eligible compensation.

All contributions, including the employer contributions, may be directed daily at the discretion of each participant into the various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with (a) the participant's contributions, (b) participant's rollovers or transfers, (c) the Company's base contribution, if eligible, and (d) any earnings or losses thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, as well as direct charges for distributions or participant loans. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective salary deferrals, rollover contributions and transfers, and actual earnings thereon. Participants are also completely vested in their accounts upon normal retirement age of 65, early retirement age of 55, or due to death or

permanent disability. Vesting in the Company's base contribution is based on the years of service as follows:

Forfeitures

Forfeitures represent participant account balances that are not vested upon the termination of an employee. Forfeitures can be used to reduce future employer contributions. The balance of the forfeiture account at December 31, 2024 and 2023 was \$7,257 and \$5,622, respectively. During 2024 and 2023, \$1,504 and \$5,527, respectively were used to reduce employer contributions.

Notes Receivable from Participants

Participants may borrow at any given time from their account under the terms of and for purposes specified in the Plan document. There is no limit on the number of loans that a participant may have outstanding at one time. The participant's outstanding loan balance must not exceed \$50,000 or 50 percent of their vested account balance, whichever is less. Participant loans are to be repaid over a period not to exceed five years, unless used to acquire a principal residence. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest, ranging from 5.00% and 9.50% for 2024 and from 4.25% and 6.50% for 2023. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a non-refund life annuity, full cash refund annuity, period certain and continuous

annuity, joint and survivor life annuity, joint and survivor with period certain and continuous annuity, or a lump sum option. Participants with accumulated balances of less than \$1,000 at date of service termination will receive a lump-sum benefit. Distributions paid directly to a participant are subject to income tax withholdings. The Plan does permit hardship distributions as outlined in the Plan document.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the

fair value measurements. For all investments, Mutual of America Life Insurance Company (MOA) calculates a daily unit value, based on either the daily credited interest rate (general account) or the underlying market value of investments (separate accounts). The value of a participant's fund balance is equal to the daily unit value multiplied by the number of units accumulated.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's investment-related expenses, in addition to gains and losses on investments bought and sold as well as held during the year.

Investment Options

Upon enrollment in the Plan, a participant may direct all employee and employer contributions into any of the choices provided under the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of December 31, 2024 and 2023.

Plan Expenses

The Plan assesses, against an individual participant's account, certain expenses which are incurred by, or are attributable to, a particular participant based on use of a particular Plan feature. The remaining fees and expenses are paid by the Company. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

3. Investment Contract with Insurance Company

The Plan has a deposit contract with MOA. Under the terms of the contract, a portion of the Plan assets are held in MOA's general account, which is made up mainly of U.S. Government agency and high-quality nonindustrial corporate bonds and notes. The general account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by MOA. MOA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract, which is fully benefit-responsive, is included in the financial statements at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$41,609 and \$51,741, respectively.

The effective annual yield and the crediting interest rate for the years ended December 31, 2024 and 2023 was 3.00% for accounts activated before May 1, 2008. For contracts activated after May 1, 2008, the effective annual yield and the crediting interest rate for the years ended December 31, 2024 and 2023 was 2.85% and 1.60%, respectively. Interest is compounded daily and is periodically adjusted by MOA.

MOA is responsible for maintaining the balances due to each of the eligible participants in the Plan. The net assets available for benefits include assets available to current eligible employees as well as terminated employees who have not yet been paid their benefit by the Plan. MOA is also responsible for the proper payouts of benefits to eligible terminated employees per the terms of the Plan documents.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or

partial Plan termination or merger with another Plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event that would limit the Plan's ability to transact at contract value with participants is probable.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Fair values for Level 1 investments are determined by reference to unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access. Fair values for Level 2 investments are determined by reference to quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 investments have significant unobservable inputs, as they trade infrequently or not at all.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan held no assets measured under the fair value hierarchy for the years ended December 31, 2024 and 2023.

Investments Measured Using the Net Asset Value per Share Practical Expedient

Investments at fair value consist of the Plan's interest in the pooled separate account and are valued at the net asset value of shares held by the Plan at year-end. The pooled separate account invests in mutual funds, including funds managed by Mutual of America Capital Management Corporation, a wholly owned subsidiary of MOA, and other funds managed by outside investment advisors. Investments held in the pooled separate account are stated at fair value and are not available to satisfy the liabilities of the general account. The pooled separate account is valued at net asset value per share as determined by investment managers under the so-called "practical expedient." The practical expedient allows net asset value per share to represent fair value for reporting purposes when the criteria for using this method are met. The pooled separate account consists of mutual funds actively traded that are easily redeemed at the request of participants without restrictions on sales and there are no unfunded commitments. The investment strategies of the underlying investment funds of the separate account include seeking capital appreciation, current income, and the preservation of shareholders' capital.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of the future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan, or to amend the Plan at any time and in any respect, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balance.

6. Tax Status

The Plan converted to a Mutual of America Prototype Plan via a Plan amendment effective September 12, 2012. The Prototype Plan obtained its latest determination letter on November 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designated, was in compliance with the applicable requirements of the Internal Revenue Code. The Prototype Plan has been amended since receiving the determination letter. The

Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Further, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

7. Information Certified by the Plan's Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, the custodian of the Plan.

8. Related-Party and Party-In-Interest Transactions

Certain Plan investments in the pooled separate account and investments in the general account are managed by MOA. MOA is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for investment management services incurred by the Plan are included in net appreciation of the investments, rather than a direct payment. The Company pays directly any other fees related to the Plan's operations. Administrative expenses paid by the Plan at December 31, 2024 and 2023 were \$2,568 and \$651, respectively.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
