Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Douglas County Public Health Services Group, Inc. 401(k) Retirement Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. Description of plan

The following description of the **Douglas County Public Health Services Group, Inc. 401(k) Retirement Plan** (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Douglas County Public Health Services Group, Inc. (the Company) who are age 21 or older and who have completed one year of service, which equals 1,000 service hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan also covers related employers and a maximum of five years of their service to the Douglas County Health Department. The Plan also includes a special participation date, granting immediate participation in the Plan to any participant over the age of 21, providing that they were an eligible employee on November 1, 2004. All eligible participants may qualify for the discretionary employer match once they have completed two years of service. All eligible participants may qualify for the discretionary employer profit-sharing contribution once they have completed two years of service, given that they are employed on the last day of the Plan year and have completed 1,000 hours.

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) was enacted and was effective beginning on January 1, 2020. The SECURE Act provisions included, among other things, an increase in the age limit for required minimum distributions from age 70 ½ to 72. The Plan is in the process of operationally being amended to implement certain changes related to the SECURE Act. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

Effective March 1, 2021, the Plan was restated to change the Plan year end to December 31.

Contributions

Each year, participants may contribute up to 100 percent of their annual compensation in the form of salary reductions, either pre-tax or post-tax Roth deferrals, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employee contributions are subject to certain limitations as limited by IRS regulations.

The Company is required to make a safe-harbor non-elective contribution no less than 3 percent of plan compensation for any eligible employee. The Company made a safe-harbor contribution totaling \$263,611 and \$217,534 for the years ended December 31, 2024 and 2023, respectively.

The Plan allows for the Company to make a discretionary match contribution equal to a percentage of the eligible participant's compensation with a maximum amount of 4 percent. The Plan also allows for the Company to make a discretionary profit-sharing contribution equal to a fixed amount allocated out to eligible participants. The Company elected to not make any discretionary match or profit-sharing contribution for the years ended December 31, 2024 and 2023 Plan years, respectively.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Companies' contribution and (b) earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their individual contributions, plus actual earnings thereon. Vesting in the safe-harbor non-elective contribution, discretionary employer match, and discretionary profit-sharing contribution portion of their accounts, plus actual earnings thereon, is immediate as well.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to 50 percent of their vested account, or \$50,000 minus any outstanding loan balances, whichever is lesser. Loan terms range from 1 – 5 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate from loan prevailing rates, Prime plus 2 percent per year. Interest rates range from 5.25 to 10.50 percent during the years ended December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

Payments of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his/her account. In-service distributions are also allowed if the participant has reached age 59 ½.

If a participant ceases to be an employee of the Company for other reasons and his/her account balance is less than \$1,000, then the entire vested account balance will be paid out in a lump-sum. If the participant's account balance is more than \$1,000 but less than \$5,000, excluding amounts attributable to rollover contributions, the entire vested account balance may be payable to the participant or his/her beneficiaries in a single lump-sum payment or rolled over into an individual retirement account or other qualified plan. Participant balances in excess of \$5,000 may remain in the Plan until the later of, your normal retirement age or age 62, with the vested account balance then being paid out in a single lump-sum payment.

2. Summary of significant accounting policies

This summary of significant accounting policies is presented to assist in understanding the Plan Administrator's financial statements. The financial statements and notes are representations of the Plan Administrator's management, which is responsible for their integrity and objectivity. In preparing financial statements, the Plan Administrator makes estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Basis of accounting

The Plan's financial statements are presented on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from plan participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of the years ended December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

3. Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Observable inputs other than Level 1 process, such as quoted prices for similar assets or liabilities; quoted prices for identical or similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at the years ended December 31, 2024 and 2023.

Pooled separate accounts: Separate account assets comprise of actively traded mutual funds and other investments whose publicly quoted pricing input is the net asset value as of the measurement date. These investments are ultimately valued similarly to mutual funds and can be redeemed daily.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of the years ended December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Tax status

The Plan was designed under a volume submitter profit-sharing plan accepted by the Internal Revenue Service by a letter dated June 30, 2020, in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and that the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

7. Guaranteed investment contracts with insurance companies

The Plan invests in a benefit-responsive Guaranteed Interest Investment Contract with Lincoln National Life Insurance Company. Lincoln National Life Insurance Company maintains the contributions in separate guaranteed interest accounts based on the maturity date and provides a guaranteed interest rate. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Guaranteed Interest Investment Contract promises contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible market value adjustment when funds are withdrawn prior to their maturity. The crediting interest rate is guaranteed for the lifetime of the contract at 3 percent.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln National Life Insurance Company represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

8. Related-party transactions and party-in-interest transactions

Certain Plan investments are managed by Lincoln National Life Insurance Company. Lincoln National Life Insurance Company is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan incurs expenses related to general administration and record-keeping. The Plan Sponsor pays a portion of these expenses and certain accounting and auditing fees relating to the Plan.

9. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

10. Subsequent events

Effective January 1, 2025, the Plan was amended and restated, changing the service requirement for eligibility to a 90-day period of service for all types of contributions allowed by the Plan. Eligible employees who satisfy the eligibility requirements may also enter on the first day of the month following the requirements being met.

Effective January 1, 2025, the Plan was amended to allow for hardship distributions due to financial hardships (as defined by the IRS).
