INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees and Plan Administrator of
Athens of Memphis 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Athens of Memphis 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of November 6, 2024 (Date of Transfer) and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 through November 6, 2024 (Date of Transfer), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Athens of Memphis 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFP 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 6, 2024 (Date of Transfer) and December 31, 2023 and for the period January 1, 2024 through November 6, 2024 (Date of Transfer) stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Athens of Memphis 401(k) Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN

The following description of the Athens of Memphis 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Athens Distributing Company of Memphis (the "Company", "Sponsor", "Employer", or "Plan Administrator"). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for the oversight of the Plan. The Plan Trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held by Reliance Trust Company ("Reliance") and are managed by Transamerica Retirement Solutions, LLC ("Transamerica"), collectively the trustee and the qualified institution for the Plan, which invests contributions and Plan earnings and makes investment transactions as directed by the Plan Trustees and provides certain recordkeeping services. FuturePlan by Ascensus, LLC acts as the third-party administrator for the Plan, which performs certain plan administration, annual ERISA compliance testing and other recordkeeping services. On January 1, 2024, the Plan transitioned the third-party administrator services to July Services. July Services performs certain plan administration, annual ERISA compliance testing and other recordkeeping services.

Transfer from Plan

Effective October 4, 2024, the Sponsor formally adopted the Athens Distributing Retirement Plan and the Plan's net assets were transferred to the Athens Distributing Retirement Plan on November 6, 2024. As a result, the Plan was effectively terminated.

Eligibility

Employees may become a participant of the Plan when they have reached age twenty-one or older and have completed one year of service, with one year of service being credited for 1,000 hours of service during a Plan year. Collective bargaining employees and non-resident aliens are not eligible for Plan participation. An eligible employee may enter the Plan on the first day of the following Plan quarter after all eligibility requirements have been met. Participants must be employed on the last day of the Plan year or have at least 501 hours of service during the Plan year and have current year employee deferrals to be eligible for the flexible discretionary match and profit sharing contributions.

Athens of Memphis 401(k) Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN (Continued)

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company provides safe-harbor matching contributions of 100% of the first 1% and 50% of the next 5% of base compensation that a participant contributes to the Plan. Additional profit sharing contributions and flexible discretionary matching contributions may be contributed at the option of the Company's board of directors and are invested in a portfolio of investments as directed by the Company. During the period January 1, 2024 through November 6, 2024 (Date of Transfer), the Company did not make a profit sharing contribution or flexible discretionary matching contribution. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's safe-harbor matching contributions, as well as allocations of the Company's profit sharing contributions, flexible discretionary match contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor matching contributions portion of their account is based on years of continuous service. A participant is 100% vested after two years of service.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Vesting (continued)

Vesting in the Company's profit-sharing contributions and flexible discretionary match contributions portions of their account is based on years of continuous service in accordance with the following schedule:

Years of Credited Service	Percentage Vested
Less than two years	0%
Two years	20%
Three years	40%
Four years	60%
Five years	80%
Six years	100%

A participant may become fully vested, regardless of the above vesting table, in their account if the participant dies, becomes totally disabled or attains normal or early retirement age while employed by the employer. Participants became fully vested upon the transfer from the Plan to Athens Distributing Retirement Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balance, or \$50,000 reduced by the participant's highest outstanding loan amount during the prior twelve months. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate in effect at the origination of the note. Principal and interest is paid ratably through monthly payroll deductions.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeitures

At November 6, 2024 (Date of Transfer) and December 31, 2023, forfeited nonvested accounts were \$0 and \$5,439, respectively. These accounts will be used to reduce future employer contributions. During the period from January 1, 2024 through November 6, 2024 (Date of Transfer), no forfeitures were used to reduce employer contributions and the forfeited nonvested accounts were transferred to the Athens Distributing Retirement Plan.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Distributions to participants are recorded when paid.

Athens of Memphis 401(k) Plan Notes to Financial Statements

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. The Plan holds assets in an expense balance account ("EBA") which receives deposits as a result of a revenue sharing agreement with Transamerica. During the period January 1, 2024 through November 6, 2024 (Date of Transfer), deposits totaled \$40,304, which are netted in administrative expenses on the statement of changes in net assets available for benefits. Funds in the account are used to pay qualified plan expenses. During the period January 1, 2024 through November 6, 2024 (Date of Transfer), revenue sharing credits totaling \$47,940 were used to pay plan expenses. The EBA totaled \$0 and \$12,583 as of November 6, 2024 (Date of Transfer) and December 31, 2023, respectively. See Note 6 for further disclosure.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, September 29, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at November 6, 2024 (Date of Transfer) and December 31, 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at November 6, 2024 (Date of Transfer) and December 31, 2023.

- c) Total investment income and interest income from notes receivable from participants, included in the statement of changes in net assets available for benefits for the period January 1, 2024 through November 6, 2024 (Date of Transfer).
- d) All amounts included in Note 4, *Fair Value Measurements*.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 6, 2024 (Date of Transfer) and December 31, 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: FAIR VALUE MEASUREMENTS (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

There were no Plan assets as of November 6, 2024 (Date of Transfer). The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023:

Note 5: TAX STATUS

The Plan uses a pre-approved plan document sponsored by FuturePlan by Ascensus, LLC, which received an opinion letter from the IRS dated June 30, 2020, that the pre-approved Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more than likely would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Transamerica. Transamerica is the recordkeeper and provides certain administrative services for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (Continued)

Transamerica receives revenue from mutual fund service providers for services Transamerica provides to those funds. This revenue is used to offset certain amounts owed to Transamerica for the administrative services Transamerica provides to the Plan (see Note 2). If the revenue received by Transamerica from such mutual fund service providers exceeds the amount owed for administrative services, Transamerica remits the excess to the Plan's account. During the period January 1, 2024 through November 6, 2024 (Date of Transfer), there were no excess amounts. The Plan or Company may make a payment to Transamerica for administrative expenses not covered by the revenue sharing.

Note 7: PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. See Note 1.
