Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the **Paul Mueller Company Profit Sharing and Retirement Savings Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedules Required by ERISA

The supplemental schedule of assets held (at the end of the year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. Description of plan

The following description of the **Paul Mueller Company Profit Sharing and Retirement Savings Plan** (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Paul Mueller Company (the Company) who have completed three months of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Plan is an adopted prototype plan established January 1, 1989. The Plan was restated on November 1, 2012. The Plan was amended as of January 1, 2023, to change the service requirement for eligibility into the Plan. The service requirement prior to January 1, 2023, was 3 months of service for the employee deferral and 1 year of service for the employer match. Effective January 1, 2023, the service requirement for eligibility is the completion of 30 days of service with the Company for both the employee deferral and employer match.

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) was enacted and was effective beginning on January 1, 2020. The SECURE Act provisions included, among other things, an increase in the age limit for required minimum distributions from age 70 ½ to 72. The Plan is in the process of operationally being amended to implement certain changes related to the SECURE Act. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security (CARES) Act was enacted. The CARES Act provides immediate and temporary relief for eligible retirement plans and their participants who were adversely impacted by the coronavirus. Effective March 27, 2020, the Plan made amendments related to the provisions of the CARES Act to allow these participants to take coronavirus-related distributions up to \$100,000, increase participant loan amounts up to \$100,000 or 100 percent of eligible vested balances between March 27, 2020 to September 22, 2020, defer loan repayments during the period of March 27, 2020 to December 31, 2020, and waive required minimum distributions for the calendar year 2020.

Contributions

Employee contributions

Employee contributions are subject to certain limitations as limited by IRS regulations. In addition, individuals who are at least age 50 at the end of the Plan year are permitted to make "catch-up" contributions also limited by IRS regulations. In addition, the Plan allows for in-plan ROTH conversion contributions.

The Plan has elected to operate as an eligible automatic contribution arrangement. Prior to May 1, 2023, the Plan's automatic deferral percentage for newly hired and newly eligible employees was 6 percent. The Plan has elected for all eligible employees, except those represented by the International Association of Sheet Metal Workers' Local Union 208, to automatically increase the deferral percentage by 1 percent at the beginning of each plan year, unless the employee elects otherwise. Prior to May 1, 2023, the auto-escalation feature within the Plan was a 1 percent increase each year up to a maximum elective deferral percentage of 10 percent.

Effective May 1, 2023, the Plan was amended to increase the automatic enrollment contribution rate for new hires and newly eligible employees, including those represented by the International Association of Sheet Metal Workers' Local Union 208, from 6 percent to 8 percent of compensation unless the employee elects otherwise. The Plan was also amended to increase the auto-escalation maximum elective deferral percentage from 10 percent to 15 percent.

Effective July 1, 2024, the Plan was amended to permit employees to make a separate election to defer 100 percent of any bonus or other incentive compensation.

Employer contributions

Prior to January 1, 2023, the service requirement for employer matching contributions was one year of service. An eligibility period is the twelve-month period beginning on the date of hire with 1,000 hours worked equal to one service year. Effective January 1, 2023, the Plan was amended to change the service requirement for the employer matching contributions to 30 days of service. The Plan annualizes the safe harbor matching contribution and the fixed matching contribution for employees who are represented by Local Union 208 of the Sheet Metal, Air, Rail and Transportation Workers International Association.

Safe harbor matching contributions - Safe harbor matching contributions for employees who are not represented by International Association of Sheet Metal Workers' Local Union No. 208, will be made each payroll period equal to 100 percent of the first 1 percent of the salary the participant elects to contribute as either pre-tax or Roth salary deferral contributions, plus 50 percent of the next 5 percent of the salary the participant elects to contribute as either pre-tax or Roth salary deferral contributions, up to a maximum contribution of 3.5 percent. Effective January 1, 2023, the employer safe harbor matching contributions for employees who are not represented by the International Association of Sheet Metal Workers' Local Union No. 208 was removed from the Plan.

Employer percentage of deferral match contributions - Effective January 1, 2023, the employer safe harbor matching contribution was replaced with an employer percentage of deferral match contribution. Under the percentage of deferral match contribution, the employer may contribute to each eligible participant an amount equal to 50 percent of the first 8 percent of compensation that the participant elects to contribute as either pre-tax or Roth deferral contributions, up to a maximum employer match contribution of 4 percent.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) earnings. Each participant's account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeited non-vested accounts are first used to reduce the employer contributions to the Plan. Forfeitures totaling \$40,521 and \$18,129 were used to reduce employer contributions during 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$59,023 and \$22,079, respectively.

Vesting

Participants are immediately vested in their individual contributions, plus actual earnings thereon. Vesting in the Company's safe harbor contribution and fixed matching contribution portion of their accounts, plus actual earnings thereon, is based upon years of continuous service. A participant is 100 percent vested after two full years of credited service based upon their employment date for the Company's safe harbor contributions. For the Company's fixed matching contributions, vesting begins at 20 percent after two full years of credited service and reaches 100 percent after six or more years.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to 50 percent of their vested account or \$25,000, if less. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined quarterly by the Plan Administrator. Interest rates are prime plus 2 percent at a rate between 5.25 percent and 10.50 percent for 2024. Principal and interest is paid ratably through weekly payroll deductions.

Payments of benefits

If a participant ceases to be an employee of the Company and if the vested account balance is over \$1,000 but not more than \$5,000, and the participant has not attained the later of age 62 or the normal retirement age under the Plan, and a timely distribution or direct rollover election has not been made, the entire vested account balance, including any prior rollover contributions, will automatically be rolled over to a traditional IRA serviced by Diversified. Effective January 1, 2015, the Plan was amended to remove this rollover requirement. If the vested account balance is \$1,000 or less, and a timely distribution or direct rollover election has not been made, the vested account balance will be paid directly to the participant by check as a mandatory distribution.

If a participant ceases to be an employee of the Company and the vested balance is greater than \$5,000, benefits can be distributed to the participant as follows: lump-sum disbursement, installment payments, and partial payment with a minimum of \$1,000. Other optional forms of distribution, including death benefit lump-sum payments, are also available if a qualified election is filed by the participant and/or the beneficiary.

Participants may request to make a withdrawal of their contributions to the Plan due to financial hardships (as defined by the IRS). Withdrawal of all or part of an employee's vested accrued benefits may be allowed at the Plan Administrator's discretion. Additionally, the Plan was amended during 2004 to allow employees to withdraw all or a portion of their vested account balance when they reach age 59 1/2.

2. Summary of significant accounting policies

This summary of significant accounting policies is presented to assist in understanding the Plan Administrator's financial statements. The financial statements and notes are representations of the Plan Administrator's management, which is responsible for their integrity and objectivity. In preparing financial statements, the Plan Administrator makes estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Basis of accounting

The Plan's financial statements are presented on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Other receivables are those items related to a sale of an underlying investment in the fund that is not settled, or other miscellaneous adjustments made to the fund not settled until after the reporting period.

Notes receivable from participant

Notes receivable from plan participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for

credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Subsequent events

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

3. Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Observable inputs other than Level 1 process, such as quoted prices for similar assets or liabilities; quoted prices for identical or similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units as provided by the trustee based upon the fair value of the underlying investments held by the fund less its liabilities. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. NAV is a readily determinable fair value and is the basis for current transactions.

Other investments: Self-directed account that includes various stocks, mutual funds and money market accounts. The underlying investments are valued at the daily closing price as reported by the fund (see Note 8).

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Summary of certified information

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from State Street Bank and Trust Company, the trustee of the Plan, and Transamerica Financial Life Insurance Company, the custodian, for the years ended December 31, 2024 and 2023, that all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net changes in fair value of investments and interest income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Plan's trustee and custodian.

5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

6. Tax status

The Plan was designed under a non-standardized pre-approved profit-sharing plan accepted by the Internal Revenue Service by a letter dated June 30, 2020, in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

7. Guaranteed investment contract with insurance companies

The Plan invests in a fully benefit-responsive Guaranteed Interest Investment Contract with Transamerica Financial Life Insurance Company (Transamerica). Transamerica maintains the contributions in separate guaranteed interest accounts based on the maturity date and provides a guaranteed interest rate. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The Guaranteed Interest Investment Contract promises contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible market value adjustment when funds are withdrawn prior to their maturity. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise; therefore, the contract value is equal to fair value with no market adjustments needed. The fair value of the investment contract at December 31, 2024 and 2023 was \$76,845 and \$55,662, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; and (4) a material amendment to the agreement without the consent of the issuer.

8. Investments – other

The Plan invests in a supplemental investment fund through Charles Schwab. This is a self-directed brokerage account that allows participants to direct the investment of their account in investment options other than those offered under the Plan. The underlying investments that the participant can choose from include actively traded stocks, mutual funds, and money market accounts. The fair value of this investment fund is determined based upon the underlying securities held at year end.

9. Related-party transactions and party-in-interest transactions

Certain Plan investments are managed by State Street Bank and Trust Company and Transamerica Financial Life Insurance Company. State Street Bank and Trust Company is the trustee for the Plan and Transamerica Financial Life Insurance Company is the recordkeeper for the Plan. Therefore, their transactions qualify as party-in-interest transactions.

10. Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
