Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the PLA 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Notes to Financial Statements**December 31, 2024 and 2023****1. Summary of Significant Plan Provisions**

The following description of the PLA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Innovative Pallet Management, LLC, Pal-Serv of Dallas, LLC, Pal-Serv of Oklahoma City, LLC, Pal-Serv of Little Rock, LLC, Pal-Serv of Charlotte, LLC, Pallet Logistics of America, LLC, Propak Logistics, LLC, Propak Transport, LLC, TaylorMade Operating, LLC, Valley Pallet, Inc., Valley Pallet Trucking, Inc., Willamette Valley Lumber LLC, Yancey Pallet, Inc., and Yancey, LLC (the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective January 10, 2025, the Propak Logistics, LLC 401(k) Retirement Plan was merged into the Plan.

- b. **Eligibility** – Employees, other than leased employees, who have been employed for at least 90 days, are eligible to participate in the Plan. Entry dates are the first day of each month.
- c. **Contributions** – Participants may contribute to the Plan through payroll deductions and rollover contributions. Participants may contribute up to the maximum allowed by the Internal Revenue Code (“IRC”). The Employer will make a safe harbor matching contribution equal to 100% of the participant’s elective deferrals that do not exceed 4% of eligible compensation.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting rights** – A participant is always fully vested in their own contributions and the Employer safe harbor matching contributions, plus earnings/losses thereon.
- f. **Investment options** – Upon enrollment in the Plan, a participant may direct their account to any of the investment options offered under the Plan. Participants may change their investment selections at any time.
- g. **Notes receivable from participants** – Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000; or 50% of the participant’s account balance. Note terms range from one to five years with extended terms for the purchase of a primary residence. The notes are secured by the participant’s account with an interest rate at Prime plus 1%, which is commensurate with local prevailing borrowing rates. Principal and interest are paid through payroll deductions.

Notes to Financial Statements**December 31, 2024 and 2023****1. Summary of Significant Plan Provisions (cont.)**

- h. **Payment of benefits** – Upon termination of service with the Employer, a participant may choose to receive their distribution in either a lump sum payment or periodic installments. If a terminated participant's account balance is equal to or less than \$7,000, the account balance will be automatically distributed. In addition, in-service withdrawals are available to participants meeting certain hardship requirements or who have attained age 59½.
- i. **Termination of the Plan** – Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuations and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as disclosed in Note 3. See Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Administrative expenses** – Fees related to loans and distributions are charged directly to the participant's account. Administrative expenses paid by the Plan are allocated to participants' accounts. Expenses that are paid by the Employer are excluded from these financial statements.

3. **Fully Benefit-Responsive Investment Contract**

The Plan had entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with Voya Retirement Insurance and Annuity Company (“Voya”). This contract was terminated effective January 9, 2024. Voya maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of Voya or otherwise. The contract guaranteed a periodic minimum rate of interest declared monthly. The interest rate was guaranteed to be not less than zero.

4. **Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Voya, the custodian of the Plan from January 1, 2023 to January 9, 2024, and Principal Trust Company, the trustee of the Plan from January 10, 2024 to December 31, 2024, and was not subject to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Total investments as shown on the accompanying statement of net assets available for benefits of \$13,581,859 and \$7,556,582 as of December 31, 2024 and 2023, respectively.
- b. Dividends as shown on the accompanying statement of changes in net assets available for benefits of \$25,786 for the year ended December 31, 2024.
- c. Net change in value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$1,474,428 for the year ended December 31, 2024.
- d. All investment transactions that occurred during the year ended December 31, 2024.
- e. All information included in the supplemental schedule.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

5. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

5. Fair Value Measurements (cont.)

Pooled separate accounts: These investments are valued based on the net asset value (“NAV”) of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments, adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

Common collective trust funds: These investments are stated at fair value based on the NAV of units held by the Plan at year-end, as calculated by the issuer. The NAV is calculated based on the fair value of the underlying assets owned by the funds, minus its liabilities, divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated the Plan Document is designed in accordance with the applicable sections of the IRC. As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

7. Parties-in-Interest Transactions

Voya served as custodian and third-party administrator of the Plan through January 9, 2024. The Plan had a GIC with Voya and paid Voya for its services. Voya was by definition a party-in-interest. Principal Life Insurance Company (“PLIC”) serves as third-party administrator to the Plan. The Plan pays PLIC for its services. The Plan is invested in funds issued by PLIC and other entities affiliated with PLIC through common ownership. PLIC is by definition a party-in-interest. Creative Planning, LLC (“Creative Planning”) serves as investment advisors to the Plan. The Plan pays Creative Planning for its services. Creative Planning is by definition a party-in-interest. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

8. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through August 26, 2025, which is the financial statement issuance date.
