Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Smithco Construction 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1) Description of Plan

The following description of the Smithco Construction 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2015 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participation in the Plan is entirely voluntary. An eligible employee is any person employed by Smithco Construction, Inc (the “Company”) who is an employee at any of the following affiliates: Smithco Properties LLC and Smithco Ranch. The Plan is a 401(k) plan. Entry to the Plan is the first day of the calendar month coinciding with or following attainment of age twenty-one. Employees who have completed one year of service are eligible for matching and profit-sharing contributions.

Contributions

Participant Contributions – Each year, Participants may contribute a combination of pretax and Roth elective deferrals, up to 100% of annual compensation, as defined by the Plan. Salary deferral contributions are subject to both the Plan’s and the Internal Revenue Code limits. Excess contributions resulting from restrictions on salary deferrals are required to be returned to the participants. Participants who have attained age 50 before the end of the Plan year are able to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contribution to various investments options offered by the Plan.

Employer Profit Sharing Contributions – The Plan provides for discretionary profit-sharing contribution to the participants who have completed at least 1,000 hours of service and are employed on the last day of the Plan year. The profit-sharing contribution is allocated to each eligible participant, as defined by the Plan. For 2024, and 2023, the employer profit-sharing contribution was 3.83% and 4.49% of compensation, respectively. Employer Profit sharing contributions were \$400,000 for each of the years ended December 31, 2024 and 2023.

Employer Matching Contributions – The Plan provides for discretionary employer matching contribution to participants who have completed at least 1,000 hours of service and are employed on the last day of the Plan year. These contributions are paid by the extended due date of the sponsor’s federal income tax return. For 2024 and 2023, the discretionary employer matching contribution was 100% of the participants salary deferral up to 5% of compensation. Employer matching contributions were \$265,737 and \$233,816 for 2024 and 2023, respectively.

1) Description of Plan — continued

Employer Nonelective Contributions – The employer may make additional nonelective contributions to the Plan. These contributions are available to eligible participants who are employed on the last day of the Plan year. There were no employer nonelective contributions for 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is vested as follows:

<u>Years of Service</u>	<u>Percent Vested</u>
Less than 2 years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

At age 59 ½ active participants may receive an in-service withdrawal of all or a portion of their value account balance. Participants may request a distribution of their rollover contribution accounts at any time. Distribution in the event of financial hardship may also be available to participants with qualifying financial help.

Retirement Age

Normal retirement age under the Plan is the later 65 or the fifth anniversary of participation in the Plan.

Forfeited Accounts

Amounts that are forfeited due to a participant's termination of employment prior to vesting in company contributions made on the participant's behalf are used to reduce the required company contribution in subsequent periods. However, if the participant is reemployed and fulfills certain requirements, as defined in the Plan, the participant's account will be reinstated. In 2024 and 2023, forfeited nonvested accounts totaling \$35,126 and \$27,541, respectively, were used to reduce company contributions. Upon termination of the Plan, all remaining forfeitures are to be allocated to the participants' accounts. The balance in the forfeiture account as of December 31, 2024, and 2023 was \$76,237 and \$85,849, respectively.

2) **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts or assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Capital Bank and Trust Company (the "investment custodian") certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are not permissible under the Plan.

Payments of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include distribution fee charges to participants' accounts and administrative Plan fees. Investment related expenses are included in the net appreciation in fair value of investments.

Administrative Expenses

The Plan permits, but does not require, the Company to pay costs of Plan administration.

Date of Management Review

Subsequent events were evaluated through August 19, 2025, which is the date the financial statements were available to be issued.

5) Fair Value Measurement

The framework for measuring fair value provides a fair hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measure level within the fair value hierarchy is based on the lowest of any input that is significant to the value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

6) Party-In-Interest Transactions

Certain Plan investments were managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the custodian and record keeper for the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

7) Tax Status

The Plan document is a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax exempt.

7) Tax Status – continued

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan had any uncertain tax positions that require disclosure or adjustment in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8) **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9) **Plan Termination**

Although it has not expressed intent to do so, the Company, as the Plan's sponsor, has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
