## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the  
Guided by Good 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Guided by Good 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

### 1. Description of the Plan

The following description of the Guided by Good 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all salaried employees of Guided by Good, Inc. and Subsidiaries (collectively, the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan participates in the American Association of Advertising Agencies (AAAA) Retirement Fund for Member Agencies (the AAAA Retirement Fund). The AAAA Retirement Fund is organized as a 103-12 investment entity as defined by 29 CFR 2520.103-12 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The AAAA Retirement Fund for Member Agencies c/o AAAA Benefits, Inc. is the Plan's qualified institution.

Subsequent to year end, effective April 28, 2025 (Transfer Date), the Plan's interest in the AAAA Retirement Fund was transferred to Fidelity Management Trust Company (Fidelity). As of the Transfer Date, Fidelity Workplace Services is providing recordkeeping services for the Plan. The Plan's investment options with Fidelity are substantially similar to those offered for the Plan by AAAA, the previous recordkeeper.

#### Eligibility

Each salaried employee becomes eligible for participation as well as employer matching contributions upon attaining the age of 21 and after completing three months of service. The entry date is the first day of the quarter coinciding with or following the date the eligibility requirements are satisfied. An automatic enrollment feature enrolls employees who meet eligibility requirements and defers 3% of their pre-tax annual compensation, as defined by the Plan document, unless the employee elects otherwise. The Plan also has an automatic escalation feature which increases the automatic deferral by 1% of compensation on the first day of each Plan year up to 6% of compensation, unless the participant elects otherwise. In order to receive employer matching contributions, participants must be actively employed by the Company on the last day of the Plan year or must have terminated employment during the Plan year due to death, disability, or retirement.

#### Contributions

Participants may make pre-tax and/or Roth contributions of up to 100% of eligible compensation, as defined by the Plan document, not to exceed \$23,000 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up"

contributions, not to exceed \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Company matched 50% of the first 6% of each participant's pre-tax annual compensation contributed during the Plan year and totaled \$807,338 before the use of forfeitures. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, the Company's contribution and earnings and losses on the investments in their account and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions and earnings and losses thereon. Vesting in the Company's contributions is based on years of service. For participants who terminated prior to January 1, 2014, Company contributions vested 20% per year after two years of service and are fully vested after six years of service. For participants who terminate on or after January 1, 2014, Company contributions vest 25% per year in the first two years of service and are fully vested after the third year of service.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$87,619 and \$329, respectively. These accounts are used to reduce future Company contributions or to pay plan expenses. During 2025, the Plan used forfeitures totaling \$87,619 to reduce the 2024 employer matching contribution.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may not have more than two notes outstanding at any time. The notes are secured by the balance in the participant's account and must bear a reasonable rate of interest. Interest rates on notes receivable from participants at December 31, 2024 ranged from 5.25% to 10.00%. Principal and interest are paid through payroll deductions. Notes must be paid within 5 years, or a longer period as determined by the plan administrator if used for the purchase of a residence.

### Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or beneficiary may elect to receive payment of the vested interest in their account in installments or a lump-sum distribution. Participants may request in-service withdrawals if they are at least 59½ years of age. The participant may also receive a distribution for certain hardship situations.

### Administrative Expenses

The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. AAAA Benefits, Inc. charged 0.05% on the first \$5 million in assets and 0.03% of the remaining balance, which totaled \$53,239 in 2024. This was charged to participant accounts proportionately based on the value of the account balances.

The Company pays all other administrative expenses of the Plan. The Company does not expect reimbursement from the Plan for these expenses which qualify as party-in-interest transactions.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Any unfunded participant or employer matching contributions are included in the employee or employer contributions receivable on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.

In accordance with Accounting Standards Codification (ASC) 326, *Financial Instruments—Credit Losses*, the Plan estimated the current credit risk associated with the employer receivables. After giving consideration to the risk characteristics, including historical payment

experience, the Plan determined that no allowance for credit loss was necessary and there was no current year activity in the allowance for credit losses.

### **Investments**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Net change in the Plan's interest in the AAAA Retirement Fund includes realized and unrealized gains and losses on those investments, interest, dividends, and investment-related expenses.

### **Notes Receivable from Participants**

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.

### **3. Information Certified by AAAA Benefits, Inc.**

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in the Plan's interest in the AAAA Retirement Fund and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American Association of Advertising Agencies Retirement Fund c/o AAAA Benefits, Inc., the Plan's qualified institution.

### 4. Interest in the AAAA Retirement Fund

The Plan's interest in the AAAA Retirement Fund is included in the accompanying statements of net assets available for benefits. The AAAA Retirement Fund had 58 and 63 participating plan sponsors as of December 31, 2024 and 2023, respectively. The Plan's interest in the net assets of the AAAA Retirement Fund was approximately 10.06% and 9.38% as of December 31, 2024 and 2023, respectively.

The Plan's investments in the AAAA Retirement Fund are managed by an affiliate of the qualified institution; therefore, transactions in these securities qualify as party-in-interest transactions. AAAA Benefits, Inc. receives certain recordkeeping fees from the Plan which totaled \$53,239 for 2024. Fees incurred by the Plan for investment management services are included in investment earnings and losses, as they are paid through revenue sharing, rather than a direct payment. For the year ended December 31, 2024, the Plan incurred \$219,476 of investment management fees, of which \$66,665 was paid to AAAA Benefits, Inc. from Plan assets.

### 5. Fair Value Measurements

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market that the Plan has the ability to access (Level 1).

The collective trust trades at net asset value (NAV) per share. The NAV, including units of ownership to which a proportionate share of net assets is attributed, is used as of the reporting date as a practical expedient for measuring fair value. The fund is not categorized within the fair value hierarchy.

The objective of the collective trust is to provide a diversified group of investments offering competitive levels of yield consistent with stable fixed-income methodology and the careful and prudent assumption of investment risk providing for preservation of capital, stability, and predictability of returns, liquidity to pay plan benefits and high credit quality. The collective trust seeks to achieve this objective by investing in conventional, synthetic and separate account investment contracts (collective contracts) issued by life insurance companies, banks and other financial institutions. Characteristics of these contracts allow for their principal value to remain stable regardless of the volatility of the financial markets. For liquidity purposes, the collective trust may have all or a portion of its assets invested in high-quality money market instruments, investment companies and collective investment trusts that meet the investment objectives.

The collective trust investment includes certain redemption restrictions. If the AAAA Retirement Fund chooses to redeem all or a significant portion of the collective trust, the issuer may require a 12-month wait period to redeem.

There were no transfers in or out of Level 1, 2, or 3 during the years ended December 31, 2024 and 2023.

Investments are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, etc. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

### 6. Income Tax Status

The Company adopted a prototype basic plan document that received a favorable opinion letter from the IRS on June 30, 2020, which stated that the prototype basic plan document is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself and has been amended since receiving the prototype opinion letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by the taxing authorities and may change upon examination.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.
