### 1. DESCRIPTION OF THE PLAN

The following description of the Fuchs North America, Inc. 401(k) Plan (the Plan) (formerly the Baltimore Spice, Inc. 401(k) Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, which was established by Fuchs North America, Inc. (the Company or Plan Sponsor) effective November 1, 1987. The Plan is a deferred savings plan covering all employees of the Company. The Plan covers substantially all employees of the Company, with the exception of non-resident aliens. The Plan allows for immediate eligibility and entry of participants into the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was amended and restated effective January 1, 2022 to comply with tax law changes and to become a safe harbor plan.

#### Participant Contributions

Participants may contribute between 2% and 100% of their annual compensation, as defined by the Plan, not to exceed the maximum allowable contribution under Section 402(g) of the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. The Plan includes an automatic enrollment provision whereby an eligible participant who does not elect to contribute a specific percentage of their compensation will be automatically enrolled to contribute to the Plan at the rate of 3% of current compensation, unless they affirmatively elect not to contribute. This percentage increases annually on January 1<sup>st</sup> for all participants in 1% increments up to a maximum of 6%. Participants may contribute post-tax Roth elective contributions. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code. For the years ended December 31, 2024 and 2023, the maximum allowable amount for catch-up contributions totaled \$7,500. Participants are also permitted to make rollover contributions into the Plan from other qualified retirement Plans.

#### Company Contributions

The Company makes safe harbor matching contributions equal to 100% of the first 6% of participants' elective deferrals of compensation on a plan year basis. Participants are eligible to receive safe harbor matching contributions if they have attained 21 years of age. For the years ended December 31, 2024 and 2023, safe harbor matching contributions totaled \$709,183 and \$679,411, respectively.

#### Participant Accounts

Each participant's account is participant-directed and credited with the participant's contributions and allocations of: (a) Company contributions, (b) Plan earnings and losses and (c) Plan expenses. Allocations of earnings, losses, and administrative expenses are based on the proportion of each participant's account balance to the total of all account balances within the respective fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance, without regard to the intended use of the funds. Prior to October 1, 2024, the Plan's loan policy limited participants to two outstanding notes at any given time. Effective October 1, 2024, the Plan's loan policy limits participants to one outstanding note at any given time. Notes are collateralized by the participant's vested account balance. Note repayments are to be made each pay period through payroll deductions. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for the purchase of a primary residence shall be limited to a period consistent with commercial home loan practices.

#### Payment of Benefits

Upon termination of service, death, disability, retirement, or attainment of age 59½, a participant or their beneficiary, in the event of death, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments over a period not to exceed the participant's lifetime. If a participant has three or more years of credited service with the Company, an election to begin receiving benefits as early as age 55 can be made. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan document. If a participant's account balance is less than \$7,000, the Plan may elect to automatically distribute the participant's vested balance in a lump sum distribution. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions as of year-end.

#### Payment of Benefits – cont'd.

Effective January 1, 2024, in accordance with the SECURE 2.0 Act (SECURE 2.0), the Plan elected certain provisions: (a) Participants may request one emergency distribution per year of up to \$1,000 for unforeseeable or immediate personal or family financial needs, with the option to repay within 3 years, (b) the threshold for mandatory distributions increased from \$5,000 to \$7,000, (c) participants may take penalty-free early distributions in cases of domestic abuse wherein eligible participants may withdraw up to the lesser of \$10,000 or 50% of their vested account balance, provided the distribution occurs within one year of the domestic abuse incident, subject to specific provisions, (d) a surviving spouse may elect to be treated as the deceased employee for purposes of the required minimum distribution rules, (e) the Plan permits distributions of up to \$22,000 for expenses incurred as a result of a federally declared disaster, in accordance with the permanent disaster relief rules established under SECURE 2.0. Such federally declared disaster distributions are not subject to the 10 percent additional tax and are taken into account as gross income over 3 years, subject to specific repayment options, and (f) the Plan has a grace period to correct reasonable errors in administering automatic enrollment and escalation features without penalty, as long as corrections are made within 9 ½ months after the end of the plan year in which the error occurred. A formal amendment incorporating all SECURE 2.0 provisions is expected to be adopted no later than December 31, 2026, in accordance with Internal Revenue Service (IRS) guidelines. As of September 19, 2025, the Plan has not been formally amended for these provisions.

#### Vesting

Participants are immediately vested in their contributions, any rollover contributions, and any safe harbor matching contributions plus earnings thereon. Vesting in Company matching contributions plus earnings thereon is based on years of credited service. A participant becomes 100% vested after three years of credited service. Prior to three years of service, a participant is 0% vested; however, if an active participant dies, reaches retirement age, or is permanently disabled prior to attaining the normal retirement age, the participant's account becomes immediately 100% vested.

#### Forfeitures

Forfeitures of non-vested accounts are applied to reduce future Company matching contributions or pay Plan expenses. Forfeiture balances available totaled \$981 and \$1,782, as of December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, forfeitures totaling \$30,965 and \$41,311 were used to reduce Company matching contributions, respectively. For the years ended December 31, 2024 and 2023, there were no forfeitures used to pay Plan expenses.

#### Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid with net assets of the Plan unless the Company, at its discretion, elects to pay them. During the years ended December 31, 2024 and 2023, the Company paid a portion of the Plan's direct administrative expenses. Expenses paid directly by the Company are excluded from the Plan's financial statements. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of these investments may occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Interest income is recorded on the accrual basis. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

#### Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Fair Value Measurement – cont'd.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

*Insurance company general account:* Valued based on deposits, plus interest credited under the terms of the contract, less any withdrawals.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

### 3. INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule including assets held as of December 31, 2024 and 2023, interest and dividend income and net appreciation in the fair value of investments for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC (ETC), the Plan's Custodian and Trustee.

### 4. PARTY-IN-INTEREST TRANSACTIONS

The Plan loans funds to its participants according to the applicable provisions of the Plan document. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 5. INCOME TAX STATUS

The Plan adopted a non-standardized prototype plan with a deferral arrangement, which received a favorable opinion letter from the IRS dated June 30, 2020. The prototype plan has been amended since receiving the latest opinion letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's accompanying financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress.

### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions to the Plan would cease and all affected participants would become 100% vested in their accounts.
