## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of All Star Family 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTES TO FINANCIAL STATEMENTS****All Star Family 401(k) Plan**

December 31, 2024 and 2023

**Note 1 - DESCRIPTION OF PLAN**

The following description of the All Star Family 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**a. General**

The Plan is a defined contribution plan of All Star Electric, Inc. (the “Company”), covering employees of the Company and its participating employers (Regional Mechanical Services, LLC, All Star Premier Homes, LLC, Global Security & Data, LLC, RMS Services, LLC, ASE Services, LLC, and Star Recovery Services, LLC) who have at least one year of service and are age eighteen or older, except for employees covered by a collective bargaining agreement and non-resident aliens, as defined in the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**b. Contributions**

Each year, participants may contribute up to the maximum amount allowed by law of their annual compensation, as defined in the plan agreement. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Roth deferrals are permitted, and participants may elect both pre-tax and Roth deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides that the Company and its participating employers, except for Star Recovery Services, LLC, make ADP test safe harbor contributions of 100% of participant contributions up to 3% of compensation and 50% matching contributions of participant contributions greater than 3% up to 5% of compensation. For Star Recovery Services, LLC, ADP test safe harbor contributions are equal to the sum of 100% of the participant’s elective deferrals that do not exceed 6% of the participant’s compensation. The Plan also allows for discretionary employer nonelective contributions. For 2024, the Company and its participating employers made ADP test safe harbor contributions totaling \$675,858. There were no discretionary employer nonelective contributions made for 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Note 1 - DESCRIPTION OF PLAN (Continued)**

**c. Participant Accounts**

Each participant's account is credited with the participant's contributions and company ADP test safe harbor contributions, as well as allocations of the employer nonelective contributions (if any) and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**d. Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer nonelective discretionary contributions is at the rate of 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service, and 100% vested after six years of service. A participant is immediately 100% vested in all ADP test safe harbor contributions.

**e. Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that is based on prime plus 1% (8.50% as of December 31, 2024). Loan terms may not exceed five years. Principal and interest is paid ratably through payroll deductions.

**f. Payment of Benefits**

Participants may receive the full value of their vested account due to death, disability, retirement, or termination of employment. Distributions are made as soon as administratively feasible and are distributed in a single lump sum. In-service distributions are allowed to participants that have attained age 59½. Hardship distributions are permitted as defined in the plan agreement.

**g. Forfeited Accounts**

As of December 31, 2024 and 2023, there were no forfeited non-vested accounts. Under the plan agreement, forfeitures may be used to reduce employer contributions. During 2024, there were no forfeitures used to reduce employer contributions.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

**a. Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America as promulgated by the Financial Accounting Standards Board.

**b. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**c. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**d. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**e. Payment of Benefits**

Benefits are recorded when paid.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**f. Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**g. Subsequent Events**

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

**Note 3 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedules, including investments at fair value and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (John Hancock), the custodian of the Plan.

**Note 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) issued Accounting Standards Codification (ASC) 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Note 4 - FAIR VALUE MEASUREMENTS (Continued)**

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

- *Pooled separate accounts*: Valued at net asset value (NAV) of the units of the pooled separate accounts. The NAV is a readily-determinable fair value because the investments are equity securities in a structure similar to a mutual fund in which the fair value per unit are determined and published and are the basis for current transactions. The daily NAV is available to participants of the Plan and participants allowed to make daily redemption requests at NAV. The pooled separate accounts are measured using fair value and have been determined to be Level 2 inputs.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation method is appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Based on a reevaluation of the criteria for concluding that an investment has a readily-determinable fair value, the fair value of the common collective trust funds as of December 31, 2023 has been reclassified from investments measured at NAV as a practical expedient to Level 2 in the fair value table to conform with the current year presentation. This reclassification has no impact on net assets available for benefits as of December 31, 2023.

**Note 5 - PLAN AMENDMENTS - PARTICIPATING EMPLOYERS**

Effective October 1, 2023, the Plan was amended to allow Star Recovery Services, LLC to become a participating employer in the Plan. The age requirement was waived for eligible employees of Star Recovery Services, LLC employed on October 1, 2023, and the ADP test safe harbor contributions for this participating employer will be an amount equal to the sum of 100% of the participant's elective deferrals that do not exceed 6% of the participant's compensation.

**Note 6 - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Plan investments are held in pooled separate accounts managed by John Hancock, the Plan's custodian. Therefore, fund transactions associated with John Hancock are considered to be party-in-interest transactions.

John Hancock receives revenues from fund service providers for administrative services it provides to funds which the Plan invests under a revenue sharing agreement. This revenue is used to offset certain amounts owed to John Hancock for its recordkeeping and administrative services to the Plan. During the year ended December 31, 2024, total excess revenue sharing amounts of \$6,119 were received and were reported as other income in the statement of changes in net assets available for benefits.

**Note 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company and its participating employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 8 - TAX STATUS**

The Plan, originally effective January 1, 2004, was amended and restated January 1, 2022. The amended and restated Plan is a non-standardized pre-approved plan and has received a favorable advisory letter from the IRS dated June 30, 2020. The Plan itself has not separately applied for tax-exempt status; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
