## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of TCRG 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

December 31, 2024 and 2023

### (1) Description of Plan

The following description of the TCRG 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan covering substantially all eligible employees of Texas Capitalization Resource Group, Inc. and subsidiaries and Domestic Energy Partners, LLP, (collectively, the “Company”) who have completed 60 days of service. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and these employee contributions are invested in a designated balanced fund unless subsequently changed by the participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### (b) Contributions

Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company’s contributions are discretionary and determined annually by the Board of Directors. For the years ended December 31, 2024 and 2023, there were no discretionary employer contributions made to the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

#### (c) Participant Accounts

Each participant's account is credited with the participant's contributions, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(Continued)(1) Description of Plan (continued)(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is fully vested after six years of credited service. Full vesting in employer contributions also occurs upon death, disability, or retirement at or after age sixty-five.

(e) Notes Receivable from Participants

Participants may borrow from the vested portion of their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loan terms generally may not exceed five years. The loans are secured by the participant's account and bear interest at a rate determined by the plan administrator. The loan interest rates range from 5.25% to 10.50%. Principal and interest are paid ratably by payroll deductions.

(f) Payment of Benefits

The Plan provides that distributions of amounts \$5,000 or less be paid as a lump-sum. For account balances greater than \$5,000, on termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or various installment options over extended periods of time.

(2) Summary of Significant Accounting Policies(a) Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, interest income and contributions are recognized when they are received rather than earned. Certain expenses and related liabilities, including liabilities for corrective distributions, are recognized when paid rather than when the obligation is incurred.

(b) Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully-benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to direct investments in fully benefit-responsive

investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the modified cash basis. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent participant loans are recorded as distributions based upon the terms of the Plan agreement.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Administrative Expenses

The plan document allows for the expenses of maintaining the Plan to be satisfied directly out of the Plan's assets. A portion of the administrative expenses of the Plan is paid by the Company. Also, certain transaction charges are paid by the participants involved. Investment related expenses are included in net appreciation in fair value of investments.

(f) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs.

(Continued)(2) Summary of Significant Accounting Policies (continued)(g) Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Information Certified by the Custodian

The financial information included in the financial statements, except for contributions, benefits paid to participants, and administrative expenses, have been derived from information certified as complete and accurate by Reliance Trust Company, the custodian of the Plan, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA.

(4) Investments and Fair Value Measurements

The Plan invests in mutual funds and an unallocated investment contract with Transamerica Life Insurance Company (“Transamerica”).

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability.

The following methods and assumptions were used to estimate the fair value of the mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following methods and assumptions were used to report the value of the unallocated investment contract, the Transamerica Stable Value Core Option (the "Fund"). This unallocated investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The Fund guarantees a credited rate of return that is adjusted semi-annually based on current market conditions and performance of the fund's investments. There is no stated minimum or maximum interest rate for the Fund.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is set semi-annually by the issuer and is effective on January 1<sup>st</sup> and July 1<sup>st</sup> for the corresponding six-month period. The Plan must provide a 30-day advance notice of its intent to withdraw from the investment. If the Plan ends its participation in the Fund, it will receive the Plan's fair value as surrender value. Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs) that cause a significant withdrawal from the plan, or (c) the failure of the fixed account to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

(Continued)(5) Party-In-Interest Transactions

As more fully described in Note 4, the Plan invests in an unallocated investment contract with Transamerica Life Insurance Company (“TLIC”). Transamerica Retirement Solutions, LLC (“TRS”), an affiliated company of TLIC, provides recordkeeping services for the Plan, and this entity qualifies as a party-in-interest. Fees paid by the Plan for recordkeeping services to TRS and affiliated companies amounted to \$59,092 and \$44,418 for the years ended December 31, 2024 and 2023, respectively.

(6) Tax Status

The Plan is using a non-standardized prototype profit-sharing plan document. In a letter dated June 30, 2020, the IRS indicated the standardized form of the Plan is acceptable under Section 401 of the Internal Revenue Code (the “Code”). The opinion of the IRS on the acceptability of the form of the Plan is not a ruling or determination as to whether the Plan qualifies under Code Section 401(a). Although the Plan has been amended as a result of legislative changes since receiving the acceptability letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and that the related trust is tax-exempt.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

(8) Risks and Uncertainties

The Plan investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.

(9) Subsequent Events

The Plan has evaluated subsequent events from date of the statements of net assets available for benefits – modified cash basis through August 22, 2025, the date at which the financial statements were available to be issued, and determined there are no items to disclose.
