1. DESCRIPTION OF PLAN

The following description of the MDM Hotel Group Limited, 401(K) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of MDM Hotel Group Limited (the “Company”) who have completed 60 days of service and have attained age 18. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The effective date of the Plan is February 1, 1992.

Plan Administration

The Plans assets are held by Lincoln Financial Group Trust Company, Inc. (“Lincoln”) (the “Trustee”) and is administered by MDM Hotel Group Limited (the “Administrator”). The Plan’s recordkeeping services and maintenance of participant account records were managed by the Trustee.

Contributions

Each year, participants may elect to make pre-tax contributions or after-tax contributions to the Plan’s Roth investment option, as defined in the Plan document. For any calendar year, a participant’s elective deferrals may not exceed the lesser of a specific amount of \$23,000 for 2024 as determined by the Internal Revenue Service (“IRS”), or 100% of the participant’s eligible annual compensation. For participants fifty years of age or older, an additional \$7,500 contribution is allowed in 2024. Participants may also contribute amounts representing distributions from other qualified plans (“Rollovers”).

In addition, the Employer may make a safe harbor matching contribution and it is based on the amount of each participant’s elective deferral for the Plan year. For 2024, the Employer’s safe harbor matching contribution was 100% of the first 3% of the employee’s compensation and 50% for the next 2% of the employee’s compensation. The Employer made \$456,226 matching contributions during the year 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contribution and Plan’s earnings, and charged with benefit payments and allocations of the Plan’s losses and administrative expenses. Allocations of Plan’s earnings and losses are based on participant account balances, while contributions are credits based upon elective deferrals and compensation, as defined by the Plan document. Transaction fees are charged directly to the accounts of the participants who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance. Participants may change their investment options at any time.

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions plus actual earnings thereon to be invested in any of the investment options offered by the Plan. Participants may change their investment options daily.

1. DESCRIPTION OF PLAN (CONTINUED)

Administrative Expenses

Administrative expenses in connection with the Plan may be paid by the Plan unless paid by the Company. Administrative expenses paid by the Plan for the year ended December 31, 2024 totaled \$84,109. Expenses paid by the Company are excluded from these financial statements.

Notes Receivable from Participants

Participants may borrow from their fund account an aggregate amount not to exceed the lesser of \$50,000 or 50% of the fair market value of the vested portion of their account balance. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The balance of the loans as of December 31, 2024 and 2023 is \$219,699 and \$237,887, respectively. The interest earned on the loans for the year ended December 31, 2024 was \$19,830.

Vesting

Participants are immediately vested in their elective contributions, rollover contributions, and safe harbor matching contributions plus earnings thereon. A participant's vested interest in his/her Employer contribution account and/or matching contribution account is determined by multiplying the participant's vesting percentage (determined under the applicable vesting schedule as described in the Plan agreement) by the total amount under the applicable account.

Payment of Benefits

Upon termination of service, due to employment termination, death, disability or retirement, a participant may elect to receive a lump sum distribution or an amount for any part of the participant's vested interest in the account through periodic cash distributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may materially differ from those estimates.

Investment Management Fees

Investment management fees charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Registered investment company accounts are reported at fair value. Funds held in the insurance company general account are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Participant notes receivable are valued at cost, which approximates fair value. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed as incurred.

Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 1, 2025, which is the date the financial statements were available to be issued.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

4. TAX STATUS

Effective December 26, 2014, the Plan adopted a Volume Submitter Profit Sharing Plan with a cash or deferral arrangement developed by Lincoln Financial Group Trust Company, Inc. which obtained a favorable IRS opinion letter on March 31, 2014 in which the IRS stated that the form of the underlying volume submitter plan was acceptable under provisions of the Internal Revenue Code ("Code") and that any employer adopting this form of the plan will be considered to have a plan qualified under the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's investments at December 31, 2024 and 2023 were held by the Trustee, Lincoln Financial Group Trust Company, Inc. Accordingly, the following information was certified as accurate and complete by the Trustee in accordance with Department of Labor regulations. Accordingly, the custodians have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate.

- 1) Investments, at fair value and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- 2) Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- 3) Schedule of Assets (Held at Year End) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

6. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive investment contract with Lincoln Financial Group Trust Company, Inc., which receives the contributions and deposits them into either the insurance company general account or into registered investment company accounts according to the participants election. Registered investment company accounts are reported at fair value. The insurance company general account is reported at contract value. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals and administrative expenses.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund, or (3) an amendment to the Plan or a change in the administration or operation of the Plan. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

7. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Certain Plan investments are in registered investment companies administered by the Trustee. Lincoln is the Trustee as defined in the Plan and therefore, these transactions qualify the Trustee as party-in-interest. Notes receivable from participants are also considered party-in-interest transactions.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. FAIR VALUE MEASUREMENTS

The Financial Accounting Standard Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: Valued at quoted market prices or the net asset value of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date

10. PROHIBITED TRANSACTIONS

For the years ended December 31, 2024 and 2023, there were participants and employer contributions totaling \$644,533 and \$693,241, respectively that were not remitted to the Plan within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Department of Labor ("DOL") requires that participant contributions be remitted to the Plan on the earliest date on which they can be reasonably segregated from the Company's general assets. Failure to remit participant contributions to the Plan in a timely manner result in a prohibited transaction which must be separately reported to the DOL and may result in penalties to the Plan. As of September 1, 2025, the Plan administrator is currently working with the Company to calculate the loss or earnings and made the corresponding corrective contributions to the Plan for the year ended December 31, 2024. On May 27, 2025, the Company remitted \$13,884 to the Plan related to the missed earnings for the year ended December 31, 2023. The accompanying supplemental Schedule of Delinquent Participant Contributions presents the prohibited transactions of the Plan.
