Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## Notes to Financial Statements

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

### 1. DESCRIPTION OF THE PLAN

The following description of the Savage Arms Union Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all Union eligible employees of Savage Arms, Inc. (the “Company,” “Plan Administrator,” or “Plan Sponsor”). The Plan was established effective as of October 1, 2019. The Plan is subject to the Internal Revenue Code (“IRC”), as amended, and the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant directed and each participant has the ability to change their allocation at any time.

In 2024, an employee of the Plan Sponsor transferred internally within the organization. As a result, all assets held by the employee were transferred out of the Plan to Savage Arms Non-Union Retirement Plan (an existing plan controlled by the Plan Sponsor).

#### *Eligibility*

Full-time employees become eligible to participate in the Plan upon three months of service. Part-time employees become eligible to participate in the plan upon working 1,000 hours in a 12-month period. At such time that employees are eligible to participate, they are also eligible for safe harbor employer matching contributions.

Non-union employees, non-resident aliens, leased employees, employees who are residents of Puerto Rico, and temporary employees are not eligible to participant in the Plan.

#### *Participant Contributions*

Participants may elect to defer and contribute to the Plan eligible compensation up to the maximum amount allowed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

## ***Employer Contributions***

### ***Safe Harbor Matching Contributions***

The Company makes safe harbor matching contributions to employees covered by a Collective Bargaining Agreement with the International Association of Machinists and Aerospace Workers, AFL-CIO and Hasset Lodge No. 1420 and District 15 equal to 100 percent of salary deferrals up to the first 3 percent of eligible compensation, plus 50 percent of salary deferrals up to the next 2 percent of eligible compensation.

### ***Participant Accounts***

Each participant's account is credited with the participant's deferral contributions, Company safe harbor matching contributions, participant's rollover contributions, and allocations of the Plan's earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in safe harbor matching contributions and their voluntary contributions plus actual earnings thereon.

### ***Notes Receivable from Participants***

The Plan permits its participants to obtain loans against their respective account balances. Plan participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have one loan outstanding at any time. All loans bear an interest rate of 1% plus the effective prime rate at the time the loan is requested. Loans are repaid through salary deferrals in equal installments, and the term of a loan may not exceed five years, unless the loan is for the purchase of a principal residence. Certain restrictions apply to loans, as defined in the plan document.

### ***Forfeitures***

There are no amounts subject to vesting and therefore no forfeited nonvested accounts at December 31, 2024 and 2023.

### ***Benefits***

Withdrawals may be made from a participant's account at retirement, death, disability, termination of employment, or financial hardship. The participant's vested account will be distributed to the participant (or to the participant's beneficiary in the event of the participant's death) in a single lump-sum payment or installment payments. If a participant terminates service, the entire vested amount in his or her account may be distributed or rolled over into another qualified plan, as directed by the participant.

Withdrawals from salary deferral portions of the Plan may be made from the participant account based on

financial hardship in accordance with rules promulgated by the Internal Revenue Service (“IRS”) and the Plan document. Participants over age 59 ½ may elect to withdraw all or a portion of their account balances.

## 2. SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The financial statements have been prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that effect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### *Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Delinquent loans are recorded as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### *Payment of Benefits*

Benefit payments to the participants are recorded when paid.

## *Administrative Expenses*

Certain of the Plan's administrative expenses are paid directly by the Company and are excluded from these financial statements. Administrative fees charged to the Plan as shown on the statements of changes in net assets available for benefits relate to fees charged to the participants for recordkeeping and information management or participant loan processing that are deducted from their asset balances. Investment related expenses are included in net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits.

### **3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Valuation is based on observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds and Money Market Fund:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact business at that price. The funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **4. FINANCIAL INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, a qualified institution.

The Trustee also certified the information included in the Schedule of Assets (Held at End of the Year) included in the supplemental schedule in these financial statements.

## 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to provisions of ERISA.

## 6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by The Vanguard Group (“Vanguard”). Vanguard is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid for investment management, custody and recordkeeping services are included as a reduction of the investment return earned by each investment. The Plan issues loans to participants, which are secured by balances in the participant’s account and therefore qualify as party-in-interest transactions.

## 7. TAX STATUS

The Plan has adopted an adoption agreement for Sentinel Benefits Group, Inc. non-standardized defined contribution pre-approved plan. The IRS has determined and informed Sentinel Benefits Group, Inc. by a letter dated November 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or Department of Labor (“DOL”). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

## **9. NONEXEMPT TRANSACTIONS**

During 2024, the Plan Sponsor inadvertently failed to deposit approximately \$69,000 of participant contributions and loan repayments within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor intends to deposit lost interest to correct this failure in 2025. The Plan Sponsor intends to file Form 5330 and intends to pay the applicable excise tax to the IRS. The correction will be made from the Plan Sponsor's assets and not from assets of the Plan.

## **10. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.


