To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Responsibilities of Management for the 2024 Financial Statements

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of American Gift Corporation Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about American Gift Corporation Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule of Assets (Held at Year End) for the year ending December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Auditor's Report on the 2023 Financial Statements

The financial statements of American Gift Corporation Retirement Savings Plan as of December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 4, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirement of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the American Gift Corporation Retirement Savings Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan, which was adopted on January 1, 1998, is a defined contribution plan covering all eligible employees of the company. Employees become eligible to participate in the Plan after completing one year of service, as defined by the Plan and who are age eighteen or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Amendments - The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. Effective January 1, 2025 the Plan adopted certain optional provisions related to the SECURE 2.0 act, including the higher catch-up contributions for certain participants aged 60-63. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Contributions - For 2024, participants could contribute up to \$23,000. Participants, who reach age 50 during the calendar year may contribute an additional \$7,500, for a total of \$30,500 for 2024 of their pretax annual compensation as defined by the Plan. Participants can also elect a direct rollover of an existing balance from a tax-qualified retirement or savings plan into the Plan.

The Company may also contribute an amount equal to a percentage of each participant's salary reduction or total compensation based on a discretionary matching contribution to the plan. The Company has elected to make safe harbor matching contributions of 100% of employee deferrals, not to exceed 3% of the employee's compensation, plus 50% of employee's deferrals between 3% and 5% of the employee's compensation. The Employer may also make a discretionary profit-sharing contribution to the Plan each year.

The annual contribution from all sources to participant's account may not exceed the lesser of \$69,000 (\$76,500 including catch-up contributions) for 2024, or the participant's annual compensation during the plan year. Employer matching contributions for 2024 amounted to \$182,385. In addition, the employer elected to make a discretionary contribution of \$200,000 for 2024, which was allocated as follows: The breakdown was 4.92% for owners, 4.45% for salaried employees and 1.64% for all other eligible employees.

Participant Accounts - Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's matching contributions, (b) the Company's profit-sharing contribution, (c) Plan earnings and losses, and (d) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Alternatives - Plan participants may direct their entire account balances in partial percentage increments to any of the various investment options offered by the Plan. Employer contributions are also invested based upon participant allocation elections. Participants may change their investment options on a daily basis.

Notes Receivable from Participants - Loans to participants are not permitted.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s matching and profit-sharing contributions portion of their accounts plus earnings thereon is based on years of continuous service as shown below. A participant must have 1,000 hours worked in a given year in order for it to count as a single year of service for vesting purposes. All participants who terminate due to death, disability, or attain the Normal Retirement Age are 100% vested in their matching and profit-sharing contributions.

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant with a vested balance that exceeds \$5,000 may elect to receive an amount equal to the value of the participant’s vested interest in their account, in either a lump-sum amount, or in installments over a period of no more than the participants assumed life expectancy. The normal retirement age as defined by the Plan is 65. Participants who are still employed and have reached age 60 and are 100% vested are eligible for an in-service distribution of all or a portion of their vested balance. If a participant terminates before retirement, the participant will receive a lump sum payment of their vested percentage balance.

Forfeitures – Forfeited balances of terminated participants’ non-vested accounts are used to offset employer matching contributions and non-elective contributions for the year as well as to pay Plan administrative expenses. During 2024 forfeitures of \$17,267 were applied. Unallocated forfeitures outstanding as of December 31, 2024 and 2023, were \$7,202 and \$17,173, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan’s administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the stable value fund, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for the investment in the guaranteed interest account because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan administrator determines the Plan’s valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/(depreciation) of the fair value of investments.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Also known as registered investment companies, which are valued at quoted market prices on the last business day of the Plan year.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the years ended December 31, 2024 and 2023, there were no transfers of financial instruments into or out of Level 1 or 2. The Plan had no Level 2 or 3 measurements during the years ended December 31, 2024 and 2023.

NOTE 5 – INVESTMENTS AT CONTRACT VALUE

Investments at contract value consist of the JPMCB Stable Asset Income CF, an investment option, which is a guaranteed interest account that offers a guaranteed minimum interest rate and a return on principal. Participant account balances are credited daily with interest and participants have daily liquidity at full book value (principal and interest) for all participant initiated events. Interest rates averaged approximately 2.45% and 2.5% for 2024 and 2023, respectively. At December 31, 2024 and 2023 the balance in the JPMCB Stable Value Asset Income Account was \$479,807 and \$633,602, respectively.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

The Plan's Investments are held by JP Morgan Chase Bank, N.A. These transactions qualify as party-in-interest transactions.

Empower Trust Company, LLC provides recordkeeping, Plan management, and day-to-day support to the Plan; therefore, these transactions qualify as party-in-interest.

American Gift Corporation is the Plan Administrator and Sponsor of the American Gift Corporation Retirement Savings Plan. These transactions qualify as party-in-interest transactions. Certain key personnel are also considered parties-in-interest due to ownership and administrative rights over the plan.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 8 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 11 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through September 17, 2025, which is the date the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements.
