We have performed an audit of the financial statements of the WHEMCO - Steel Castings Inc. 401(k) Plan (“Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## NOTES TO FINANCIAL STATEMENTS

### WHEMCO - Steel Castings Inc. 401(k) Plan

#### 1 Description of Plan

The following description of the WHEMCO - Steel Castings Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### *General:*

The Plan, which was restated effective March 21, 2016, is a defined contribution plan covering all employees of West Homestead Engineering and Machine Company ("Company") who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In January 2025, the Plan was amended and renamed to WHEMCO - Steel Castings Inc. 401(k) Plan. Additionally, two additional plans were created as of January 1, 2025 named WHEMCO Inc. 401(k) Plan and Whemco-Ohio Foundry Inc. 401(k) Plan. Participant balances for employees of these divisions were transferred to their respective employer plans in April 2025.

##### *Eligibility:*

All employees of the Company age 18 and older and are employed for three months are eligible to participate in the Plan.

##### *Contributions:*

Cash or Deferred Option 401(k) - Participants may elect a portion of their compensation, between 1% and 50%, to be contributed to the Plan through pretax contributions. Catch up contributions are also allowed under the Plan.

Employer Matching Contributions - The Company may make discretionary contributions to each participant who has one year of service. Company matching contributions are paid to the Plan at a maximum annual amount of \$2,800 for 2024 and 2023. The Company match is paid in January and July for the preceding six-month period. The maximum payment in July is equal to one-half of the maximum annual amount, or \$1,400 for 2024 and 2023. The remaining Company match paid in January is equal to the maximum annual amount less the bi-annual payment amount that was paid in July.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

In 2023, the Plan was amended to include an automatic-enrollment provision. Automatically enrolled participants will have their deferral rate set at 3% of eligible compensation.

## NOTES TO FINANCIAL STATEMENTS

### WHEMCO - Steel Castings Inc. 401(k) Plan

#### **1 Description of Plan, Continued**

##### ***Participants' Accounts:***

401(k) Accounts - Each participant's account is credited with the participant's elective contributions, employer matching contributions, earnings and losses thereon.

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

##### ***Vesting:***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also fully vested in the Company contribution portion of their accounts plus actual earnings thereon.

##### ***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed five years, with exceptions for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the Prime rate. Principal and interest are paid ratably through payroll deductions. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### ***Other Plan Provisions:***

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59-1/2.

##### ***Payment of Benefits:***

Upon termination of employment prior to normal retirement, participants may elect to receive a lump sum distribution of their account balance. At retirement or death, a participant's account shall be paid in a lump sum payment in cash. For purposes of such distributions, all accounts shall be valued by reference to the value of the participant's account after the next valuation date, as defined in the Plan agreement, following the date of death or termination of employment. There were no future payments owed to separated participants at December 31, 2024 and 2023.

##### ***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

## NOTES TO FINANCIAL STATEMENTS

### WHEMCO - Steel Castings Inc. 401(k) Plan

#### **1 Description of Plan, Continued**

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may direct his or her contributions in any or all of the Plan's investment options. Participants may change their investment options and transfer funds between investment options daily.

##### ***Basis of Accounting:***

The Plan prepares its financial statements on the modified cash basis, which differs from accounting principles generally accepted in the United States. The Plan records contributions when such amounts are received, rather than when earned.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **2 Summary of Significant Accounting Policies**

##### ***Valuation of Investments:***

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Administrative Fees:***

Substantially all administrative fees are paid by the Company. The fees paid by the Company for services rendered by parties-in-interest are based on customary and reasonable rates for such services.

## 2 Summary of Significant Accounting Policies, Continued

### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

### *Risks and Uncertainties:*

The Plan's investments include investments in mutual funds and a guaranteed investment contract with varying degrees of risk, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits (Modified Cash Basis).

### *Contributions:*

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 18, 2025, which is the date the financial statements were available to be issued.

## 3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

**4 Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets.
- \* Quoted prices for identical or similar assets or liabilities in inactive markets.
- \* Inputs other than quoted prices that are observable for the asset or liability.
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds:***

The fair value of the mutual funds is based on quoted market prices and are classified in Level 1 of the valuation hierarchy.

#### 6 Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Ascensus Trust Company, the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Usual and customary fees were paid by the mutual fund for the investment management services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest transactions.

#### 7 Benefit-Responsive Contract

The Plan holds a benefit-responsive insurance contract with Standard Insurance Company ("Standard"). The contract meets the fully benefit-responsive insurance contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value is stated at \$1,384,722 (2024) and \$2,027,331 (2023).

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code, (2) the establishment of a defined contribution plan that competes with the plan for employee contributions, (3) any substantive modification of the plan or the administration of the Plan that is not consented to by the wrap issuer, (4) complete or partial termination of the Plan, (5) any change in law, regulation, or administrative ruling applicable to the plan that could have a material adverse effect on a portfolio's cash flow, (6) merger or consolidation of the plan with another plan, the transfer of assets to another plan, or the sale, spin-off or merger of a subsidiary or division of the plan sponsor, (7) any communication given to participants by the plan sponsor or any other plan fiduciary that is designed to induce or influence participants not to invest in a portfolio or to transfer assets out of a portfolio, (8) exclusion of a group of previously eligible employees from eligibility in the plan, (9) any early retirement program, group termination, group layoff, facility closing, or similar program, and (10) any transfer of assets from a portfolio directly to a competing option. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants is probable.
