Independent Auditor's Report

Opinion on the Financial Statements

I have audited the accompanying financial statements of ERISA Plans Participating in the Health and Welfare Benefits Consortium of Educational Institutions (the "Trust"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of trust assets and liabilities as of December 31, 2024 and 2023, and the related statements of trust income and expenses and changes in trust assets for the years then ended, and the related notes to the financial statements.

In my opinion, the financial statements referred to above present fairly, in all material respects, the financial status of the Trust as of December 31, 2024 and 2023, and the changes in its financial status for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the Financial Statements

I conducted my audit in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. I am required to be independent of the Trust and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the three remaining Participating Employers of the Trust terminated their participation in the Trust effective June 1, 2025 and the Trustees have initiated the process to terminate the Trust. My opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current trust instrument, including all trust amendments; administering the Trust; and determining that the Trust's transactions that are presented and disclosed in the financial statements are in conformity with the Trust's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

My objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with generally accepted auditing standards, I:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in my judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Trust's ability to continue as a going concern for a reasonable period of time.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audit.

Notes to Financial Statements December 31, 2024 and 2023

1. Description of the Trust

The following description of the Health and Welfare Benefits Consortium of Educational Institutions (the “Trust”) provides only general information. Participants should refer to the Group Insurance Trust Agreement (“Agreement”) for a complete description of the Trust’s provisions.

These financial statements relate to the plans of “Participating Employers,” as defined in the Agreement that are subject to the requirements of Title I of the Employees Retirement Income Security Act of 1974 (the “ERISA Plans Participating in the Health and Welfare Benefits Consortium of Educational Institutions”).

General— The Trust began on January 1, 2010 and operates as a multiple employer welfare arrangement. The Trust functions as a group insurance arrangement through which unrelated “Participating Employers” purchase the benefits which they make available to eligible individuals. The Trust holds the policies under which benefits are administered and paid and serves as the conduit for the payment of premiums to insurers.

Each Participating Employer sponsors a fully-insured group health plan for the benefit of its eligible employees and their dependents. Each Participating Employer serves as the administrator with respect to its own plan including eligibility determinations and enrollment, the type and amount of benefits to which participants are entitled and to pay benefits.

To be eligible for admission as a Participating Employer, an employer must be a not-for-profit educational institution and meet certain requirements as defined in the Agreement, including executing a Membership Agreement. Effective June 1, 2024, one additional Participating Employer joined the Consortium.

Subsequent to December 31, 2024, the three remaining Participating Employers of the Trust terminated their participation in the Trust effective June 1, 2025 as permitted by the Membership Agreement. Also, the Trustees have initiated the process to terminate the Trust in accordance with the Group Insurance Trust Agreement. The Trustees will direct the satisfaction of any and all obligations and expenses of the Trust and coordinate final reporting requirements to regulatory authorities as soon as practicable.

2. Summary of Significant Accounting Policies

Basis of Presentation—The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Cash—Cash consists of non-interest bearing deposits with a financial institution.

Deferred Group Health Insurance Premiums—Represents contributions received from Participating Employers in advance of the period for which the premiums are due. Such amounts are payable to Highmark Western and Northeastern New York Inc.

Administrative Expenses—The Participating Employers are responsible for paying all expenses and fees incurred by the Trust. Trust fees and expenses are shared equally by all Participating Employers.

Net Deficit Position – At December 31, 2024, the Trust’s liabilities exceeded assets available for benefits (a net deficit). This net liability was remedied in 2025 when the Trustees assessed additional funding from the Participating Employers for the payment of the accrued administrative expenses at December 31, 2024 and for other ongoing operations.

Use of Estimates—The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events — The Trust has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

3. Funding and Operation of the Trust

Administration of the Trust

The Board of Trustees, or “Trustees” have the responsibility for administering the Trust. Each Participating Employer may appoint two Trustees. The Trustees shall administer the affairs of the Trust in accordance with the terms of the Agreement.

Funding of the Trust

Premium Payments—Each Participating Employer contributes to the Trust the premiums established by the insurer for coverage provided to individuals enrolled by the Participating Employers for coverage under the Policy, as defined. Upon receipt by the Trust, premiums paid by a Participating Employer will be credited against the premiums due the insurer as soon as administratively practicable after the date on which the Trust receives the payment. Broker commissions are included with the respective monthly premiums.

Other Employer Contributions—Each Participating Employer contributes to the Trust such other amounts as the Trustees may from time to time determine, for the payment of expenses of administering the affairs of the Trust, as defined in the Agreement.

Benefits Under the Trust

The Trust serves as a conduit for the payment of Policy premiums, as defined in the Agreement. The medical insurance coverage available to eligible employees of Participating Employers is provided on a fully-insured basis pursuant to a group insurance contract issued by Highmark Western and Northeastern New York Inc.

4. Tax Status

The trust administrator believes the Trust is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Trust is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Transactions with Parties In Interest and Related Parties

Certain officers of the Trust or Trustees perform administrative services at no cost to the Trust. During 2024 and 2023, a Participating Employer advanced funds to the Trust to cover certain administrative costs.

6. Trust Termination

The Trust may be terminated by a majority of the Trustees, as defined in the Agreement. A Participating Employer may withdraw and terminate its participation in the Trust pursuant to certain conditions as prescribed in the Membership Agreement. As described in Note 1, the three remaining Participating Employers of the Trust terminated their participation in the Trust effective June 1, 2025 as permitted by the Membership Agreement and the Trustees have initiated the process to terminate the Trust in accordance with the Group Insurance Trust Agreement.
