### Report on the Financial Statements

#### *Opinion*

We have audited the accompanying financial statements of Western Regional Employee Welfare Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits and of Plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in Plan's benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of the Plan's benefit obligations of Western Regional Employee Welfare Benefits Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and of changes in the Plan's benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

#### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Western Regional Employee Welfare Benefits Plan (the Plan) provides only general information. The Trust is the funding vehicle for the Plan, which provides health and welfare benefits to eligible employees of Reed Family Companies, formerly Basic Resources, Inc. (the Company) and subsidiaries. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan provides health benefits to substantially all full-time employees of the Company who have at least 60 days of consecutive service and are not covered by a collective bargaining agreement. The Plan also provides health benefits to eligible dependents of each participant. As required by the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), the Plan includes a continuation of coverage option to certain terminated, retired and totally disabled participants and their covered dependents for a period not to exceed 18 months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections and to extend coverage to eligible dependents. Participants pay the full cost of supplemental and dependent life insurance, supplemental accidental death and dismemberment insurance, critical illness, and pet insurance programs based on the current group rate premium costs. The Company pays the full cost of basic life insurance, and basic accidental death and dismemberment insurance for all employees and the full cost of long-term disability coverage for employees scheduled to work at least 30 hours per week following 12 months of service.

Participating employers make a monthly contribution pursuant to the current rates set forth by the Board of Trustees. The employers contribute to the Plan monthly, based on an internal calculation prepared by the Company which covers premiums for eligible employees. The Board of Trustees periodically reviews and adjusts the contribution rates.

**Benefits**

The Plan provides health benefits including medical, prescription drug, dental, vision, life insurance, long-term disability benefits, accident insurance, critical illness, pet insurance, accidental death and dismemberment benefits, and flexible spending accounts to eligible full-time employees of the Company and to their covered dependents.

**Benefits (Continued)**

The Plan also offers a Health Reimbursement Arrangement (HRA) option for Kaiser Permanente and CIGNA to reimburse employees for qualified medical expenses that are paid out of pocket. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year cannot be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the employer. Included in the accompanying statements of net assets are amounts available to reimburse participants for qualifying medical expenses totaling \$1,194,758 and \$558,448 as of December 31, 2024 and 2023, respectively.

**Self-Insured Benefits**

The Plan has an active agreement with CIGNA to provide health benefits including medical, major medical, hospital, surgical, dental, and vision services to eligible employees of the Company and to their covered dependents. Claims for these benefits are subject to various deductible and co-payment amounts. The Plan provides these benefits on a self-funded basis, subject to a stop-loss limit. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

**Stop Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as aggregate exposure for all claims).

**Fully-Insured Benefits**

The Plan has an active agreement with Kaiser Permanente to fully insure and provide health benefits including medical, major medical, hospital, and surgical to eligible employees of the Company and to their covered dependents. The Plan fully insures life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), long-term disability benefits, pet insurance benefits, accident insurance, and critical illness benefits. The Plan purchases annual insurance contracts for these insured benefits.

**Flexible Spending Account**

The Plan has a flexible spending account (FSA) that is funded solely through employee contributions and administered by a third-party service provider. The FSA allows eligible participants to be reimbursed tax free for qualified medical expenses and qualified dependent care costs subject to a maximum annual amount of \$3,200 and \$5,000, respectively. FSA participants have an additional 2 ½ month grace period of time to submit expenses after the Plan year-end.

**Health Savings Accounts**

The Plan offers a health savings account (HSA) arrangement that is funded through both employee and employer contributions and funds are remitted to and managed by a third-party service provider. The HSA permits eligible participants to contribute amounts on a pre-tax basis (up to annual Internal Revenue Service (IRS) limits) through payroll deductions and allows tax-free growth of HSA balances as long as funds are used to pay for qualified medical expenses. The Plan transfers the HSA contributions to a third-party administrator on a weekly basis. Funds within the HSA arrangement are owned by the individual participant, roll over from year to year if unspent, are not subject to vesting requirements or forfeiture provisions and are portable upon termination once the employee leaves the Company.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Concentration of Credit Risk**

The Plan maintains its demand deposits in commercial bank accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

**Administrative Expenses**

All administrative expenses may be paid out of the Plan unless paid by the Company. During the years ended December 31, 2024 and 2023, the Plan paid for substantially all administrative expenses, which consisted of claims administration fees (ASO), COBRA and HRA administration fees and other miscellaneous expenses.

**Payment of Benefits**

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

Premiums paid through the VEBA trust are recorded as premium payments in the accompanying the statements of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

**NOTE 3 PREMIUM DEPOSIT**

Effective March 1, 2018, the Plan was required to maintain a premium deposit with the third-party claim administrator, CIGNA. The premium deposit is related to claims and will be used to the pay claims in the event the Plan terminates the contract with CIGNA. The premium deposit amounted to \$213,888 as of December 31, 2024 and 2023.

**NOTE 4 BENEFIT OBLIGATIONS**

The Plan self-funds medical, prescription, dental and vision benefits provided to participants. As of each December 31, there are self-funded claims that have been incurred on which benefits payments will be made subsequent to that date. Plan obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's management based upon claims data provided by the Plan's third-party claims administrator, using claims patterns, claim trend rates and actual lag patterns. These amounts are paid by the Plan only if claims are ultimately submitted and approved for payment.

**NOTE 5 STOP LOSS COVERAGE**

During the years ended December 31, 2024 and 2023, the Plan maintained a stop-loss insurance policy with Cigna Health and Life Insurance Company. Since the Plan utilizes Cigna for both claims processing and as the stop-loss insurance carrier, the Plan is not billed for claims in excess of \$60,000 per year for each participant for the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, claims in excess of \$60,000 paid directly by the stop-loss insurance carrier, totaled \$742,358 and \$2,856,852, respectively.

**NOTE 6 TAX STATUS**

The Trust established under the Plan to hold the Plan's assets received an exemption letter from the IRS dated June 30, 2014, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income. In addition, the Plan and the Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

**NOTE 6 TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.
