Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MCP Services, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MCP Services, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1. DESCRIPTION OF PLAN

The following description of the MCP Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of Management Consulting Personnel Services, Inc. (the "Company") who have completed 90 days of service with at least 1,000 hours of service and are age twenty-one or older. The Plan, which was amended on January 1, 2024, includes an automatic enrollment percentage for any eligible participants under safe harbor provisions. The amended Plan is now referred to as a qualified automatic contribution arrangement 401K plan, also known as a "QACA". The trustee and recordkeeper for the Plan's investments is Transamerica Retirement Solutions ("Transamerica"). Transamerica provides administrative services and insurance products to the Plan. Reliance Trust Company is the custodian under a contract arrangement with Transamerica through June 30, 2024. Transamerica Trust Company was the custodian at December 31, 2024. The Company is the Plan's sponsor and serves as the plan administrator.

Contributions: Each year, participants may contribute a percentage of pretax compensation as limited by the law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute (rollover) amounts representing pre-tax distributions from other qualified plans. The deferral rate for automatically-enrolled participants is initially set at 3% and will automatically increase 1% per year until the deferral gets to 6%. All Company contributions to the Plan are determined at the discretion of the Company's board of directors. The Company matching is a 100% match to 1%, and a 50% match up to 6% of the participants' deferral. Additional profit-sharing amounts may be contributed by the Company and are invested directly in a portfolio of investments as directed by the Company. The Company's matching contribution for the year ended December 31, 2024 and 2023 amounted to \$576,108 and \$534,025, respectively.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Allocations may be determined proportionately based on participant earnings or account balances. Participants direct the investments of their contributions and the Company's matching contributions, if any, into various investment options offered by the Plan. The Plan currently offers various mutual funds and a pooled separate account as investment options for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the Company's contribution to the participants' accounts is based on years of continuous service. A participant is 100 percent vested after two years of credited service under the QACA safe harbor match rules.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable interest rate (prime rate at the inception of the loan plus two percent). Principal and interest is paid ratably through payroll deductions. Interest rates on outstanding loans ranged from 5.25% to 10.5% at December 31, 2024. Loans are amortized in level payments over a period not to exceed five years, except for loans to purchase the participant's primary residence that are amortized in level payments over a period not to exceed thirty years.

Payment of benefits: On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in the account in either lump-sum amount or in periodic installments. Additionally, participants may keep their account with the Plan or rollover the balance to another qualified retirement account. The Plan also allows in-service hardship withdrawals before retirement age for qualifying circumstances.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America. Accordingly, income is recognized when earned, and expenses are recorded when incurred.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value, which are valued at the net asset value of shares owned by the Plan as determined by Transamerica based on factors such as quoted market prices in active markets and prevailing interest rates. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Invesco Stable Value Trust Fund, which is a pooled separate account, is reported at fair value and adjusted to contract value. Contract value represents the accumulated contributions plus accrued and net earnings, less distributions. Fair value of the investment in the Invesco Stable Value Trust Fund is estimated to be the same as contract value. See Note 4 for discussion of fair value measurements.

Contributions are invested in unaffiliated mutual funds and pooled separate accounts. These investments generally invest in a mix of stocks, bonds, cash equivalents, and potentially other asset classes, either directly or via underlying investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as held during the year.

Noted receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Investment transaction expenses are offset against the related investment income. Other administrative and non-investment expenses of the Plan are either paid by the Company, which is a party-in-interest, or through the Plan expense account. Expenses paid the Company, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA. Expenses paid through the Plan expense account are included in administrative expenses in the Statement of Changes in Net Asset Available for Benefits. The Company absorbs a significant portion of the Plan's administrative expenses. For the year ended December 31, 2024, and 2023, the administrative expenses paid by the Plan were \$76,268 and \$68,942, respectively.

Forfeited accounts: As of December 31, 2024, and 2023, the forfeited nonvested accounts totaled \$26,857 and \$19,141, respectively. Forfeitures of nonvested accounts may first be used to pay any administrative expenses and any remaining forfeitures will be used to reduce any Company contribution, of which \$1,381 was used to pay administrative expenses during 2024.

Subsequent events: The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued. No subsequent events have arisen that would require disclosure in these financial statements.

NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology are observable other than level 1 prices, such as quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation measurement are unobservable, supported by the little or no market data, and are significant to the fair value of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded and are considered Level 1 assets. The NAV is a quoted price in an active market.

Pooled separate accounts: Valued at the NAV of units of the fund, which is based on the estimated market value of the underlying investments less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In regards to the classification of investment options offered by the plan, there were no reclassifications in or out of levels 1, 2 or 3 during the years ended December 31, 2024, and 2023. The nature, risks and investment objectives of the investments described above, including those for which fair value is estimated using NAV as a practical expedient, can be found in the plan's enrollment literature. These investments can be redeemed immediately and without a redemption notification period. For the years ended December 31, 2024 and 2023, there were no unfunded commitments associated with any of these investments.

NOTE 5. POOLED SEPARATE ACCOUNT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica. Transamerica maintains the contributions in the Invesco stable value trust ret account, which is a pooled separate account (PSA). PSAs offered are proprietary to Transamerica and many invest exclusively in one underlying mutual fund traded on an established market. As such, the PSAs begin with a price determined by Transamerica and the number of units issued are calculated to match the current fair market value of the underlying mutual fund holdings. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract.

Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

All of Transamerica's PSA choices are valued using publicly available quoted market prices, and participants bear the investment risks and are invested in fixed maturity securities, which are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities. The redemption frequency and redemption notice are daily with all PSAs and there are no unfunded commitments.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are made available by Reliance Trust Company, who is the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Fees incurred by the Plan for investment servicing are included in net appreciation (depreciation) in fair value of investments and amounted to, as they are paid through revenue sharing, rather than direct payment.

During the years ended December 31, 2024 and 2023, the Plan made direct payments of \$76,268 and \$68,942, respectively, to third party servicers for recordkeeping, trustee, and investment advisory services, which were not covered by revenue sharing. Of these payments, certain fees of \$60,402 paid to Transamerica, the recordkeeper, are considered to be party-in interest transactions under ERISA. The Company pays directly any other fees related to the Plan's operations, other than investment management fees.

NOTE 7. CERTIFIED INVESTMENT INFORMATION

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution, through June 30, 2024. Transamerica Trust Company, a qualified institution, certified through December 31, 2024.

NOTE 9. TAX STATUS

The Plan document is a pre-approved prototype plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the plan has been amended since receiving the favorable opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the federal or state tax authorities. The Plan's administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

NOTE 11. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
