Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Aperto Property Management, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Notes to Financial Statements

1. THE PLAN

The following description of the Aperto Property Management, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan commenced in January of 2018 as a defined contribution plan covering all employees of Aperto Property Management, Inc. (the "Company") employed for 2 months who have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute part of their pretax annual compensation as defined by the Plan, up to the maximum allowed by law. The contract currently offers various mutual funds and a money market account as investment options for participants.

Based on Plan provisions, the employer makes Safe Harbor matching contributions equal to 100% of each participant's deferred compensation up to 3% of their total pay and then an additional 50% up to 5% of pay. The Company also has the option to make profit sharing contributions.

Participant accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, an allocation of the Company's discretionary contributions, if any, and an allocation of Plan earnings within the designated specified investment funds. Each participant's account is charged with an allocation of management fees. Allocations are based on participant earnings or account balances, as defined. The Company pays administrative expenses incurred on behalf of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions, along with employer Safe Harbor matching contributions, plus actual earnings thereon. The Company can make additional profit sharing contributions which are subject to a vesting percentage scale as defined in the Plan agreement. Participants who become totally disabled or die before normal retirement age become fully vested in their accrued benefits.

1. THE PLAN (CONTINUED)

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to 10 years or a repayment period consistent with commercial home loan practices. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Interest rates range from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or as an annuity described in the Plan agreement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

Forfeited non-vested accounts are used to reduce the Company's contribution for the next plan year. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$89 and \$85, respectively. For the years ended December 31, 2024 and 2023, \$0 of forfeitures were used to fund employer contributions for both years.

Hardship withdrawal

A participant may be permitted to withdraw a portion or all of the balance of their individual account that is attributable to their tax-deferred contributions (without earnings) for the reasons specified by and to the extent permitted under regulations issued by the Internal Revenue Service.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Notes receivable from participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits

Benefits are recorded when paid.

Operating expenses

All expenses of maintaining the Plan are paid by the Company.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs are those that are observable, either directly or indirectly, for the asset or liability other than quoted prices included in Level 1; and Level 3 inputs, which are unobservable, are used when level 1 and 2 inputs are not available. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used to measure investments where the underlying assets are directly observable to unadjusted quoted prices in active markets. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 fair value measurements

The fair value of money market portfolio and mutual funds are based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stocks, corporate bonds, and U.S. Government securities are based on quoted market prices.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their matching contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their accounts.

7. RELATED PARTY TRANSACTIONS

Certain Plan investments are in funds managed by The Vanguard Group. The Vanguard Group is the recordkeeper, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are allowable under the ERISA regulations. As of December 31, 2024 and 2023, total administrative fees paid by the Plan to The Vanguard Group totaled \$14,100 and \$11,070, respectively.

8. TAX STATUS

The Plan is placing reliance on an opinion letter dated March 31, 2014, received from the Internal Revenue Service indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has been amended since the date of the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

9. EXCESS CONTRIBUTIONS

As of December 31, 2024 and 2023, the statement of net assets available for benefits reflected an accrual of \$1,465 and \$1,103, respectively, payable to refund excess employer contributions and employee contributions related to an error in the calculation of the employer match and certain deposit calculation errors made by the third party payroll company contracted with the Plan sponsor.
