## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Chicago Zoological Society Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

### Note 1 - Plan Description

The following description of Chicago Zoological Society Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Chicago Zoological Society (the "Society"). All regular employees who have attained the age of 21 and have completed one hour of service are eligible to participate in the Plan on a voluntary basis.

Prior to January 1, 2024, employees in positions classified in pay grades as GS, S, or U-700 to U-799 who have attained the age of 21 and have completed one year of service were eligible to participate in the Plan. Participation for employees whose positions are classified in these pay grades was effective on January 1 or July 1 after one year of service was completed. A year of service is defined as 1,000 hours of service during the 12-consecutive-month period beginning on the employee's date of hire. Effective January 1, 2024, employees in positions classified by the Society in pay grades as GS, S, or U-700 to U-799 who have attained the age of 21 and have completed one hour of service are eligible to participate in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Society is the sponsor of the Plan. Empower Trust Company, LLC functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

#### **Contributions**

The Plan provides for employee salary 401(k) contributions, on a pretax and/or Roth basis, up to a maximum of 50 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Eligible employees who do not elect otherwise are automatically enrolled in the Plan with a deferral contribution rate of 6 percent. Employees who do not elect otherwise will have their deferral contribution rate increased by 1 percent on March 1 of each year, and the participant's deferral contribution rate will not be increased to an amount that exceeds 10 percent of the participant's compensation. No increase shall occur if the participant affirmatively elects at any time not to be subject to the 1 percent increase provision of the Plan.

The Plan provides for employer matching contributions of 50 percent up to 6 percent of the participant's deferral contributions, resulting in a maximum matching contribution of 3 percent of the participant's compensation up to maximum limitations established by the Internal Revenue Code. Regular full-time and part-time participants who have completed one year of service will be eligible to receive employer matching contributions. Employer match participation is effective on the first day of the next quarter following the date when the one-year eligibility requirement is satisfied. Employees classified as G, S, or U-700 to U-799 are also eligible to receive employer matching contributions after completing one year of service, but the effective date is January 1 or July 1 following the date when the one-year eligibility requirement is satisfied.

The Plan also provides for employer discretionary nonelective contributions for all participants who have completed one year of service and per the entry dates above. No employer discretionary nonelective contributions were made in 2024.

### Note 1 - Plan Description (Continued)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Society's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Regular full-time and part-time participants are immediately vested in their contributions, employer match contributions, and employer discretionary contributions, plus actual earnings thereon, and are not subject to forfeiture for any reason.

Participant contributions of employees whose positions are classified in pay grades as GS, S, or U-700 to U-799 are fully vested at all times and are not subject to forfeiture for any reason. The employer match contributions and employer discretionary contributions for employees who are classified as GS, S, or U-700 to U-799 vest according to the following schedule:

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount or installment payments equal to the vested balance of a participant's account. Account balances of less than \$7,000 are paid in a single lump sum after the one-year anniversary of the participant's severance from employment or death, unless an earlier distribution is requested.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Empower Trust Company, LLC or its affiliates. Empower Trust Company, LLC is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### Note 1 - Plan Description (Continued)

#### ***Termination***

While it has not expressed any intent to do so, the Society has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net realized and unrealized losses on investments include gains and losses on investments bought and sold, as well as held, during the year. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Society.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 20, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Empower Trust Company, LLC (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### **Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### **Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### **Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### **Mutual Funds**

Mutual funds are valued at closing quoted prices reported in active markets.

#### **Common Collective Trust Fund**

The Putnam Stable Value Fund is a common collective trust fund and is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets and liabilities of the trust. There are no redemption restrictions or unfunded commitments related to this investment.
