### **1. Plan Description**

The following description of the Milrose Consultants, LLC 401(k)/Profit Sharing Plan (the "Plan") is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Milrose Consultants, LLC (the "Company" or "Employer") except members of a collective bargaining agreement and non-resident aliens. The Plan was adopted January 1, 2006 and restated on July 25, 2022, qualifies under Section 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective January 1, 2024, the Plan merged in the JM Zoning LLC 401(k) Plan. As a result of this merger \$3,752,688 of assets were transferred into the Plan.

#### ***Eligibility***

Employees of the Company are eligible to participate in the Plan on their hire date. Employees are eligible to receive the Company's discretionary matching contribution, if any, in a given year, after completion of one year of service. Employees of the JM Zoning division are not eligible for Employer matching contributions and employees of the Howard L. Zimmerman division are not eligible for Employer discretionary contributions.

#### ***Contributions***

An employee participating in the Plan may annually contribute through payroll deductions on a pre-tax basis or after-tax (Roth) basis, up to the amount provided annually by the Internal Revenue Service and may contribute amounts representing distributions from other qualified plans. Any participant, age 50 or over, may make an additional "catch-up" contribution. The Company may elect to make a discretionary matching contribution equal to a uniform percentage or dollar amount of elective contributions. Each year, the Company will determine the formula for the discretionary matching contribution. The Company discretionary matching contributions totaled \$201,450 for the year ended December 31, 2024. The discretionary match was 100% of elective deferrals up to 4% of eligible compensation. The Company did not make discretionary matching contributions for the year ended December 31, 2023.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's discretionary matching contributions, if any, (b) Plan earnings and losses, and (c) charged with certain account maintenance and service fees. Allocations are based on participant earnings or account balances, as defined in the Plan document. The participant's account is reduced by withdrawals and losses on investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

A participant is 100% vested in their contributions, Employer matching contributions, Employer discretionary contributions and any earnings thereon.

#### ***Investment Options***

Upon enrollment in the Plan, participants may direct their elective contributions and Company contributions into various investment options offered by the Plan. Participants may change their investment options at any time. Investments are participant directed.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loans to participants are secured by the balance in the participant's account and bears an interest rate at prime plus one percent at the time the loan is made.

Loans must be repaid over a period not to exceed five years, except in the case of loans incurred for the purchase of a primary residence, which can be repaid over a period of up to twenty-five years. Principal and interest are paid ratably through payroll deductions. Only three loans may be outstanding to a borrower at any time.

If a participant fails to make a payment when a loan is due under the terms of the loan, that participant will be in default. In the event of default, the loan shall become due and payable immediately and interest will continue to accrue until the entire loan balance is repaid. The Plan will take all reasonable actions to collect the balance owed on the loan. Under certain circumstances, the loan in default could be considered a distribution from the Plan and could be considered income to the participant. In any event, failure to repay a loan will reduce the benefit a participant would otherwise be entitled to receive from the Plan.

#### ***Payment of Benefits***

On termination of service due to death, disability, termination or retirement, a participant or designated beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Hardship distributions are allowed under the Plan. In-service distributions are permitted for participants who have attained the age of 59½.

#### ***Forfeitures***

The non-vested portion of a participant's account is forfeited upon termination of employment. Forfeited amounts are retained by the Plan and will be used to offset administrative fees and future Company discretionary matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,742 and \$3,625. No forfeitures were used to reduce Company contributions or offset administrative fees in 2024 and 2023.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based on the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The common/collective trust is valued at the NAV per unit, as determined by the trustee at year end. The NAV is used as the practical expedient to estimate the fair value and is based on the fair value of the underlying investment held by the fund, less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Administrative Expenses***

Certain expenses of the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 22, 2025.

### **5. Common/Collective Trust**

The Plan invests in the MetLife Stable Value Fund (the "Fund") which is a collective investment trust that was formed for the purpose of allowing plan sponsors of defined contribution plans qualified under Sections 401(a) and 501(a) to the IRC, to invest in the MetLife Group Annuity Contract 25053 and certain other MetLife group annuity contracts. The contracts were issued by Metropolitan Life Insurance Company to Reliance Trust Company, who is the trustee of the Fund.

Units of the Fund are valued daily. Unit purchase and redemptions are transacted at the NAV determined as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values. As of December 31, 2024 and 2023, there were no unfunded commitments.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **7. Tax Status**

The Plan has adopted a volume submitter prototype plan document which received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **8. Exempt Party-In-Interest Transactions**

Principal Trust Company is the trustee and record-keeper for the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain administrative functions are performed by employees of the Company, which is a party-in-interest. No such employee receives compensation from the Plan.

Participants who are active employees of the Plan may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

### **9. Non-exempt Party-In-Interest Transactions**

During 2023, certain participants' contributions and loan payments totaling \$1,599 were remitted by the employer to the custodian later than required by Department of Labor Regulation 2510.3-102. The employer has corrected the delinquent contributions in 2024.

### **10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
