No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

The financial statement disclosures are neutral, consistent, and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor’s report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan’s financial statements. We identified no material inconsistencies in performing and completing our audit.

*Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in performing and completing our audit.

*Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There are no uncorrected misstatements.

*Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

During testing of the Plan's contributions, we noted the Plan incorrectly deducted from a participant's payroll for ROTH contributions. The participant did not elect ROTH contributions.

*Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

*Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

*Other Matters*

With respect to the ERISA-required supplemental schedule accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedule to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

This information is intended solely for the use of Plan administrator and those responsible for Plan governance and is not intended to be, and should not be, used by anyone other than these specified parties.

The SAG-AFTRA 401(k) Retirement Plan (the “Plan”) is a defined contribution plan established effective May 5, 1985 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees of the Plan’s sponsor, SAG-AFTRA (the “Union”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Officers and employees of the Union serve as the Plan’s administrator. The specific provisions of the Plan are contained in the Plan document, which governs the legal operations of the Plan.

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**B. Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**C. Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The following tables summarize the Plan’s investments based on the inputs used to value them:

Level 1 investments consist of mutual funds valued at their quoted market prices. Purchases and sales of investments are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis.

**D. Risks and Uncertainties**

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the financial statements. The Plan's exposure to the credit loss in the event of nonperformance of investments is limited to the carrying value of investments.

**E. Eligibility**

Employees of the Union are eligible to participate in the Plan upon reaching the age of 18 and three months of service.

**F. Contributions and Vesting**

Participants may contribute to the Plan through salary deductions of 1% to 70% of eligible compensation, as defined in the Plan, up to the statutory maximum as determined by the Internal Revenue Code ("Code"). Eligible participants are automatically enrolled into the Plan at a contribution rate of 4%. Effective April 22, 2024, the Plan will automatically increase participant's contributing rate by 1% annually, not to exceed 7%. Catch up contributions are allowed. Participants' rights to voluntary contributions, rollover contributions and earnings thereon are 100% vested immediately upon contribution.

The Union may make matching contributions at its discretion only for eligible employees who worked 1 hour or more during the plan year. For 2024, the Union made matching contributions equal to 200% of SAG-AFTRA legacy participants' deferrals of up to 2% of their eligible compensation. Participants' rights to matching contributions are 100% vested immediately upon contribution.

**G. Notes Receivable from Participants**

At the discretion of the plan administrator, a participant may borrow up to the lesser of 50% of his or her vested account balance or \$50,000. The minimum loan is \$1,000. The term of the loan may not exceed five years, except it may be fifteen years when loan proceeds are used to purchase the participant's principal residence. Loans bear interest at a reasonable rate, commensurate with rates charged by commercial lenders under similar circumstances.

**H. Distributions and Withdrawals**

Each participant's share of the net assets of the Plan is allocated to an individual account. Vested benefits are payable upon termination, death or retirement. Additionally, a participant may withdraw vested amounts from his or her account prior to termination of employment with the Union after age 59½, or prior to that age for financial hardship (as defined in the Plan).

**I. Retirement Age**

Normal retirement age is 65. The Plan allows early retirement at the later of age 55 or completion of 5 years of service.

**J. Administrative Expenses**

Administrative fees are paid by the Plan; all other Plan expenses are paid by the Union. During 2024, the Plan received \$78,372 in investment performance-based fee reimbursements by Fidelity Management Trust Company, offsetting \$63,621 in administrative fees.

**K. Forfeitures**

Forfeitures of terminated participants' non-vested accounts may first be used to pay for administrative costs. Any remaining forfeitures are used to reduce Employer matching contributions. During 2024, \$173 of forfeitures were used to offset Employer matching contributions. There were no unused forfeitures remaining at December 31, 2024.

**NOTE 2 - INCOME TAX STATUS**

The Plan is a volume-submitter plan that has received an opinion letter from the Internal Revenue Service stating the form of the Plan, if properly adopted by the Union, could be exempt from federal income taxes under the Code. Management believes that the Plan is operating in accordance with regulations for plans exempt from income taxes and that the Plan is exempt from taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 3 - INVESTMENT FUNDS**

All amounts in each participant's account are invested and reinvested as elected by participants from among the investment funds made available by the Plan's investment committee. Participants may change how their accounts are allocated daily.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Union has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and net assets would be distributed based upon the participants' account balances at that time.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS**

Payments of direct and indirect administrative and investment manager fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 7 - PLAN AMENDMENT**

Effective April 22, 2024, the Plan was amended to automatically increase eligible participant deferral by 1% annually, up to a maximum of 7%.

**NOTE 8 - SUBSEQUENT EVENTS**

Effective June 23, 2025, the Plan was amended to expand provisions for in-plan roth conversions and roth contributions.

Management has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued. Except as noted above, there were no other material subsequent events that required recognition or additional disclosures in these financial statements.
