NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of Plan And Basis Of Presentation

The following description of the JVA, Inc. Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of JVA, Inc. (the Company) who have completed 1,000 hours of service or 3 months of service, whichever is earlier, and have attained age 21. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (the Code), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (formerly Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC, respectively) serves as the trustee, manages Plan assets and maintains the Plan's records. Empower Annuity Insurance Company of America and Empower Trust Company, LLC will be collectively referred to as Empower.

Contributions

Each year, participants may contribute between 1% and 100% of eligible compensation (as defined in the Plan Agreement), as Roth contributions, pre-tax contributions or a combination thereof, subject to certain Internal Revenue Service (the IRS) limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are immediately eligible for Company matching contributions, which are made at the discretion of the Company and are equal to a uniform percentage or dollar amount of a participant's elective deferrals each payroll period. During the year ended December 31, 2024, the Company matched the lesser of 40% of deferrals not exceeding 6% of eligible compensation or 2.4% of eligible compensation. The Company, at its discretion, may also make nonelective contributions in addition to the matching contributions outlined above. Participants who complete 1,000 hours of service or 3 months of service, whichever is earlier, during the Plan year are eligible to share in the nonelective contributions. There were no nonelective contributions made during the year ended December 31, 2024.

Notes To Financial Statements (*Continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions and allocations of Company nonelective contributions, Plan earnings or losses, forfeitures and Plan expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the vested portion of the participant's account.

Investment Options

The Plan offers participants a variety of investment options through various mutual funds, a common/collective trust fund and a guaranteed investment contract. A participant may direct contributions to any of the investment options provided by the Plan. Participants may change their investment elections or future contributions at any time during the year.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to 50% of the value of their vested account balance, or \$50,000, whichever is less. Note receivable terms range up to five years. The notes receivable are secured by no more than 50% of the vested balance in the participant's account and bear interest at the Prime Rate plus 1% at the time the note receivable originated. Principal and interest are paid in equal installments through payroll deductions, personal checks from employees on leave or cashier's checks for the full payoff of the notes receivable. Participants may have one loan outstanding at a time.

Benefit Payments

Upon termination of employment, retirement, disability or death, a participant, or their beneficiary in the instance of death, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. The Plan allows in-service distributions and partial distributions of vested account balances to participants age 59½ or older. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement account.

Active participants who experience a qualifying financial hardship may withdraw all or part of their vested accounts. Hardship withdrawals will be approved only if they conform to the Plan and established IRS safe harbor provisions.

Notes To Financial Statements (*Continued*)

Vesting

Participants are immediately vested in their voluntary salary deferral contributions, Company matching contributions, rollover contributions and any income or loss thereon.

The Company's discretionary contributions, if any, vest according to the following schedule:

<u>Years Of Service</u>	<u>Vested Percentage</u>
Less than three years	0%
Three years or more	100%

A participant's account becomes 100% vested upon death or disability while an employee or attaining normal retirement age (age 65).

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are placed in a separate account and can be used as an additional discretionary nonelective contribution, an additional discretionary matching contribution or to pay Plan expenses. There were no forfeitures available on December 31, 2024 and 2023, and no forfeitures were used during the year ended December 31, 2024.

Administrative Expenses

Each participant pays administrative expenses based ratably on the size of the participant's account balance or expenses may be charged equally to each participant. In addition, some expenses are only charged to participants based on their use of a Plan feature or receipt of a distribution. Administrative expenses may be paid by the Company, or by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value of investments.

The Plan has an expense account which accumulates a balance through fee reduction agreements with Empower and interest allocations. The account may be used to pay certain Plan expenses at the discretion of the Plan Administrator. As of December 31, 2024 and 2023, the Plan expense account had a balance of \$5,316 and \$4,000, respectively, and is reported as cash on the statement of net assets available for benefits.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan's investments, other than the fully benefit-responsive investment contract, are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Key Guaranteed Portfolio Fund is a fully benefit-responsive investment contract and is reported at contract value on the statement of net assets available for benefits.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation represents the difference between an investment's aggregate fair value at year end and its value at the beginning of the year, and includes any realized gains and losses in shares that were bought and sold during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

The Company has concluded that no allowance for credit losses was necessary at December 31, 2024 or 2023.

Payment Of Benefits

Benefit payments are recorded when paid.

Reclassifications

Certain prior-year amounts have been reclassified for consistency with the current year's presentation. These reclassifications had no effect on the previously reported change in net assets available for benefits.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants as of December 31, 2024 and 2023, and investment income and interest income on notes receivables from participants for the year ended December 31, 2024, disclosed in the accompanying financial statements and supplemental schedule of assets held at end of year, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower. This information has not been audited by the Plan's independent auditor.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds

Assets are valued at the daily closing price as reported by the funds. Mutual funds are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (the NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

Common/Collective Trust

These are valued at the unit value or the NAV of the shares held by the Plan at year end. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities, divided by the number of shares outstanding. The common/collective trust held by the Plan is not required to be reported in the fair value hierarchy. The common/collective trust held by the Plan files an annual report on Form 5500 as a direct filing entity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Guaranteed Investment Contract With Insurance Company

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest-crediting rate is based on the earnings of the underlying assets in the entire medium-long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest-crediting rate is reset quarterly and may not be set below 0.00%. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. For the years ended December 31, 2024 and 2023, the crediting interest rate was 1.41% and 1.23%, respectively.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan Agreement (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan sponsor does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

6. Party In Interest Transactions

The Plan invests in a guaranteed investment contract and mutual funds issued and managed by Empower. Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These are considered to be allowable party in interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Income Tax Status

The Plan uses a pre-approved defined contribution plan sponsored by Empower. Empower has received its latest opinion letter on June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
