Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the PDR 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of the PDR 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Planning Design Research Corporation (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on January 1, 1998, and has been amended and restated. The Company serves as the plan administrator and among other things, is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Ascensus Trust Company, LLC serves as the Plan's trustee. Prior to April 18, 2024, Newport Trust Company, LLC served as the Plan's trustee.

Eligibility

The Plan is provided for all eligible employees of the Company who have completed six consecutive months of service and are age 21 or older. If an employee does not complete six consecutive months of service, he/she will be eligible upon completion of one year of service, defined as a 12-month period with at least 1,000 hours of service. Participants may enter the Plan on the first day of the month coinciding with or next following the satisfaction of the eligibility requirements. Prior to April 22, 2024, participants could enter the Plan on the first day of the month next following the satisfaction of the eligibility requirements. The Plan includes a savings feature designed to permit the employee and the Company to contribute to the Plan, as allowable under Section 401(k) of the Internal Revenue Code (IRC).

Contributions

Employees may elect to defer up to 100% of their compensation, as defined, as either pre-tax or Roth 401(k) deferrals, subject to amounts allowed under the IRC. Eligible employees who have attained age 50 before the end of the plan year are eligible to make catch-up contributions subject to limitations of the IRC. Rollover contributions are permitted from qualified retirement plans and certain individual retirement accounts.

Employees automatically begin deferring 3% of their compensation for each payroll period after meeting the eligibility requirements, unless an affirmative election not to contribute or to contribute at a different percentage is made by the employee. The contributions are made on a pre-tax basis unless the employee affirmatively designates that any portion or all the contributions be treated as Roth contributions.

The Company makes safe harbor non-elective contributions equal to 3% of each eligible participant's compensation, as defined.

The Company may also elect to make discretionary non-elective profit-sharing contributions to eligible participants who are employed on the last date of the plan year. The contribution is equal to a discretionary percentage of compensation as determined by class where each participant is in a separate class. For the year ended December 31, 2024, the Company elected not to make discretionary non-elective profit-sharing contributions.

Vesting

Participants are immediately vested in their contributions, including rollovers, plus actual earnings thereon. Additionally, participants are 100% vested in safe harbor non-elective contributions made by the Company plus actual earnings thereon. A participant's interest in the discretionary non-elective profit-sharing contributions made by the Company begins vesting at 25% after one year of service, increasing 25% each year thereafter, with the participant 100% vested after four years. Regardless of the vesting schedule, participants become fully vested upon reaching normal retirement age, as defined, or death, or total and permanent disability.

Forfeitures

Forfeitures attributable to non-vested employer contributions may be used to pay administrative expenses and/or reduce future employer contributions. There were \$3,347 and \$119 of unallocated forfeitures available at December 31, 2024 and 2023, respectively. During 2024, \$119 of forfeitures were used to reduce employer contributions. No forfeitures were used to pay administrative expenses.

Participant Accounts

Upon enrollment in the Plan, a participant may direct the investment of his or her account balance. Participants may change their investment options at any time.

Under the Plan, each participant's account is credited with the participant's contribution, the Company's safe harbor non-elective contribution, an allocation of any discretionary non-elective profit-sharing contribution, as applicable, and plan earnings and losses, and charged with certain transactional fees.

Notes Receivables from Participants

Notes receivable from participants are loans to participants secured by the vested portion of their respective accounts. Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance reduced by the highest loan balance outstanding during the prior one-year period. A participant may not have more than one loan outstanding at any time. Interest rates are based on the prime rate on the second business day of the month the loan is issued plus 2%. Principal and interest are repaid ratably through payroll deductions. Loans are required to be repaid within five years from the date of issuance, except in the case of certain loans to acquire a principal residence, in which case the loan must be repaid within a reasonable period of time as determined by the plan administrator. There were no notes receivables from participants as of December 31, 2024 or 2023 nor were there any new loans taken by participants during the 2024 plan year.

Benefit Payments

Distributions may be made to participants or their beneficiaries upon termination of employment, retirement, disability or death, as applicable. In-service distributions are permitted for participants who have reached the age of 59½ or normal retirement age, as defined, as well as for other permitted reasons. For participants who terminate with an account balance of \$7,000 or less, the plan administrator makes a direct rollover into an individual retirement account. For participants who terminate with an account balance of more than \$7,000, the plan administrator must obtain written consent from the participant prior to processing a distribution. Withdrawals from the Plan may be subject to income taxes on contributions and income earned.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments sold during the year, as well as unrealized gains or losses on investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. In general, notes receivable from participants are considered to be in default at the end of the calendar quarter following the quarter in which payment is not received by the Plan. Defaulted notes receivable are treated as distributions based upon the terms of the plan document when a distributable event has occurred.

Benefit Payments

Benefits paid to participants or beneficiaries are recorded when paid.

Administrative Expenses

Loan fees and certain transactional charges are paid by the participants. All other administrative costs are paid by the Plan unless paid by the Company, at its discretion.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by the Plan's Trustees

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Ascensus, LLC, as an authorized representative of Ascensus Trust Company, as of December 31, 2024 and for the period from April 18, 2024 through December 31, 2024 and from Newport Trust Company, LLC as of December 31, 2023 and for the period from January 1, 2024 through April 17, 2024, that all of the information provided is complete and accurate. Information included in the accompanying financial statements and the notes to the financial statements as to cash, investments, investment income and all the related information in the supplemental schedule of assets (held at end of year) is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements, and the supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: These funds are valued on a daily basis at their quoted market prices.

Common/Collective Trust Fund: This investment is valued by the issuer at its net asset value (NAV) based upon the quoted market prices of the underlying investments, when available. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 6 - Tax Status

The pre-approved plan document adopted by the plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the pre-approved plan document was in compliance with the applicable requirements of the IRC. The pre-approved plan document has been amended since receiving its IRS letter; however, the plan administrator, through its adoption of the pre-approved plan document, believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Nonexempt Party-in-Interest Transactions

As disclosed in the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, there were unintentional delays in remitting \$65,611 of participant contributions and \$327 of participant loan repayments to the Plan within the timeframe specified by the DOL's Regulation 29 CFR 2510.3-102. Of these amounts, \$30,694 of participant contributions relate to the 2023 plan year, \$34,250 of participant contributions and \$327 of participant loan repayments relate to the 2022 plan year and \$667 of participant contributions relate to the 2021 plan year. The participant contributions and the participant loan repayments for all years were remitted to the Plan prior to December 31, 2023. During 2024, management remitted \$47 of lost earnings relating to \$34,917 of employee contributions and \$327 of loan repayments. Management is in the process of calculating lost earnings on the remaining \$30,694 of late remittances which relate to the 2023 plan year.
