INDEPENDENT AUDITOR'S REPORT

To the Investment Committee of the BioIntelliSense, Inc. 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the BioIntelliSense, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to the Financial Statements

December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following description of the BioIntelliSense Inc. (the Company) 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. *General*

The Plan is a defined contribution plan covering all U.S. employees of BioIntelliSense, Inc. The Plan excludes nonresident aliens. Participants may participate in the Plan on the first day of the month following their employment. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Executive Management is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Executive Management.

The Plan was amended effective March 10, 2023, to revise the eligibility requirements for all contribution types offered by the Plan. Prior to the amendment, participants were eligible to participate in the plan immediately after completing one month of service. As a result of the amendment, all new employees are eligible on the first day of the month following their employment.

2. *Participants' Contributions*

Each year, participants may contribute up to 92 percent of pre-tax and post-tax annual compensation, as defined in the Plan, subject to the maximum elective deferral amount of \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Salary deferral contributions can be changed or stopped at any time. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferred rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Enrolled participants with deferral rates less than 6 percent will have their deferral rate automatically increased by 1 percent each Plan year up to 6 percent of compensation unless they affirmatively elect not to participate in the auto escalate feature. For employees that are automatically enrolled in the Plan after July 1, the automatic deferral increase will skip the deferral increase on January 1 of the following year. The Plan currently offers various mutual and money market funds as investment options for participants. Employee contributions are subject to certain Internal Revenue Service (IRS) limitations.

3. *Employer Contributions*

The Company contributes a safe harbor non-elective contribution equal to 3 percent of compensation for all eligible participants in the plan. Additional discretionary non-elective profit sharing contributions equal to a percentage determined by the Company may also be made with approval by the Company's Executive Management. The Company did not make any discretionary non-elective profit sharing contributions to the Plan during 2024. Participants direct the Company contributions into various investment options offered by the Plan. Employer contributions are subject to certain IRS limitations.

4. *Participant Accounts*

Each participant's account is credited with the participant's contributions and Company safe harbor non-elective contributions, as well as allocations of other Company contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. *Vesting*

Participants are vested immediately in their contributions, safe harbor non-elective contributions, and discretionary non-elective profit sharing contributions by the employer plus actual earnings thereon.

6. *Unallocated Assets and Forfeited Accounts*

At December 31, 2024 and 2023, unallocated accounts made up of uncashed checks totaled \$1,076 and \$532, respectively. These funds can be claimed at any time by the participant, at which point a check will be re-issued.

At December 31, 2024 and 2023, unallocated forfeited accounts totaled \$0. These assets can be used to reduce future employer contributions and/or to pay for Plan administrative expenses. In 2024, no administrative expenses were paid from unallocated forfeiture accounts and no unallocated forfeiture accounts were used to reduce employer contributions.

7. *Notes Receivable From Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may have up to two outstanding loans at any given time. Loans are required to be repaid within five years, except for the purchase of a primary residence, which may be repaid over a ten-year period. The loans are secured by the vested balance in the participant's account. The loan interest rate is determined at the date the loan is made and is set at the prime rate plus one percent. Principal and interest are paid ratably through semimonthly payroll deductions.

8. *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal any portion of the participant's vested interest in his or her account or roll over the account balance to an IRA or to another qualified retirement plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or roll over the account balance to an IRA or to another qualified retirement plan. Accounts for terminated participants with balances in excess of \$5,000 are maintained in the Plan until the participant requests a distribution. As of December 31, 2024 and 2023, no amounts were required to be allocated to accounts of persons who had elected to withdraw from the Plan, but had not yet been paid. In-service withdrawals are permitted upon the attainment of age 59 ½, disability, or if called to active duty as a qualified reservist. In addition, hardship distributions are permitted at a minimum of \$500 if certain criteria are met.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. *Use of Estimates*

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies by utilizing information provided by the investment advisor and trustee. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Contributions*

Contributions from plan participants and safe harbor non-elective contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

5. *Notes Receivable From Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for current expected credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

6. *Payment of Benefits*

Benefits are recorded when paid.

7. *Administrative Expense*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

8. *Contributions Receivable and Current Expected Credit Losses*

Historical write-off rates continue to be the basis for the Company's allowance for current expected credit losses. To calculate the reserve, the Company considered the processes surrounding the contributions receivable since the inception of the Plan. The Company has not historically written off the contributions receivables that were accrued at Plan year-end. The Company expects business conditions for the Plan calendar year ended December 31, 2025, the collection period for the contributions receivables, to remain consistent with current conditions. As a result, the Company has recorded expected credit losses of \$0 as of December 31, 2024 and 2023.

9. *Subsequent Events*

Plan management has evaluated subsequent events from the statement of net assets available for benefits date through September 12, 2025, the date the financial statements were available to be issued. There were no material events noted in the subsequent period that would have impacted results reported herein or require disclosure.

NOTE D – PARTY IN INTEREST TRANSACTIONS

Certain plan investments are managed by Fidelity Investments Institutional Operations Company, LLC (Fidelity). Fidelity is the Plan's record keeper for the plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan to Fidelity amounted to \$19,372 for the year ended December 31, 2024.

Certain plan investment advisory and other services are provided by Strategic Advisors, Inc. Strategic Advisors, Inc. is the Plan's investment advisor and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan to Strategic Advisors, Inc. amounted to \$902 for the year ended December 31, 2024.

NOTE E – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

NOTE F – TAX STATUS

The IRS has determined and informed the Plan by an advisory opinion letter dated June 30, 2020, that the volume submitter plan adopted by the Plan sponsor, for the Plan and related trust is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since that date and has not received an advisory opinion specific to the Plan itself, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Thus, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Federal and State of Colorado taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
