Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the exp U.S. Services, Inc. Profit Sharing and 401(k) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

exp U.S. SERVICES, INC. PROFIT SHARING AND 401(k) PLAN**NOTES TO THE FINANCIAL STATEMENTS****NOTE 1 – DESCRIPTION OF PLAN**

The following description of exp U.S. Services, Inc. Profit Sharing and 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

General. The Plan is a defined contribution plan established on November 1, 1967 and is administered by exp U.S. Services, Inc. The Plan covers all employees of exp U.S. Services, Inc. and its wholly-owned subsidiaries, EXP Federal, Inc. and EXP Energy Services, Inc. (collectively, the “Employer”). The assets of the Plan are managed and administered under the terms of an agreement between the Employer and Fidelity Management Trust Company (the “Custodian”). The Custodian is responsible for the investment of such assets and the accounting for all related receipts and disbursements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Concentration of Credit Risk. Substantially all the Plan’s assets are held by the Custodian which is qualified institution pursuant to ERISA.

Eligibility. Employees are eligible to contribute to the Plan beginning upon one month of service and upon reaching age 21. A participant is eligible for an Employer match on their elective deferrals immediately, however, one year of service is required to be eligible for any profit-sharing contributions.

Contributions. The Plan is funded through participant contributions, as well as Employer matching and profit-sharing contributions. Participants may contribute up to 60% of their eligible compensation subject to Internal Revenue Service (“IRS”) limits (excluding any catch-up contributions). The Plan provides for a discretionary Employer matching contribution and discretionary profit-sharing contribution, determined annually by the Employer. Total annual Employer and participant contributions are limited to 100% of participant’s eligible compensation subject to IRS limits. The Plan matches on a per period basis.

The Plan accepts rollovers and transfers in accordance with certain rules. Rollover contributions consist of contributions from other employers’ plans that participants have elected to include with the Plan.

The Plan includes an auto-enrollment provision whereby employees are auto-enrolled in the Plan upon meeting the eligibility requirements at a contribution deferral rate of 4% unless they affirmatively elect not to participate.

Vesting. Participants are immediately fully vested in their rollover contributions, after-tax contributions, regular contributions and any earnings thereon. Employer profit-sharing contributions and earnings vest 20% after 2 years of service and 20% per year after that until fully vested. Employer matching contributions and earnings vest 25% after 2 years of service and 25% per year after that until fully vested. In the event of death, permanent disability, or retirement, a participant’s account becomes fully vested.

Participant Accounts. Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, allocations of the Employer’s contribution and Plan earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants may direct allocations into various available investment funds in 1% increments. Participants have the opportunity to change their investment mix weekly and their contribution election weekly. The net investment gain or loss for each of the investment funds is allocated to each participant’s elective deferral, discretionary, and safe harbor accounts in the proportion to which each such account bears to the total of all such fund accounts.

Investment Options. Participants may direct the investment of all their contributions among the various investment funds provided by the Plan consisting of various registered investment entities. Participants may change their investment election for existing participant balances and current contributions weekly.

NOTE 1 – DESCRIPTION OF PLAN (Concluded)

Forfeited Accounts. Forfeitures arising upon termination of a participant's employment are used to either pay for Plan expenses or to reduce the Employer's contributions for the Plan year. If a terminated participant returns to employment within five years, the amount previously forfeited will be reinstated, as defined in the Plan documents. Forfeitures of approximately \$105,000 were used to reduce employer matching contributions during the year ended December 31, 2024. Forfeiture balance was approximately \$70,000 and \$14,000 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants. The Plan provides that a participant may borrow from their vested account balance. Outstanding loans may not exceed the lesser of 50% of the participant's vested balance or \$50,000. This \$50,000 maximum is further reduced by the participant's largest outstanding loan balance during the prior twelve-month period. The loans are secured by the balance in the participant's account. Interest due on the outstanding balances of all other participant loans is calculated on a daily basis at an interest rate deemed reasonable by the Plan's administrator ("Plan Administrator") at the date of issuance. Loan terms may not exceed 5 years unless the loan is for the purchase of a primary residence.

Payment of Benefits. On termination of services, a participant may elect to receive either a lump-sum amount equal to the vested balance of their accounts or other optional forms of distribution available under the Plan. Terminated participants with a balance of less than \$1,000 must take a lump-sum cash distribution. Benefit payments are generally made immediately following the participant's request for benefit distribution.

Party-In-Interest. All Plan investments are shares of mutual funds managed by a related party to the Custodian of the Plan. These transactions are allowable party-in-interest transactions under ERISA and the regulations promulgated thereunder.

Administrative Expenses. Certain administrative expenses, including functions performed by officers or employees of the Employer, are provided by the Employer at no charge to the Plan. The Employer has no intention to seek reimbursement for any such costs.

Recent Legislation. The SECURE Act 2.0 was signed into law on December 23, 2022. The SECURE Act 2.0 allows more part-time workers to participate, increases the age for required minimum distributions and reduces the penalty for missed minimum distributions, permits plan participants to elect to receive vested employer contributions on an after-tax basis, and allows penalty free withdrawal for terminal illness, effective January 1, 2023. Additionally, it will allow for higher catch-up contributions, allow for matching contributions on student loan payments, permit plan sponsors to add an emergency savings account to their retirement plans, increase the availability of penalty-free withdrawals, and add automatic enrollment error relief provisions, effective January 1, 2024. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the accrual method of accounting.

Estimates and Assumptions. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Concluded). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments. Benefits are recorded when paid.

NOTE 3 – INFORMATION CERTIFIED BY THE CUSTODIAN

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that was prepared by the Custodian, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Custodian that such information is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net depreciation in fair value of investments and dividend and interest income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Note 4: All investment balances.
- Supplemental Schedule: All investment balances included in this schedule.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820") establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1. Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2. Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs that are both unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

Mutual Funds. Valued at quoted market price.

Stable Value Collective Trust Fund. A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust ("NAV"). NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

While the Employer has not expressed any intent to discontinue its contributions or terminate the Plan, it is free to do so at any time, subject to the provisions of ERISA and the Plan agreement. In the event of Plan termination, all participants will automatically become fully vested in all their accounts and the Custodian will distribute participant assets.

NOTE 6 – INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Fidelity Management and Research Company. Fidelity Management and Research Company received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). This opinion letter was obtained in conjunction with the IRS restatement cycle requirements. The Plan itself has not received a determination letter from the IRS. However, the Plan’s administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan provides investing in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 8 – SUBSEQUENT EVENTS

Management has evaluated all known subsequent events from December 31, 2024 to September 17, 2025, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that have not been disclosed in the notes to the financial statements.
