Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit Section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the J.M. Murray Center, Inc. Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits to employees of J.M. Murray Center, Inc. d/b/a JM Murray (JM Murray) and Enterprise Service Technologies, Inc. (ESTI), a wholly owned subsidiary of JM Murray (collectively, the Organizations), who have completed one year of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organizations are the sponsors of the Plan. Lincoln Financial Group Trust Company, Inc. (Lincoln) is the custodian of the Plan.

Eligibility

Employees become eligible for the discretionary non-elective employer contribution feature as of the first day of the next calendar quarter after completing one year of eligible service. Employees must be employed with the Organizations as of the last day of the calendar quarter to receive that quarter's discretionary non-elective employer contribution.

Contributions

Participants may contribute a percentage of their annual compensation, as defined by the Plan, subject to maximum limitations established by the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Plan provides for auto-enrollment at 3% with an available opt-out feature. The auto enrollment escalates annually with a maximum of 10%.

The Organizations made discretionary contributions to the Plan of 4.5% and 5% of eligible compensation in 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Organizations' contributions, account earnings/losses and an administrative charge. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Each participant may invest employer contributions in one or more of the investment choices made available through the Plan. Each participant may change investment allocations at any time.

Vesting

Participants are immediately vested in their contributions to the Plan. Vesting in the Organizations' contributions plus earnings/losses thereon is based on a cliff vesting schedule. A participant is 100% vested after three years of credited service.

1. DESCRIPTION OF PLAN (Continued)

Payment of Benefits

Annual benefits may begin at the normal retirement date or an early retirement date. A participant who has attained their normal retirement date shall have 100% nonforfeitable right in the value of their account. The portion of the accumulated benefits attributable to the Organizations' contributions for an employee is forfeited if the employee discontinues employment before being vested. Upon termination of service, a participant or beneficiary may elect to receive an amount equal to the vested value of his or her account, in a lump sum or annual installments over a period of time, or a combination of both. Upon the death of a participant, the participant's nonforfeitable interest in the Plan shall be distributed to the participant's designated beneficiary.

Benefit payments from the Plan will be made in a lump sum distribution if the balance is less than \$7,000 and the participant does not direct the Plan otherwise.

Forfeitures

If a participant's employment is terminated, the nonvested portion of a participant's account balance will become subject to forfeiture. Forfeitures may first be applied to reduce the administrative expenses of the Plan and then to reduce the Organizations' contribution to the Plan. Forfeitures of approximately \$29,000 and \$45,000 were used in 2024 and 2023, respectively. Unused forfeitures were \$36,974 and \$55,139 at December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investments are participant directed.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan's underlying investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

Fair Value of Financial Instruments

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Contributions Receivable and Allowance for Credit Losses

The Plan records a receivable for contributions that are remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. As no significant improvements or deteriorations are expected in the future economic conditions, management has determined that no allowance for credit losses is necessary for the years ended December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Plan Administration Costs

The Organizations' pay certain administrative expenses of the Plan. Additionally, the participants are assessed an administrative charge that is determined by several factors, including the investment mix and total value of the participant's account. The total expenses incurred by the Plan in 2024 and 2023 were approximately \$30,500 and \$28,600, respectively.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

The measurement of the fair value of registered investment companies was based on quoted market prices. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

There were no changes in the valuation techniques during 2024 and 2023.

5. STABLE VALUE CONTRACT

The Plan is invested in a fully-benefit-responsive stable value contract with Lincoln Life & Annuity Company of New York and the fund is managed by Lincoln National Life Insurance Company (LNLIC). LNLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. These contracts are considered an annuity with guarantees backed by the full faith and credit of LNLIC.

Because the stable value contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The guaranteed income fund is presented on the face of the statement of net assets available for benefits at contract value which approximates fair value as there is no market value adjustment upon a discontinuance. Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative fees.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.0%. Such interest rates are reviewed on a semi-annual basis for resetting.

Generally, there are no events that could limit the ability of the Plan to transact at contract value. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. At December 31, 2024 and 2023, there are no unfunded commitments and investments are redeemed on a daily basis.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the trustees of the Plan have the right to terminate the plan at any time, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. All distributions would be made in accordance with any applicable requirements of ERISA and the Code.

7. TAX STATUS

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan and related trust were, at that time, designed in accordance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. PARTY-IN-INTEREST TRANSACTIONS

Lincoln is the custodian of the Plan. As such, transactions between Lincoln and the Plan qualify as party-in-interest transactions.

10. SUBSEQUENT EVENT

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.
