## INDEPENDENT AUDITOR'S REPORT

### Opinion

We have audited the accompanying financial statements of Mission Cancer + Blood 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Mission Cancer + Blood 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Mission Cancer + Blood, PLLC (Plan Sponsor or Employer), as the plan sponsor (as well as employees of all other participating employers who have adopted the plan) who are age twenty-one or older and who have completed 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan management made the decision to terminate the Plan in December 2024. Contributions to the Plan ceased effective December 31, 2024, and the process of transferring the Plan assets to the successor plan began in 2025. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the financial statements for the year ended December 31, 2024.

**Contributions**

Participants may contribute a portion of their annual compensation, as defined in the Plan, up to the maximum limitations imposed by the IRS. Participants may contribute on either a pretax or post-tax basis through Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The employer contributes a matching contribution of 50% of the first 6% of compensation that a participant contributes to the Plan. The employer also contributes a safe harbor profit sharing contribution equal to 3% of an employee's compensation for the plan year. Additional profit sharing contributions may be contributed at the option of the Plan sponsor and each participating employer.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible compensation with automatic increases, as defined in the Plan. Contributions are automatically invested in a designated fund until changed by the participant. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contributions and, (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions, employer's safe harbor contributions and employer's matching contributions plus actual earnings thereon. A participant is 100% vested in the employer's nondiscretionary contributions after six years of credited service.

**Investment Options**

Upon enrollment in the Plan, a participant may invest in funds held in mutual funds, pooled separate accounts, a common/collective trust and other investment products offered by the investment company of their choice. Participants may change their investment options daily.

On termination of service a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, or annual installments over specified times, not exceeding the life expectancy or joint life expectancy of the participant and/or the beneficiary. A participant whose vested account balance does not exceed \$5,000 on termination date will receive his or her vested account balance as a lump-sum distribution.

The Plan allows for hardship withdrawals to participants who meet an immediate and severe financial need and are limited to a participant's vested account balance.

**Forfeited Accounts**

The nonvested portion of a terminated participant's account balance will be forfeited and used to reduce the employer contribution or to pay Plan expenses. During the years ended December 31, 2024 and 2023, \$22,084 and \$49, respectively, from forfeited nonvested accounts were used to reduce employer contributions. At December 31, 2024 and 2023, there were no unallocated forfeiture balances.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

As a result of the decision to terminate the Plan, the Plan's financial statements were prepared using the liquidation basis of accounting for the year ended December 31, 2024. Under the liquidation basis of accounting, assets are stated at their estimated net realizable values, and liabilities are stated at their estimated settlement amounts. The Plan's financial statements for the year ended December 31, 2023 were prepared using the going concern basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds, pooled separate accounts and other investment contracts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not been paid at December 31, 2024 and 2023.

**Uncertain Tax Positions**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 3 INVESTMENTS**

The Plan's investments are held by various investment companies. The following schedule presents investments at December 31, 2024 and 2023.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023:

*Mutual funds*—Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts*—Pooled separate accounts invest primarily in domestic and international long-term bonds, domestic and international stocks, or single mutual funds. The fair value of the underlying bonds, stocks, or mutual funds is a publicly quoted pricing input used in determining the net asset value (NAV) of the pooled separate accounts, which is not publicly quoted but is available to current investors when plan participants access their account values via the custodian's website. Pooled separate accounts are deemed to have readily determinable fair values which are calculated on a daily basis and are actively traded within the Plan.

*Self-directed brokerage accounts*—Self-directed brokerage accounts consist of mutual funds, exchange traded funds, corporate bonds, pooled separate accounts and common and preferred stocks that are valued on the basis of readily determinable market prices, and interest-bearing cash.

*Common/collective trust fund*—The common/collective trust fund may invest in various types of investments and is valued at the net asset value of the units of the issuer's collective trust. While not publicly quoted, the net asset value is considered to have a readily determinable fair value.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

**Transfers between Levels**

For years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

**NOTE 5 PLAN TERMINATION**

Effective December 31, 2024, the Plan administrator elected to terminate the Plan. All Plan assets are scheduled to be transferred to the successor Plan in 2025. Upon the termination date, all participants were 100% vested in their accounts.

**NOTE 6 TAX STATUS**

The Plan uses a prototype plan document sponsored by Nyemaster, Goode, West, Hansell & O'Brien, PC (Nyemaster). Nyemaster received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter. Although the plan has been amended since receiving the opinion letter, the prototype sponsor and the Plan's management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

**NOTE 7 ADMINISTRATION OF PLAN ASSETS**

Certain administrative functions are performed by officers or employees of the plan sponsor. The amount of such expenses and cost of such services have not been determined. No such officer or employee receives compensation from the Plan. Other administrative expenses are paid directly by the plan sponsor and include audit fees.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants invest their account balances in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are managed by Principal Life Insurance Company (Principal). Principal is the custodian of the non-brokerage account investments as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Employees of the Plan's trustees and the Plan administrator participate in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**NOTE 10 SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 22, 2025, the date which the financial statements were available to be issued. In April 2025 a majority of the Plan assets were transferred to a successor Plan. There were no other subsequent events required to be accrued or disclosed.
