### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

Notes to the Financial Statements

December 31, 2024 and 2023

(1) Description of plan

The following description of the Colonial Chemical, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all employees of Colonial Chemical, Inc. (the "Plan Sponsor") who have completed at least three months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Participants may make pre-tax contributions and Roth after-tax contributions to the Plan up to the annual statutory limits. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, participants who are age 50 or older by the end of the calendar year, may make catch up contributions. Catch up contributions cannot exceed the catch up limit in effect for the year. Participants direct the investments of their contributions into various investment options offered by the Plan.

The Plan Sponsor may make discretionary matching contributions subject to change annually. The Plan Sponsor made matching contributions equal to 100% of the first 3% of compensation that a participant contributed to the Plan for the year ended December 31, 2024. The Plan Sponsor may also make discretionary profit sharing contributions to the Plan. No profit sharing contributions were made to the Plan during the year. Plan Sponsor contributions may not exceed the maximum amount allowable for federal income tax purposes.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions and allocations of the Plan Sponsor's contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts is based on years of continuous service. A participant vests 20% per year and is 100% vested after five years of credited service. A Participant will also become fully vested in their entire account in the event death, total and permanent disability, or attainment of age 55 with 10 years of completed service.

Notes to the Financial Statements

December 31, 2024 and 2023

(e) Payment of benefits

On termination of service, a participant may elect to receive his or her vested account in a single lump-sum payment or partial withdrawals.

(f) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and may be subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures can be used to reduce the Plan Sponsor's contributions to the Plan or to pay plan expenses. Unallocated forfeitures totaled \$22,578 and \$18,717 at December 31, 2024 and 2023, respectively. No forfeitures were utilized during 2024.

(h) Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates ranging from 3.25% to 8.50%. Principal and interest is collected ratably through payroll deductions.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees incurred by the Plan for investment management services or recordkeeping are included in administrative expenses.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

December 31, 2024 and 2023

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles. The modified cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the Department of Labor. Income on investments is recorded on an accrual basis and investments are recorded at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as stated below. All other transactions are recorded on a cash basis.

(b) Investment valuation and income recognition

Investments are stated at fair value, except for the benefit-responsive investment contract, which is reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as it is received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and related disclosures. Actual results could differ from those estimates.

(e) Events occurring after reporting date

Plan management has evaluated events and transactions that occurred between December 31, 2024, and September 30, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

December 31, 2024 and 2023

(3) Certified information

Certain information reported and disclosed in the accompanying financial statements and supplemental schedule, including the fair value and contract value of investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Standard Insurance Company ("Standard").

(4) Fair value measurements

Fair value is defined as the price that would be received upon sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Pooled separate accounts*: Valued at net asset value (NAV), which is based on the market value of the underlying investments held by the pooled separate account at year-end. The net asset value is not a publicly-quoted price in an active market but has a readily determinable fair value. Each pooled separate account provides for daily redemptions by the Plan at reported net asset values per share with no advance notice requirement.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Investment contract with insurance company**

The Plan holds a fully benefit-responsive investment contract with an insurance company, Standard, with a value of \$836,362 and \$766,483 as of December 31, 2024 and 2023, respectively. The insurance company maintains the Plan's contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Notes to the Financial Statements

December 31, 2024 and 2023

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of the contract, (2) spin-offs, (3) divestitures, (4) layoffs, (5) corporate relocation, (6) partial or total Plan termination, (7) retirement incentive programs, and (8) the liberalization of Plan withdrawal or transfer rules.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) failure to abide by state or federal law, (2) failure to render performance necessary to comply with the terms of the contract, (3) failure to maintain assets of at least \$25,000, (4) plan disqualification, and (5) failure to adopt the Plan in a reasonable period of time.

The Plan's management believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers or the participants.

(6) Excess contributions

Contributions received from participants for 2024 are net of 2023 excess contributions totaling \$38,496, paid to certain active participants to return to them excess contributions, as required to satisfy the relevant nondiscrimination provisions of the Plan.

(7) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing 401(k) plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the pre-approved profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the adopted profit sharing 401(k) plan, is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

(8) Related party and party-in-interest transactions

Plan investments are units of pooled separate accounts and an investment contract managed by Standard and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan held notes receivable from participants and paid expenses to various service providers which also qualify as party-in-interest transactions.

(9) Risks and uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
