

A. Description of Plan

The following description of the ACME-RODCO ("Company") Employees' 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering all employees of the Company who have six consecutive months of service and are age twenty-one or older, with two annual open enrollments of January 1st and July 1st. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees the governance of the Plan. The Board of Trustees determines the appropriateness of the Plan's investment offerings and monitors investment performance.
2. *Contributions.* Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the plan. Participants may designate some or all of their deferrals as Roth elective deferrals. Roth elective deferrals are included in gross income. Roth contributions are maintained in separate accounts from pre-tax elective contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching contributions are discretionary. The Company matches 100 percent of the first 3 percent of base compensation. The Company will match an additional 50 percent of the next 2 percent of employee deferrals. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain statutory limitations.
3. *Participant Accounts.* Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting.* Participants are vested immediately in their own contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of credited service. A participant is 30 percent vested after one year of credited service, 60 percent after two years, and 100 percent after three years. For purposes of vesting, a "year of service" is credited only for a calendar year in which the participant completes at least 1,000 hours of service. Accordingly, participants who do not complete 1,000 hours in a calendar year receive no vesting credit for that year.

5. *Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are secured by the balance in the participant's account and bear interest at a rate that is based on prime. Interest rates on notes receivable from participants ranged from 3.25% to 8.50% during the Plan year. Principal and interest is paid ratably through weekly payroll deductions.
6. *Payment of Benefits.* On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
7. *Forfeited Accounts.* At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$5,988 and \$4,082, respectively. Forfeited accounts are used to reduce future employer contributions. Also, in 2024 and 2023, employer contributions were reduced by \$11,528 and \$14,669, respectively, from forfeited non-vested accounts.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as adjustments of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions at December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for the administration of notes receivable from participants are included in administration expenses and charged directly to the Participant's account.

Date of Management's Review of Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

C. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Standard Insurance Company Group Annuity Separate Accounts: Valued at fair value which equals the number of shares of the respective underlying fund multiplied by the closing net asset value per share quoted by that fund.

Participant loans: Valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair measurement at the reporting date.

E. Investment Contract with Insurance Companies

In 2020, the Plan entered into a guaranteed interest contract with The Standard Insurance Company (The Standard). The Standard maintains the contribution in a general account. The contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Net deposits invested in the guaranteed interest contract become part of The Standard's general account, and there are no particular segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited become liabilities against The Standard Insurance Company on the Plan's behalf. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions.

F. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Trust will continue until the distributable benefit of each participant has been distributed.

G. Tax Status

In 2020, the Plan switched to a volume submitter plan document sponsored by Standard Retirement Services. Standard Retirement Services obtained an opinion letter dated March 31, 2014, in which the IRS stated that the volume submitter plan and related trust are acceptable under the applicable sections of the Internal Revenue Code (IRC).

Although the Plans have been amended since receiving the opinion letters, the Plan administrator and the Plan's tax counsel believe that the Plans are designed, and are currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Tax Status – continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Related Party Transactions and Party in Interest Transactions

Certain plan investments are guaranteed interest accounts and group annuity separate accounts sponsored by The Standard Insurance Company. At December 31, 2024 and 2023, The Standard Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

I. Information Prepared and Certified by Trustees

In 2021, as pursuant to ERISA Section 103(a)(3)(C), the Plan qualified for an ERISA Section 103(a)(3)(C) audit. Information relating to investment assets, investment transactions, investment earnings and schedule of investments held for investment purposes was certified as complete and accurate by the trustee, The Standard Insurance Company at December 31, 2024 and 2023.
