Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) and the Schedule of Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1) Description of Plan

The New Mexico Orthopaedic Associates P.C. 401(k) Profit Sharing Plan (the “Plan”) was established on June 1, 2015 for the benefit of the employees of New Mexico Orthopaedic Associates, P.C. (the “Company”). The Company serves as the Plan sponsor. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company, who have three months of consecutive service and are age twenty-one or older. The Plan includes an automatic enrollment of 3% of eligible compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may contribute up to the maximum percentage of allowable compensation, as defined by the Plan, not to exceed annual limits set by the Internal Revenue Code. For 2024 and 2023, the annual limits were \$23,000 and \$22,500, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers approximately thirty investment options for participants. Participants may also contribute amounts representing rollovers from other qualified plans. Discretionary employer matching contributions may also be made to the Plan. For the years ended December 31, 2024 and 2023, the Company did not make discretionary matching contributions. The employer also has the option to make safe harbor non-elective contributions, as defined by the Plan. For the years ended December 31, 2024 and 2023, the Company made a safe harbor contribution equal to 3% of an eligible employees’ compensation. The Plan made safe harbor contributions for 2024 and 2023 of approximately \$682,000 and \$631,000, respectively. Participants are 100% vested in safe harbor contributions. The employer also has the option to make profit sharing contributions. The profit-sharing contributions are a discretionary amount as determined by the employer annually. The Plan made profit-sharing contributions for 2024 and 2023 of approximately \$1,485,000 and \$1,400,000, respectively.

To receive a non-safe harbor matching contribution, safe harbor matching contribution and profit-sharing contribution the participant must meet eligibility requirements as defined by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participants' account and bear interest at the rate based on the prime rate published by the Federal Reserve as of the date of the loan, plus two percent. Principal and interest is paid ratably through payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's deferrals, the Company's matching contributions, plan earnings and an allocation of the Company's nonelective contributions, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Forfeited Accounts

Each Plan year, forfeitures are used to reduce any matching or nonelective contributions or to pay Plan expenses. The forfeited account balance at December 31, 2024 and 2023 was approximately \$48,000 and \$7,000, respectively.

Vesting

Vesting in the Plan's discretionary matching and profit-sharing contribution portion of a participant's account plus earnings thereon is based on years of service, as defined by the Plan. A participant is 100% vested after three years of credited service according to the following schedule:

Payments of Benefits

Upon termination of service due to death, disability or retirement, vested benefits are distributed in accordance with specific requirements outlined in the Plan agreement.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable From Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for losses has been recorded as of December 31, 2024 and 2023, as the notes receivable are secured by the vested portion of participant accounts.

Administrative Expenses

The Plan permits, but does not require, the Company to pay costs of Plan administration. During 2024, the Company paid the majority of Plan administrative expenses. In 2023, the Plan was paid for the majority of Plan administrative expenses.

Payment of Benefits

Benefit payments are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5) Plan Termination

Although it has not expressed intent to do so, the Company, as the Plan's sponsor, has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6) Tax Status

The Plan is operating as a tax-exempt plan under a non-standardized pre-approved profit sharing plan with CODA. The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020, that the prototype plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype sponsor. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

6) Tax Status - continued

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7) Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements - The fair value of shares of registered investment companies are measured using quoted prices in an active market.

Level 2 Fair Value Measurements – The fair value of shares of collective investment trusts are valued at the net asset value of shares held by the Plan at the end of each day. Money market funds and cash are valued at cost which approximates fair value.
