# Notes To Financial Statements

## NOTE 1. PLAN DESCRIPTION

The following brief description of the SMI Management, LLC 401(k) Plan and Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

### **General**

The Plan is a defined contribution plan covering substantially all employees of SMI Management, LLC (the "Company") who have one month of service within a twelve-month period and are age twenty-one or older. The Plan is subject to the provisions of ERISA. The administrative committee is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

### **Contributions**

Each participant may make pre-tax contributions of up to 100% of compensation, as defined by the Plan, not to exceed \$23,000 (in 2024) indexed for inflation annually. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes a safe harbor matching contribution of 100% of a participant's contributions to the Plan to the extent the participant's contributions do not exceed 3% of their annual compensation, plus 50% of the participant's contribution between 3% and 5% of compensation. Employees must have completed one year of service (based on 1,000 hours of service) by the quarterly match entry date to share in the Company's matching contributions.

In addition to matching contributions, the Company may make a discretionary nonelective contribution to participants. The amount of the discretionary nonelective contribution, if any, is determined annually by the Company and cannot exceed 4% of employee compensation. Such discretionary contributions are subject to limitations under the Internal Revenue Code (IRC) and allocated based on each participant's compensation to total participant compensation. Employees must have completed one year of service (based on 1,000 hours of service) by the quarterly match entry date and be employed on the last day of the Plan year to participate in the discretionary nonelective contribution. There was no discretionary nonelective contribution made for 2024.

The Plan records employer and employee contributions receivable when compensation is paid. In accordance with ASC 326, *Financial Instruments - Credit Losses*, no allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

## NOTE 1. PLAN DESCRIPTION (CONTINUED)

### **Participant Investment Options**

Participants must direct their salary deferral contributions and the Company's contributions to selected investments as made available and determined by the plan administrator. Participants may change their investment options any time throughout the year via direct phone or internet access to Fidelity Management Trust Company.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of: (i) the Company's profit-sharing contribution, if any, (ii) the Company's matching 401(k) contribution, (iii) Plan earnings or losses, and (iv) forfeitures of terminated participants' nonvested account balances, if any, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company's safe harbor matching contributions plus (minus) earnings thereon. Vesting in the remainder of their account is based on years of continuous service. After two years a participant is 20% vested. A participant continues to vest 20% for each successive year until 100% vested after six years of credited vesting service.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans must be repaid in five years, unless it is for the purchase of a principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan and is secured by the balance in the participant's account. These loans bear interest at a rate commensurate with local prevailing rates as determined by the Plan.

### **Payment of Benefits**

Under Section 401(k) of the Internal Revenue Code (IRC), withdrawals are only available for the following events: termination of employment, disability, retirement, death, and amounts to satisfy a financial hardship as determined by the administrative committee. Under one of the aforementioned events, a participant or beneficiary may receive the vested value of his or her account either by a lump sum distribution or in installments, as specified in the Plan, over a period not to exceed the time period permitted by the IRC. However, if his or her vested value is \$5,000 or less, payment will be made by a lump sum distribution. Forfeitures of nonvested benefits are used to pay Plan expenses with any remaining amounts allocated to the remaining participants.

## **NOTE 1. PLAN DESCRIPTION (CONTINUED)**

### **Forfeitures**

Forfeitures of terminated nonvested account balances available at December 31, 2024 and 2023 were \$2,544 and \$1,005, respectively. These accounts will be used to reduce employer contributions or pay Plan expenses. Forfeited account balances totaling \$5,410 were used to reduce employer contributions during the year ended December 31, 2024. There were no Plan expenses paid out of the forfeiture account during the year ended December 31, 2024.

## **NOTE 2. SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Administrative Expenses**

Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Most administrative expenses for custodial and other fees of the Plan are paid directly by the Company. Certain administrative fees for participant directed transactions were paid from participant accounts in accordance with the Plan service agreement.

### **Payment of Benefits**

Benefits are recorded when paid.

## NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

## NOTE 3. FAIR VALUE MEASUREMENTS

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the quoted net asset value of shares held by the Plan at year end.

**NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)**

*Stable value collective trust fund:* Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds, money market funds, and a stable value collective trust fund managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in administrative expenses and net appreciation in fair value of investments.

**NOTE 6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participant accounts will become fully vested and nonforfeitable.

**NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8. INCOME TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the relevant taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
