#### NOTE A - DESCRIPTION OF PLAN

The following description of Century Bank 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan covers all eligible employees of Century Bank (the Company).

##### General

The Plan is a defined contribution plan covering eligible employees of the Company who are twenty-one years of age or older and who have completed a year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions

Each year, participants may contribute up to one hundred percent of their annual compensation as defined by the Plan (not to exceed the limits set by the Internal Revenue Code) on a pre-tax basis or as Roth contributions. Participants may also contribute rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts and a guaranteed investment contract as investment options for participants. The Company makes safe harbor qualified non-elective contributions for all eligible employees at a rate of three percent of participants' compensation and may also make additional qualified non-elective contributions at its discretion. In addition, the Company may make annual discretionary profit-sharing contributions to the Plan. Contributions made by the Company are allocated in the same manner as participant contributions.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's qualified non-elective contributions, (b) the Company's discretionary profit-sharing contributions, and (c) Plan earnings. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and the Company's qualified non-elective contributions, plus actual earnings thereon. Vesting in the Company's profit-sharing contributions plus actual earnings thereon is twenty percent for each year of service and participants are one hundred percent vested after five years of service.

If an employee dies, suffers total and permanent disability, or attains normal retirement age of 65 while still employed by the Company, his or her entire interest in all accounts will become fully vested, without regard to the length of service with the Company.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or fifty percent of their vested account balance reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. The loans are secured by the vested balance in the participant's account and bear interest at the Wall Street Journal prime rate plus two percent at the time the loan is made. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, though loans for the purpose of purchasing the participant's primary residence may have longer repayment terms if permitted by the Plan Administrator.

#### Payment of Benefits

Payment of benefits is made upon retirement, disability, death, or termination of employment. If a participant's vested account balance does not exceed \$5,000 the Plan will distribute the vested balance in a lump sum cash payment or rollover payment as soon as administratively practicable, except that vested balances between \$1,000 and \$5,000 will be contributed to an IRA established for the participant if the participant does not provide timely election forms for the distribution. If a participant's account balance exceeds \$5,000, the trustee will commence distribution at the time and in the form the participant elects. Such distribution can take the following forms: (a) lump sum; (b) installment payments made annually, quarterly, or monthly over a specified period of time not exceeding the participant's life expectancy; or (c) combination of both (a) and (b). The Plan also provides for hardship withdrawals in certain instances as specified in the Plan.

#### Forfeited Accounts

Forfeited non-vested accounts are used to reduce future employer contributions and pay certain Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$268 and \$102, respectively.

### NOTE B - SUMMARY OF ACCOUNTING POLICIES

#### Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

#### Investments, Guaranteed Investment Contracts and Income Recognition

Pooled separate accounts and mutual funds are recorded at fair value. See Note C for discussion of these measurements. Guaranteed investment contracts are recorded at contract value. See Note D for discussion of this measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's unrealized gains and losses on investments held, as well as realized gains and losses on investments sold.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Operating Expenses

Expenses of maintaining the Plan are generally paid by the Company, though certain expenses may be paid directly by the Plan from forfeitures.

#### Subsequent Events

The Plan evaluates events occurring subsequent to the balance sheet date, through the date the financial statements are eligible to be issued, to determine whether the events require recognition or disclosure in the financial statements. If a subsequent event evidences conditions existing at the balance sheet date, the effects are recognized in the financial statements (recognized subsequent event). If a subsequent event evidences conditions arising after the balance sheet date, the effects are not recognized in the financial statements but rather disclosed in the notes to the financial statements (non-recognized subsequent event). The effects of subsequent events are only recognized if material or disclosed if the financial statements would otherwise be misleading.

With respect to the December 31, 2024 financial statements, the Plan has evaluated subsequent events through September 11, 2025.

#### **NOTE C – INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The following is a summary of the Plan's investments at fair value as of December 31, 2024 and 2023, which was derived from information prepared by Principal Trust Company (the custodian) and furnished to the Plan administrator. The Plan administrator has obtained certifications from Principal Trust Company that such information is complete and accurate.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used in 2024 and 2023.

*Mutual funds* – Valued using the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts* – Valued using the NAV per unit of the funds. The NAV is based on the fair values of the underlying investments held by the fund less its liabilities. Principal generally determines the fair values of the underlying investments based on market quoted pricing.

**NOTE D – GUARANTEED INVESTMENT CONTRACT**

One of the current investment options in the Plan is the Principal Fixed Income Guaranteed Option. This investment guarantees principal and provides a stable credit rate and is backed by the assets in the general account of the Principal Life Insurance Company and does not have specific underlying assets assigned.

This investment is fully benefit-responsive, and contract value is the relevant measurement attribute as Plan transactions are ordinarily executed using contract value without adjustment. As the Plan intends to maintain this investment, and the investment generally cannot be sold, transferred, or assigned externally, contract value is a good proxy for fair value. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The total contract value of the guaranteed investment contract as of December 31, 2024 and 2023, was \$2,425,628 and \$3,026,758, respectively.

Certain events, such as the termination of the investment contract by the Plan, may limit the ability of the Plan to transact at contract value. As of December 31, 2024, the Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

#### **NOTE E – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

#### **NOTE F – TAX STATUS**

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator does not believe there are any such uncertain tax positions. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**NOTE G – RISKS AND UNCERTAINTIES**

The Plan invests in various investment options. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H – RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by Principal Financial Group, such as the pooled separate accounts and the guaranteed investment contract. Principal Trust Company, a member of the Principal Financial Group, is the Plan's custodian. As such, these investments qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$95,732 and \$84,064 for the years ended December 31, 2024 and 2023, respectively.

Certain administrative functions for the Plan are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. The Company generally pays expenses applicable to maintaining the Plan, other than administrative fees charged directly to the Plan which are paid using forfeited non-vested balances.
