## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Thought Logic 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, Transamerica Trust Company and Transamerica Life Insurance Company as of December 31, 2024 and for the period July 1, 2024 through December 31, 2024, and Reliance Trust Company as of December 31, 2023, and for the period January 1, 2024 through June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## Note 1. Description of Plan

The following description of the Thought Logic 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

## General:

The Plan is a safe harbor defined contribution plan covering all employees of Thought Logic Consulting, LLC "the Company." Employees are eligible to participate upon their hire date. Upon enrollment in the Plan, a participant may direct contributions in various investment options including mutual funds and the stable value fund. Participants may change their investment options daily. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

## Contributions:

Participants may elect to defer their compensation up to the maximum amount allowed under the Internal Revenue Code, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company provides a safe harbor matching contribution equal to 100% of the participants' salary deferral up to 3% of participant compensation and 50% of the participants' salary deferral between 3% and 5% of participant compensation, for a maximum match of 4%. Additional profit sharing amounts may be contributed at the option of the Company for participants employed on the last day of the Plan year. No profit sharing contributions were made for the year ended December 31, 2024. Contributions are subject to certain limitations.

## Participant accounts:

Each participant's account is credited with the participant's contribution, any Company contributions, and an allocation of Plan earnings. Allocations are based on compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting:

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in their share of Company contributions is based on years of service, as defined by the Plan. A participant is 100 percent vested after the earlier of five years of credited service, total disability, or death.

## Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of the participant's account. The loans are secured by the balance in the participant's account. The interest rate on all notes outstanding range from 7.25% to 9.50%. Notes receivable terms range from one to five years or up to fifteen years for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

## Note 1. Description of Plan (continued)

## Forfeited accounts:

Forfeitures may be used to reduce employer contributions and to pay the Plan's administrative expenses. There were no unallocated forfeitures as of December 31, 2024 and 2023. No forfeitures were used during 2024.

## Payment of benefits:

The vested value of a participant's account is payable upon termination, retirement, death, or disability in either a lump sum or partial payments. Distributions are payable as soon as administratively feasible following the date on which a distribution is requested or otherwise payable. Certain in-service withdrawals are also allowed under the Plan.

## Hardship distributions:

Participants may be distributed up to 100% of their elective deferral accounts in the event of immediate and heavy financial need. In order to receive a hardship distribution, certain requirements and conditions must be satisfied.

## Note 2. Significant Accounting Policies

## Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

## Investment valuation and income recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses on the Plan's investments are included in net appreciation in the fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

## Note 2. Significant Accounting Policies (continued)

## Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

## Plan expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

## Payment of benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

## Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the use of estimates based on management's knowledge and experience. Due to their prospective nature, actual results could differ from those estimates.

## Note 3. Party-In-Interest Transactions

Certain Plan investments are mutual funds and the stable value fund managed by Transamerica Trust Company ("TTC"), TransAmerica Life Insurance Company ("TLIC"), who acts on behalf of TTC, and Reliance Trust Company ("RTC"). TLIC, TTC, and RTC are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. The custodians and others received \$76,543 in direct fees from the Plan in 2024.

## Note 4. Information Prepared and Certified by the Custodians of the Plan

The following information included in the accompanying financial statements and supplemental information was compiled from data certified by TTC, TLIC, and RTC, the custodians, as being complete and accurate:

- A. Investments included in the Statements of Net Assets Available for Benefits – December 31, 2024 and 2023.
- B. Investment income included in the Statement of Changes in Net Assets Available for Benefits – Year Ended December 31, 2024.
- C. Investment information included in the supplemental schedule.

## Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

## Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

## Note 7. Income Tax Status

The Plan has adopted a prototype non-standardized profit sharing volume submitter defined contribution basic plan document. The underlying volume submitter plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under the applicable sections of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under the applicable section of the IRC. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status.

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt and no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2            Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Note 9. Stable Value Fund

The Plan has entered into a benefit-responsive investment contract with Transamerica Life Insurance Company (Transamerica). Assets held in the Stable Value Fund are commingled with assets in the general account. The account is recorded at its contract value. The fair value of the Stable Value Fund approximates contract value. The credited interest rate is backed by the income received from assets held in the general account. The Stable Value Fund has no stated maturity. Prior to January 1 and July 1, the effective annual rate of interest is established for the corresponding six month period. There is no stated minimum or maximum interest rate.

The Stable Value Fund investment choice is a non-tradable obligation of Transamerica. The investment's contract or proceeds cannot nor will not be assigned or sold to another party without the consent of Transamerica. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable, the Stable Value Fund may no longer be considered fully benefit-responsive. The terms of the contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions.

Permitted participant-initiated transactions are those allowed by the underlying Plan such as withdrawals for benefits, loans or transfers to other investment choices within the Plan. Since the Stable Value Fund investment choice is an obligation of Transamerica, the occurrence of an event that limits the ability of the investment to transact at contract value between Transamerica and a participant holding the investment is not probable. The Stable Value Fund investment choice allows a participant reasonable access to their assets. There are no unfunded commitments, the redemption frequency is daily, and the redemption notice period is daily.

## Note 10. Subsequent Events

Effective January 1, 2025, the Plan was amended to modify vesting in Company profit sharing contributions whereby participants are 100 percent vested after the earlier of four years of credited service, total disability, or death, and to merge an acquired company's plan with approximately \$15.5 million of assets into this Plan.

Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.
